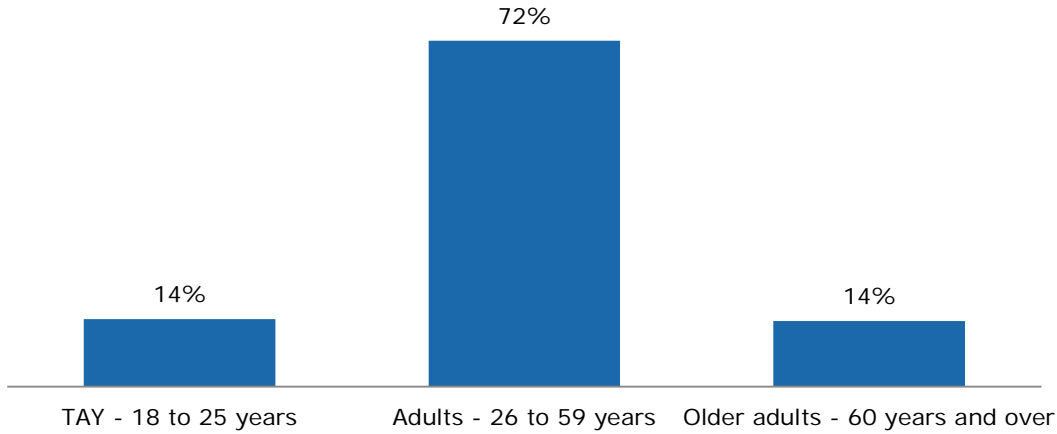

Exhibit 4. Sex Assigned at Birth (n=4,208)

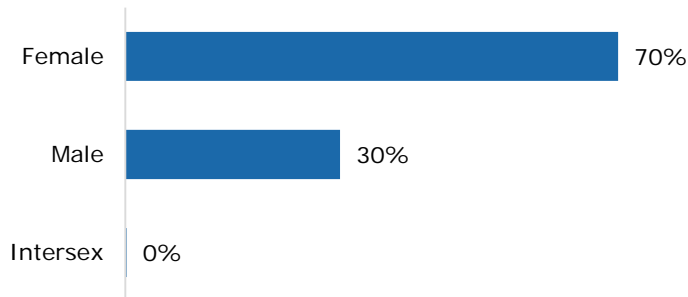


Exhibit 5. Gender of Respondent (n=4,038)

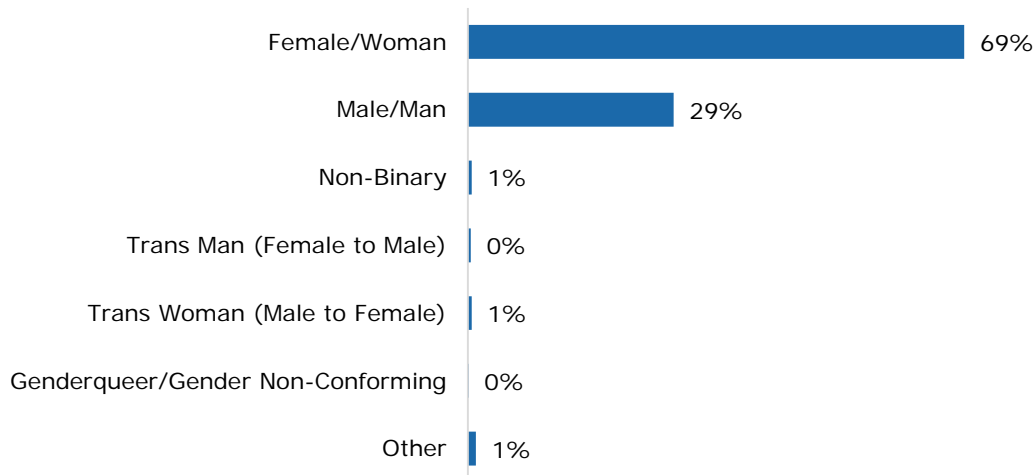


Exhibit 6. Sexual Orientation (n=3,553)

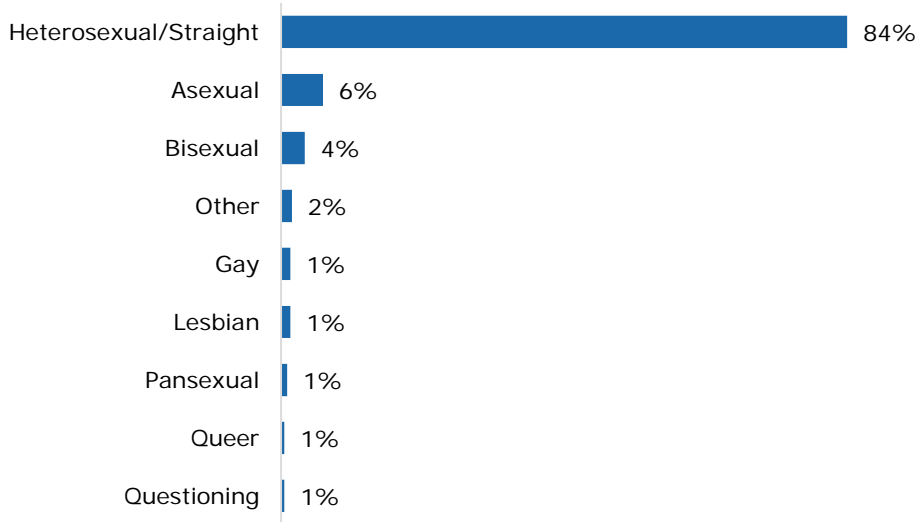


Exhibit 7. Country of Birth of the Respondent (n=4,143)

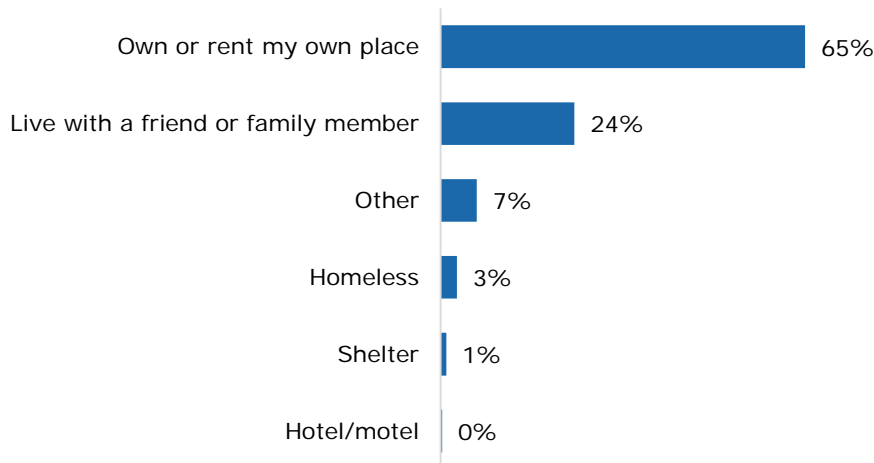
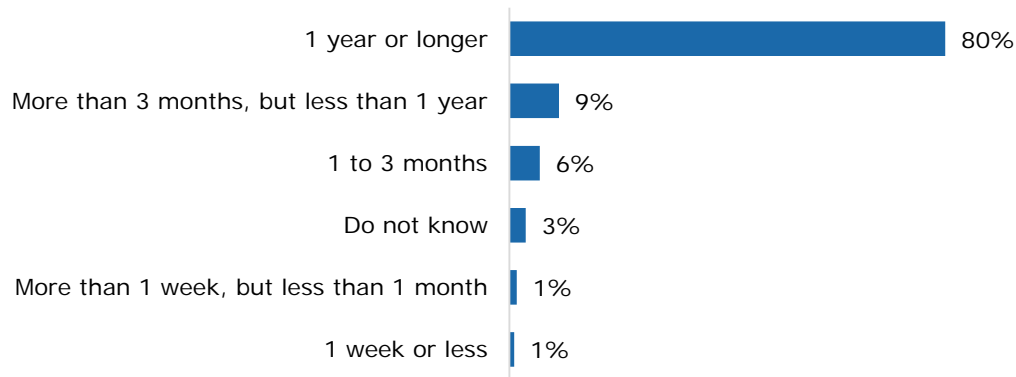


Exhibit 14. Length of Time in Current Living Situation (n=4,015)

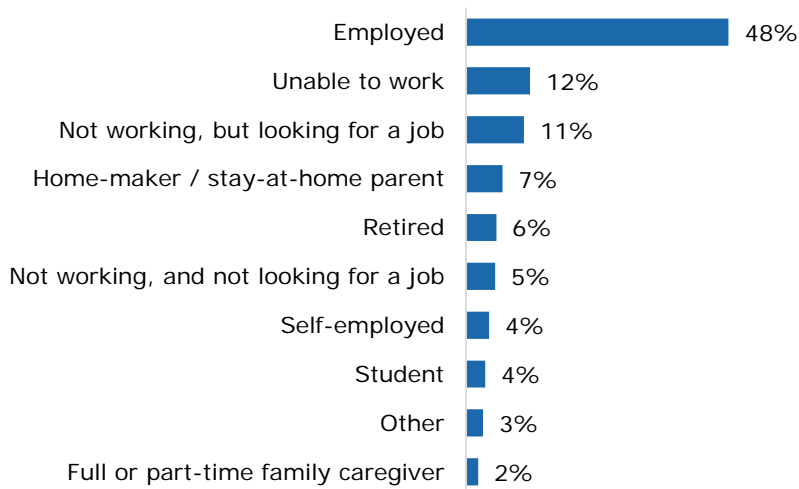
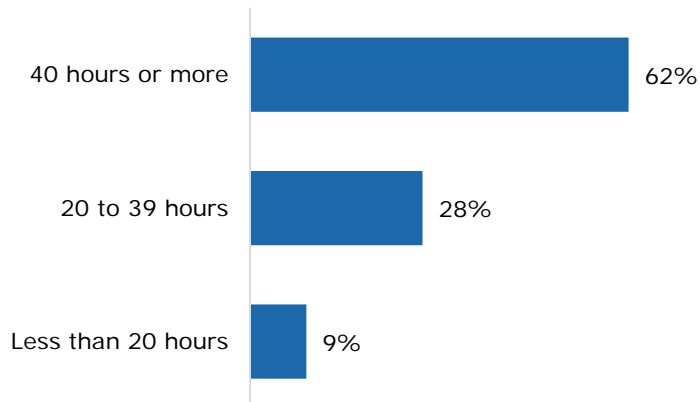


Exhibit 16. Number of Hours Respondent Works Each Week (n=2,074)²

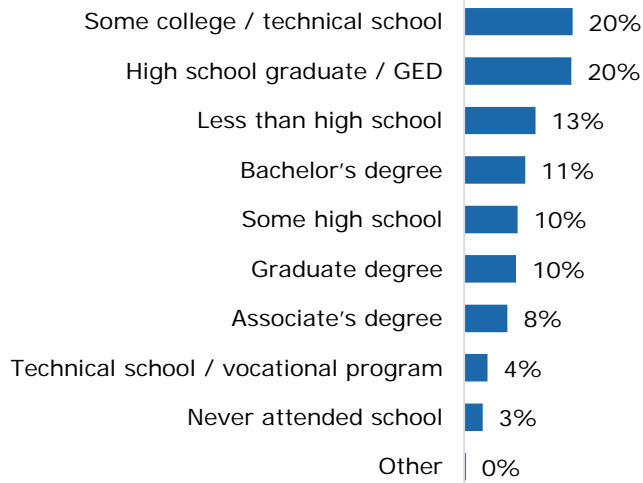
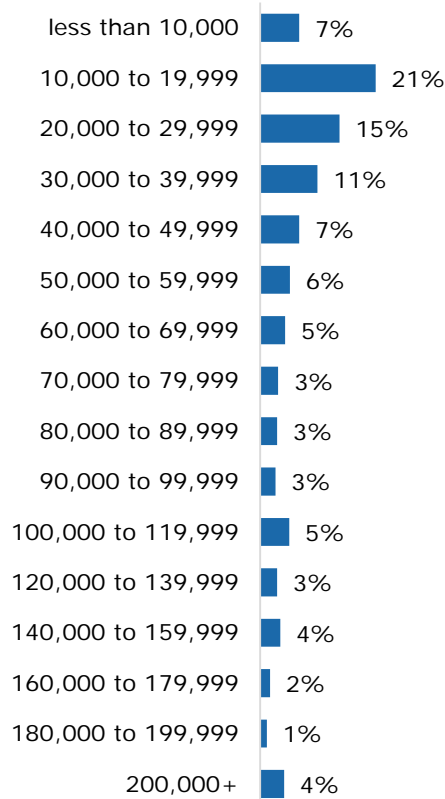
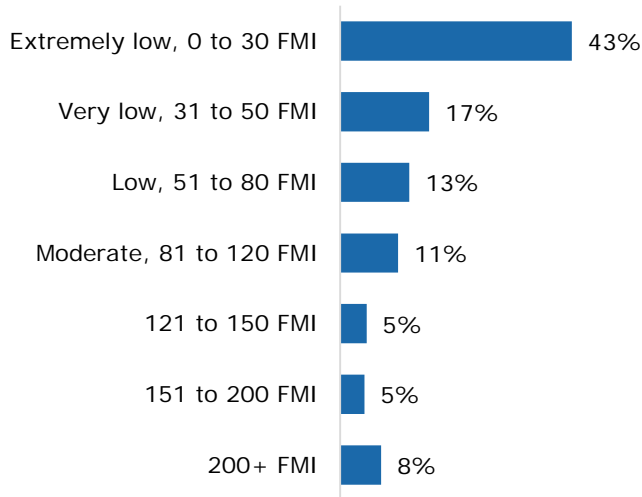


Exhibit 18. Total household income (n=2,422)



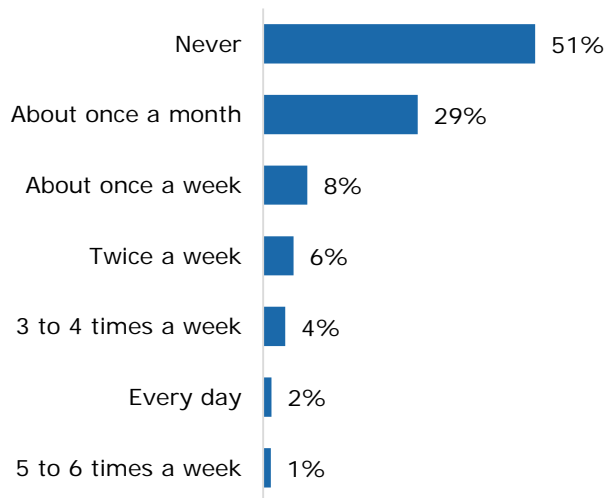

Exhibit 21. For Respondents who Reported Drinking, Average Number of Alcoholic Drinks (n=1,907)

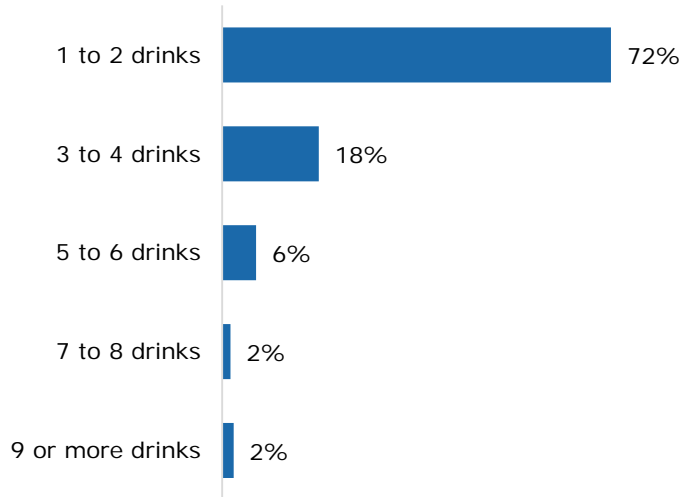


Exhibit 22. Substance Use in the Last 12 Months (n=3,919)

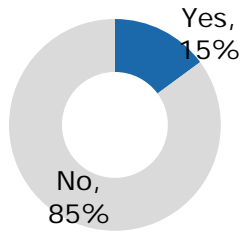


Exhibit 23. Mental Health Rating (n=3,856)

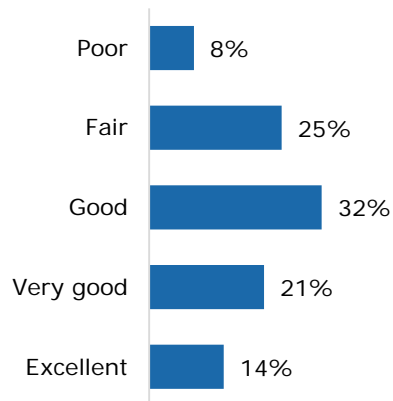


Exhibit 24. Mental Health Diagnosis by a Doctor or Other Healthcare Professional (n=2,794)

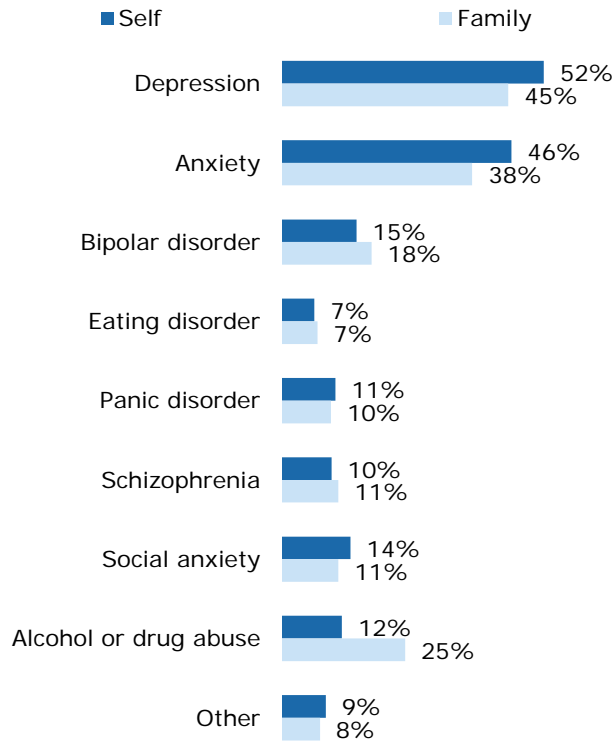


Exhibit 25. Age of First Mental Health Diagnosis

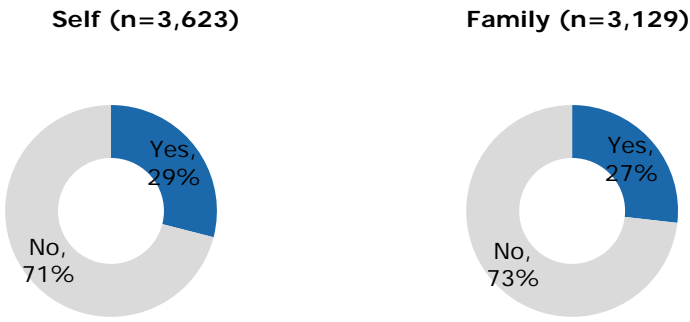


Exhibit 27. Age of First Suicide Attempt

Exhibit 28. Access to Needed Mental Health Services in the Last 12 Months

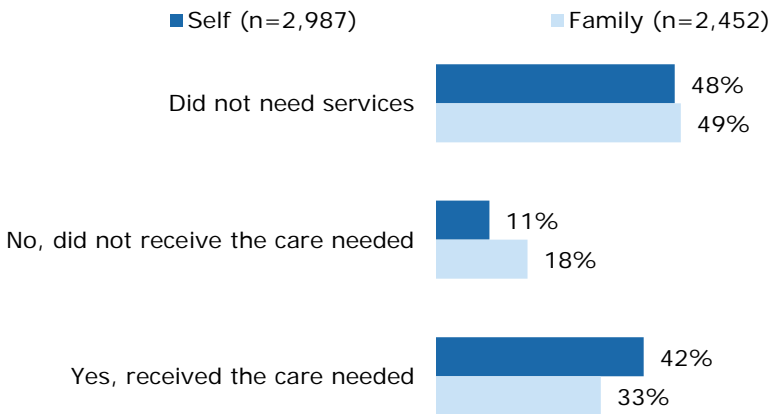


Exhibit 29. Main reasons Why Mental Health Services were NOT Received (n=533)

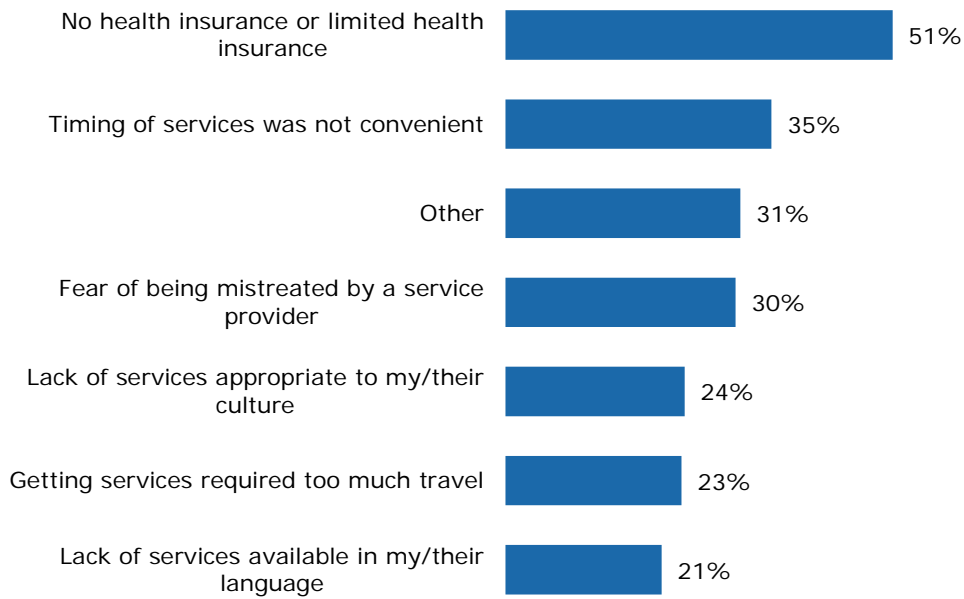


Exhibit 30. Staff that Provided Services were Sensitive to Cultural Background (n=1,531)

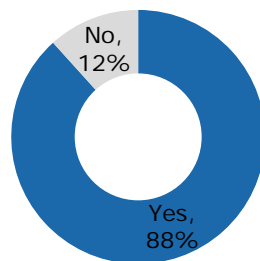


Exhibit 31. Services were Provided in Preferred Language (n=1,598)

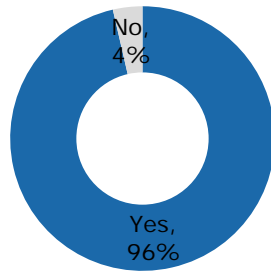


Exhibit 32. Overall Satisfaction with Received Services (n=1,577)

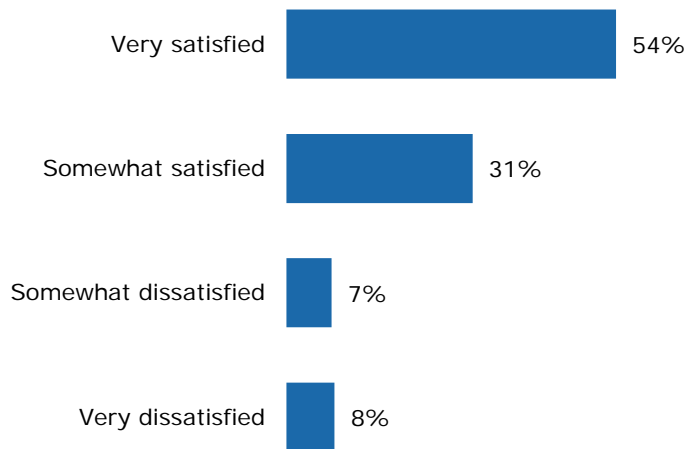
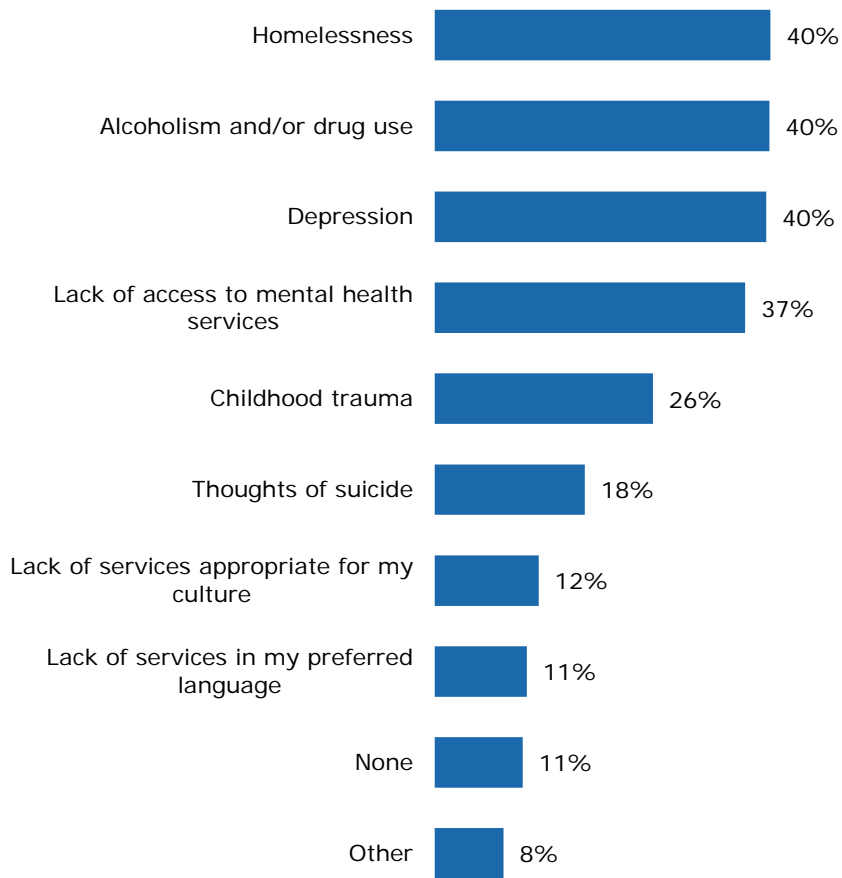


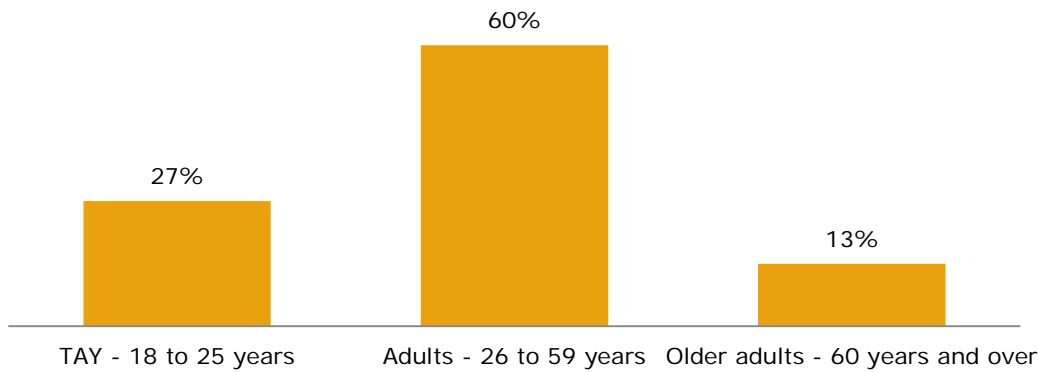
Exhibit 33. Most Urgent Mental Health Issues in the Community (n=3,715)

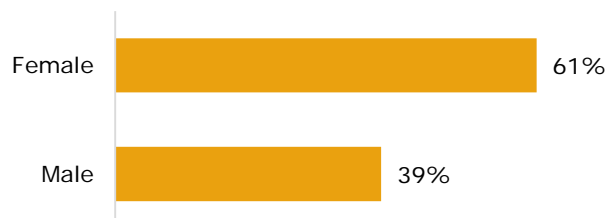


Exhibit 37. Gender of Respondent (n=115)

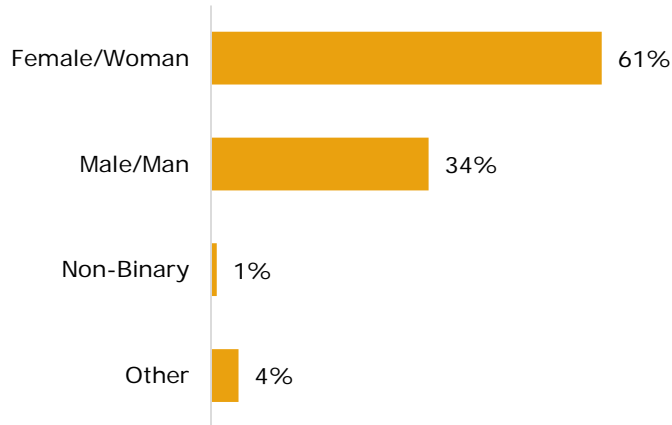


Exhibit 38. Current Sexual Orientation (n=114)

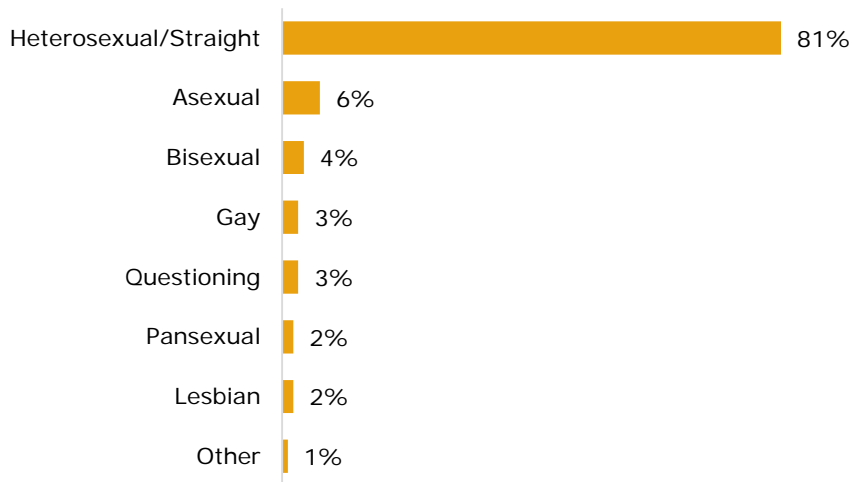


Exhibit 39. Country of birth of the respondent (n=119)

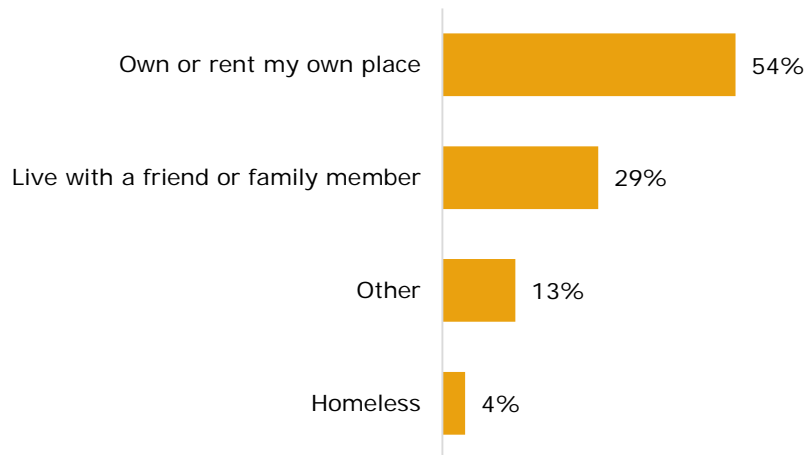
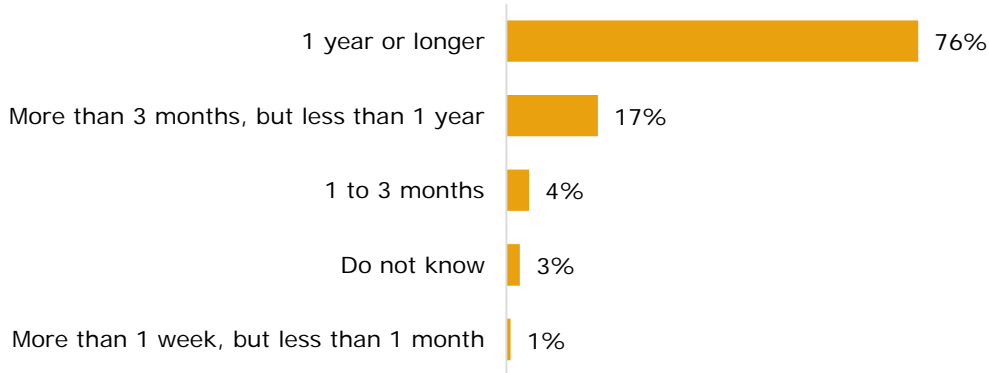


Exhibit 46. Length of Time in Current Living Situation (n=119)

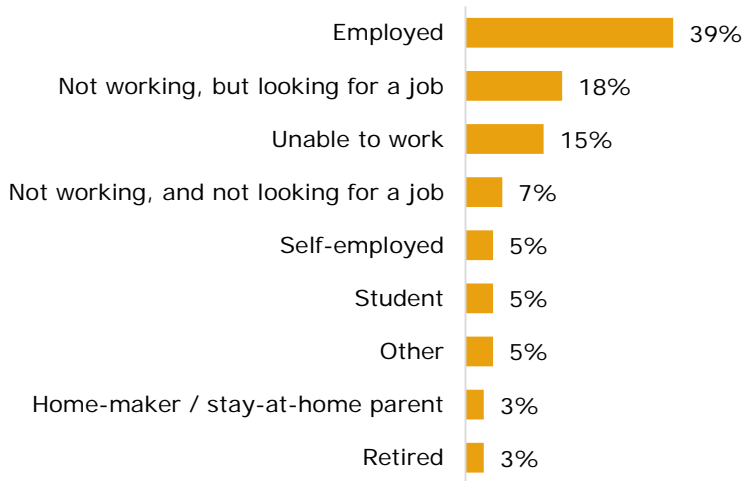
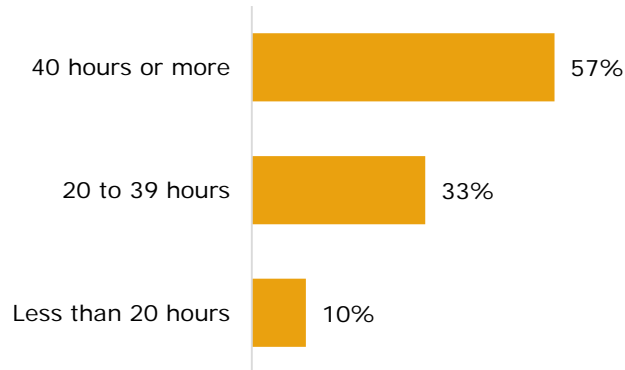


Exhibit 48. Number of Hours Respondent Works Each Week (n=49)⁴

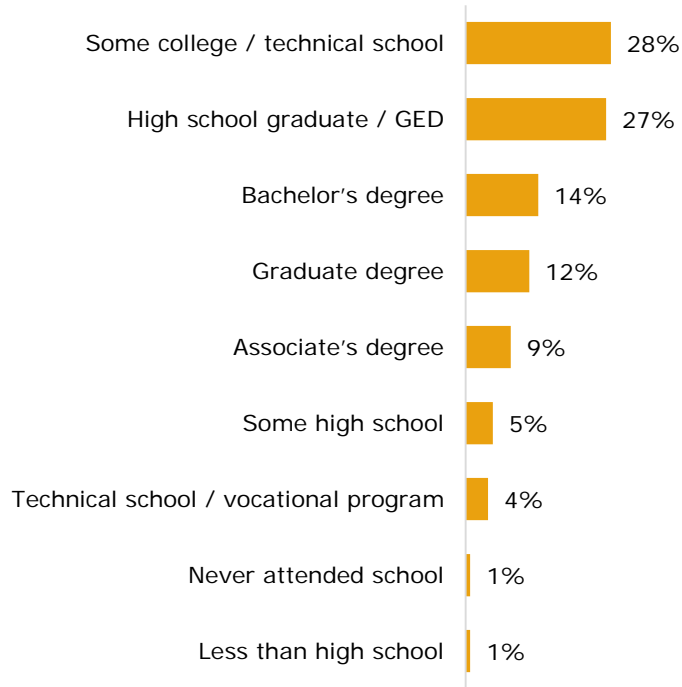
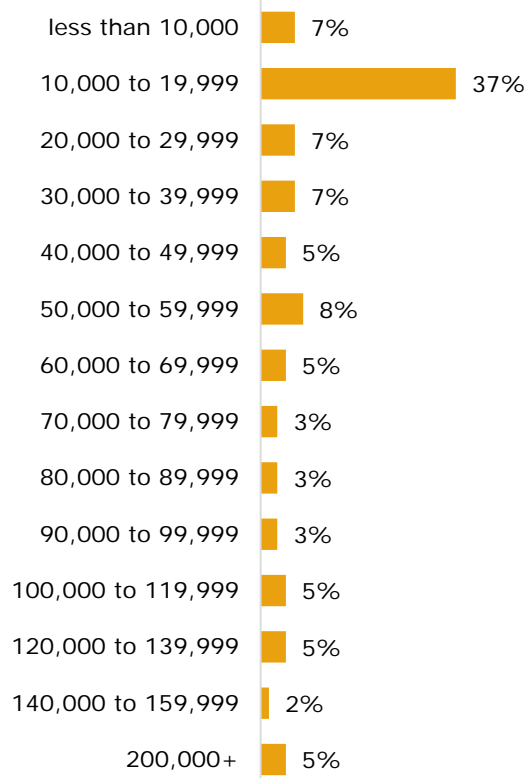
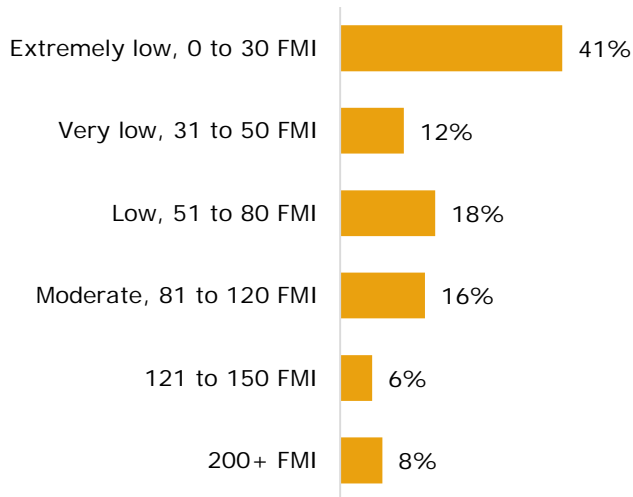


Exhibit 50. Total household income (n=62)



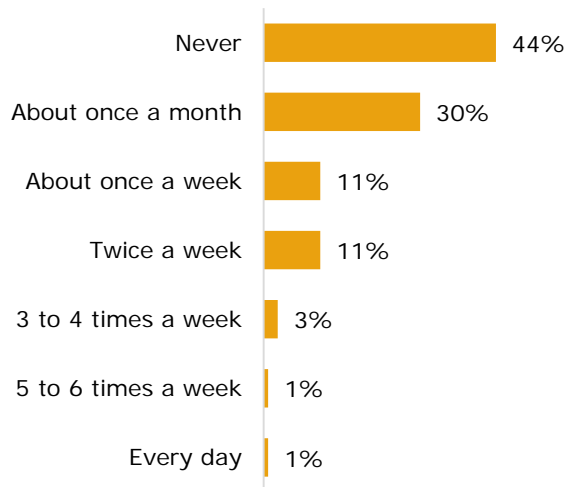

Exhibit 53. For Respondents who Reported Drinking, Average Number of Alcoholic Drinks (n=62)

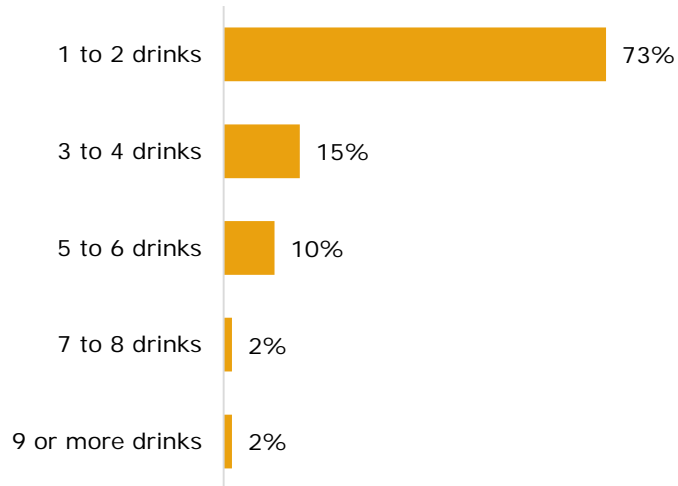


Exhibit 54. Substance Use in the Last 12 Months (n=114)

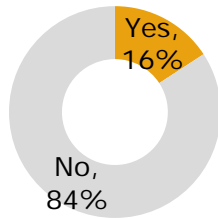


Exhibit 55. Mental Health Rating (n=111)

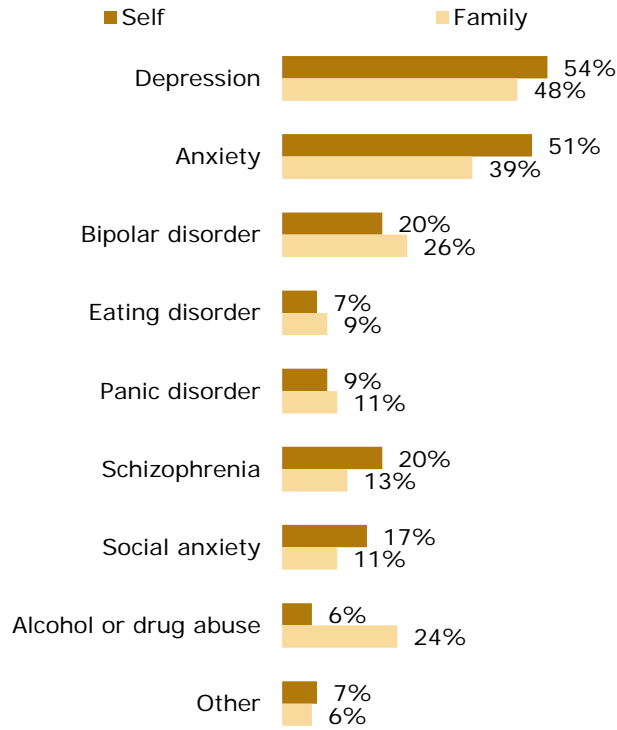


Exhibit 57. Age of First Mental Health Diagnosis

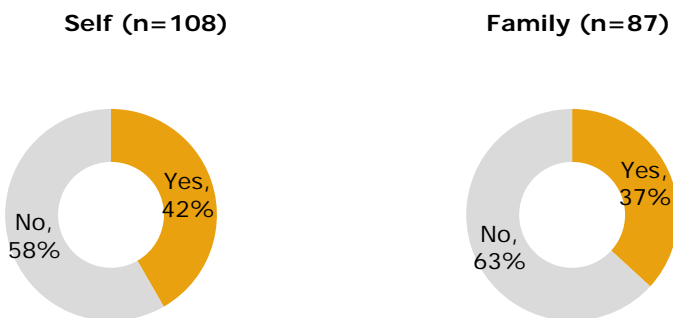


Exhibit 59. Age of First Suicide Attempt

Exhibit 60. Access to Needed Mental Health Services in the Last 12 Months

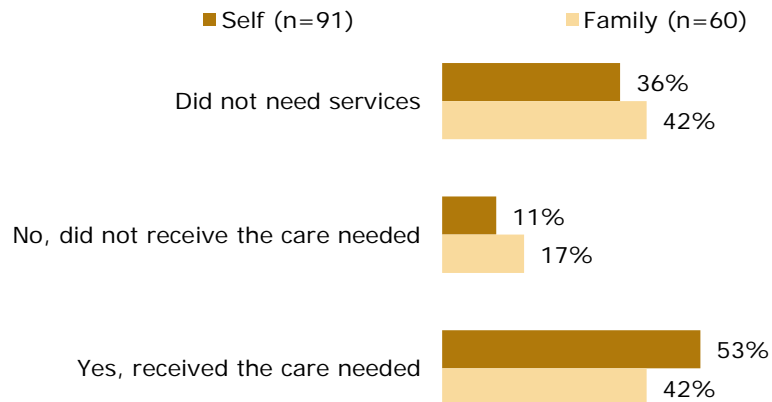


Exhibit 61. Main reasons Why Mental Health Services were NOT Received (n=15)

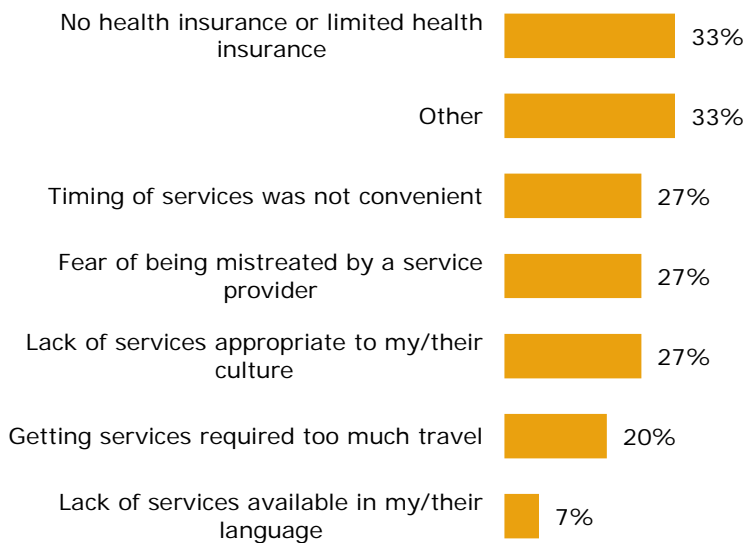


Exhibit 62. Staff that Provided Services were Sensitive to Cultural Background (n=59)

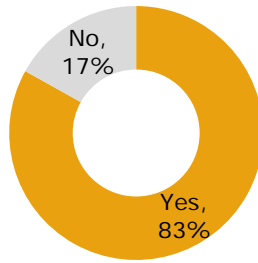


Exhibit 63. Services were Provided in Preferred Language (n=62)

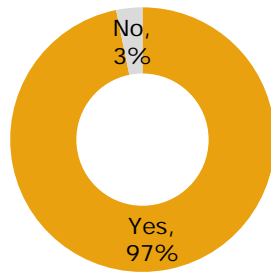


Exhibit 64. Overall Satisfaction with Received Services (n=60)

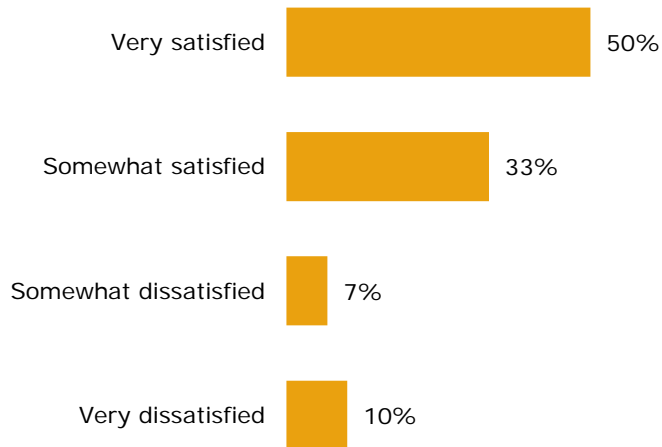
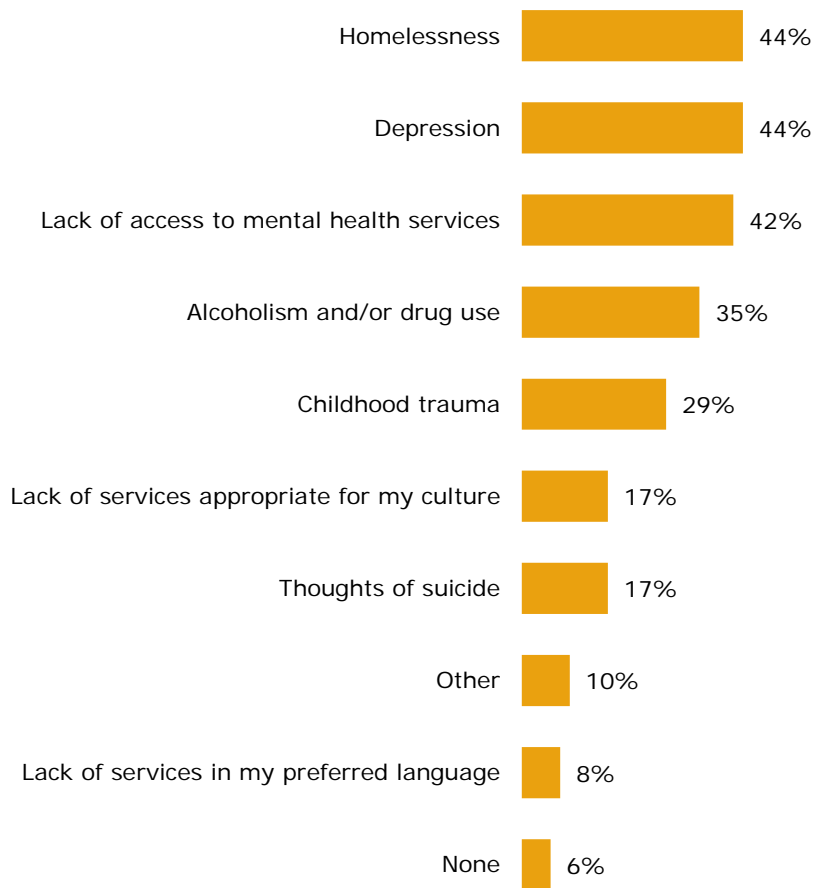


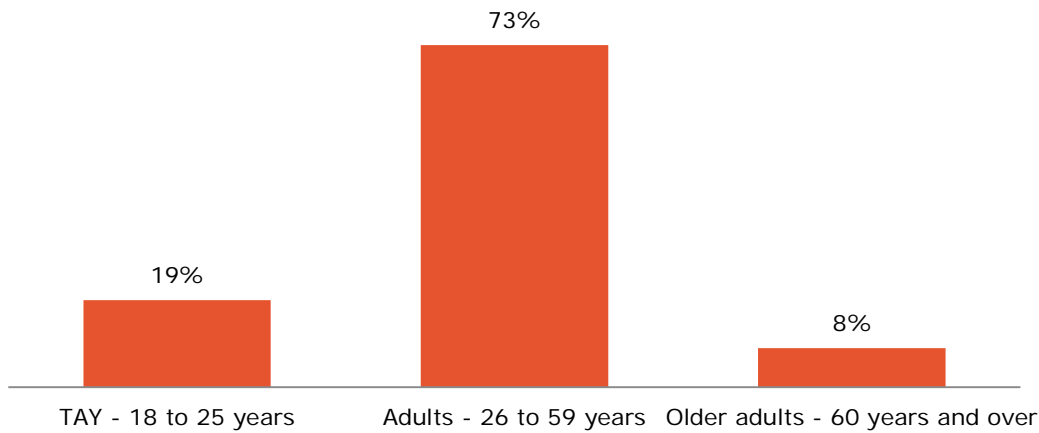
Exhibit 65. Most Urgent Mental Health Issues in the Community (n=105)

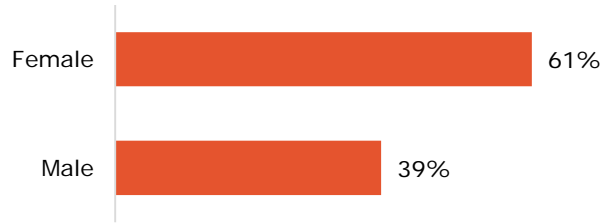


Exhibit 69. Gender of Respondent (n=152)

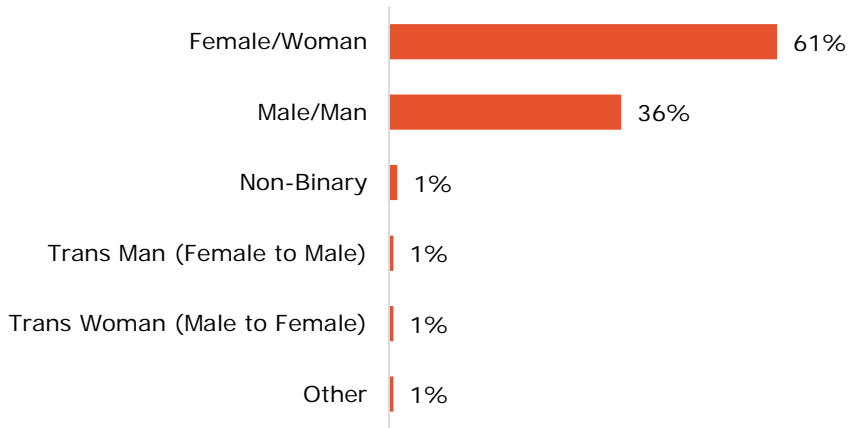


Exhibit 70. Current Sexual Orientation (n=144)

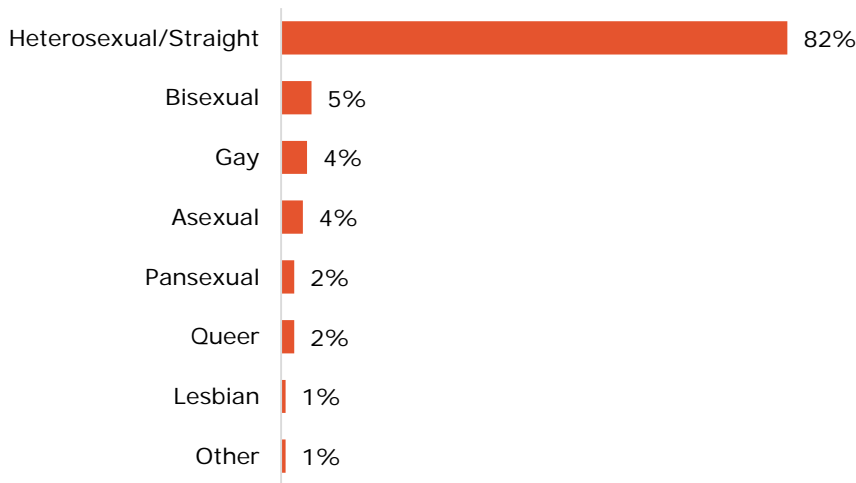


Exhibit 71. Country of birth of the respondent (n=150)

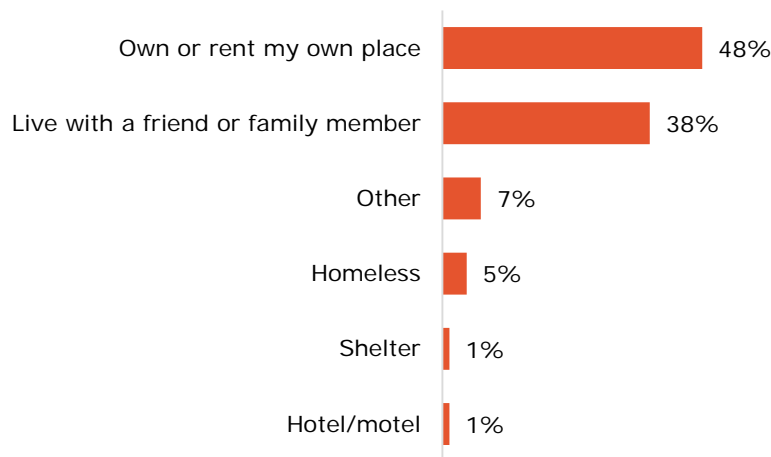
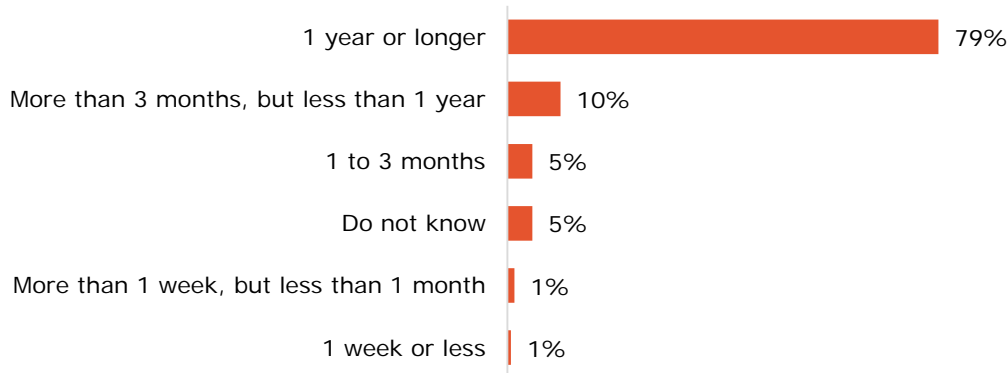


Exhibit 78. Length of Time in Current Living Situation (n=153)

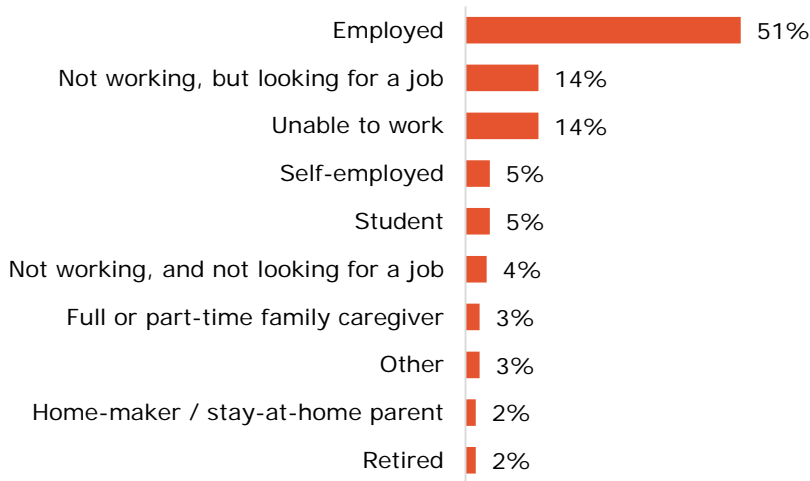
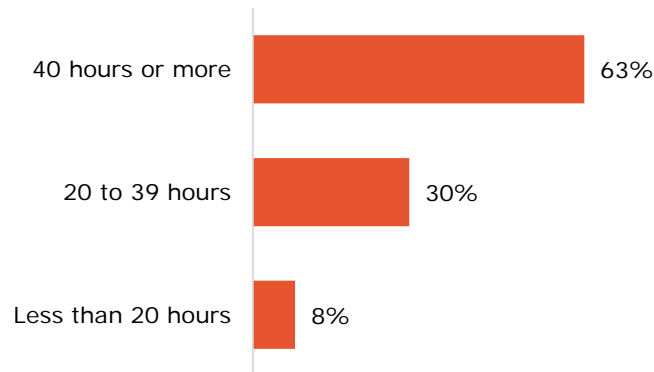


Exhibit 80. Number of Hours Respondent Works Each Week (n=88)⁶

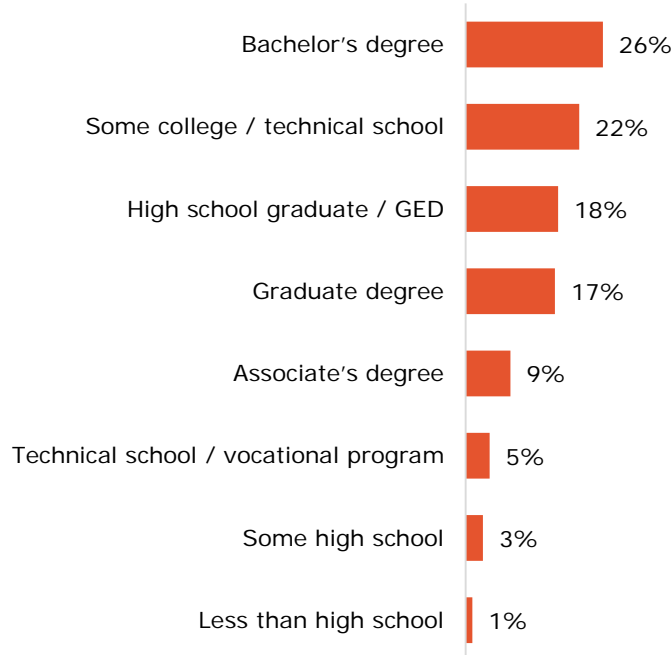
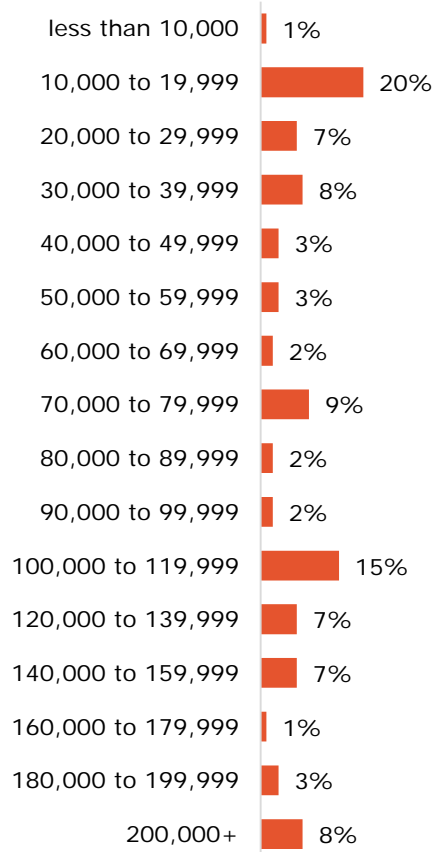
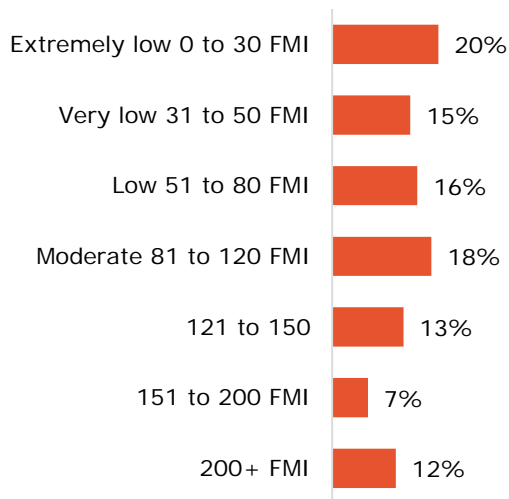


Exhibit 82. Total household income (n=87)



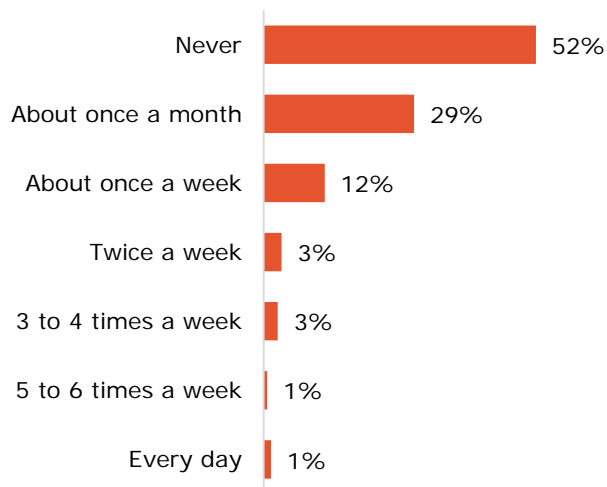

Exhibit 85. For Respondents who Reported Drinking, Average Number of Alcoholic Drinks (n=72)

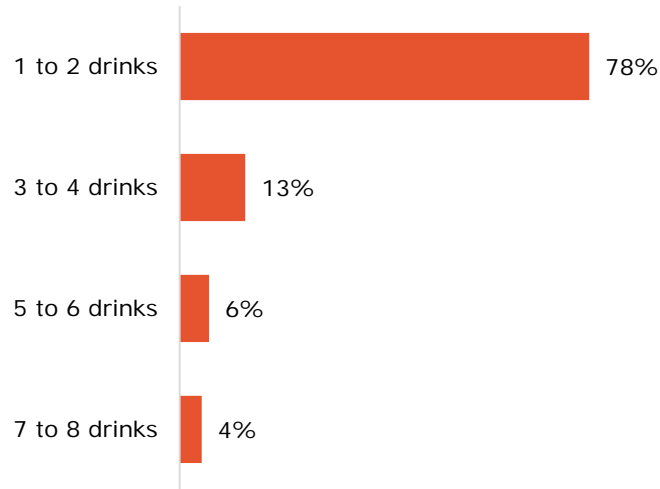


Exhibit 86. Substance Use in the Last 12 Months (n=151)

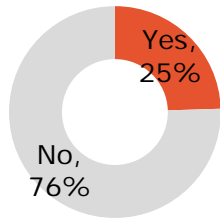


Exhibit 87. Mental Health Rating (n=146)

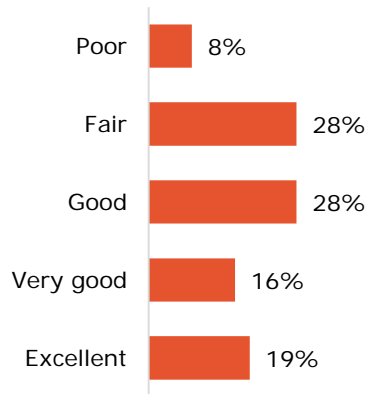


Exhibit 88. Mental Health Diagnosis by a Doctor or Other Healthcare Professional (n=101)

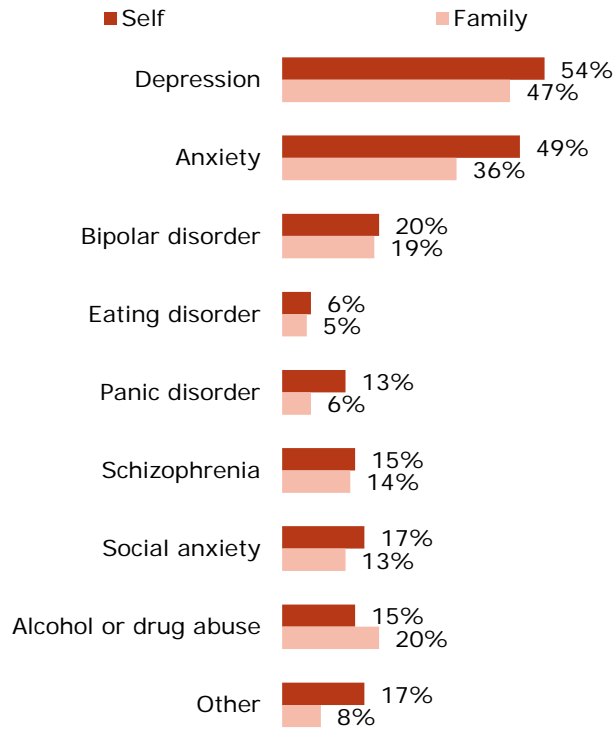


Exhibit 89. Age of First Mental Health Diagnosis

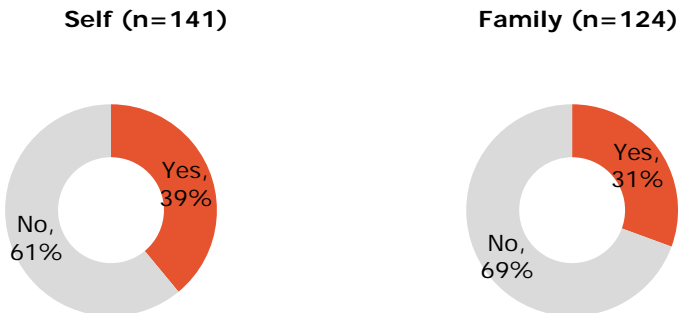


Exhibit 91. Age of First Suicide Attempt

Exhibit 92. Access to Needed Mental Health Services in the Last 12 Months

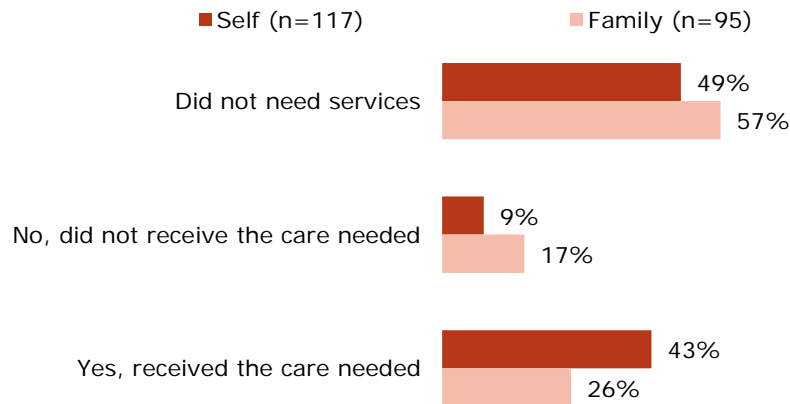


Exhibit 93. Main reasons Why Mental Health Services were NOT Received (n=19)

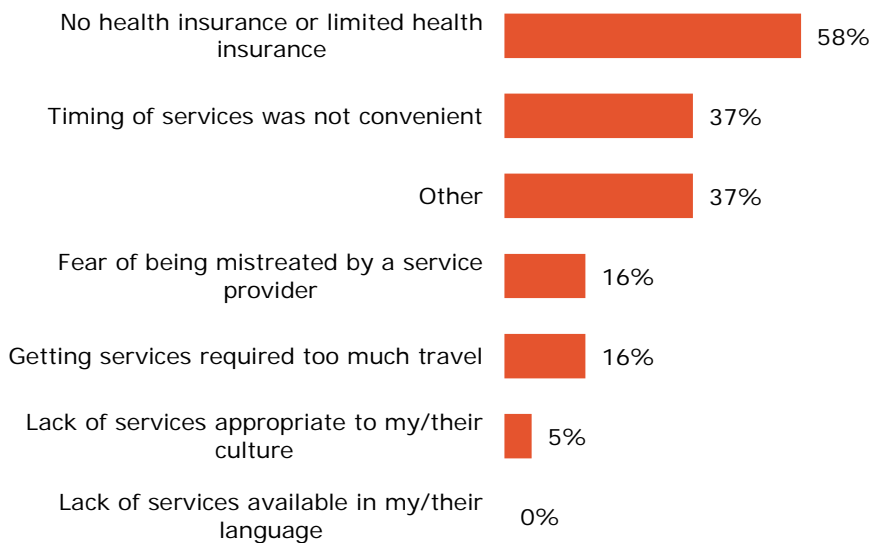


Exhibit 94. Staff that Provided Services were Sensitive to Cultural Background (n=57)

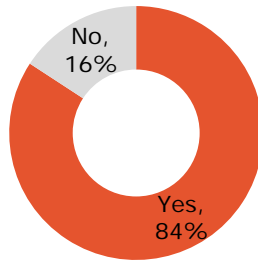


Exhibit 95. Services were Provided in Preferred Language (n=60)

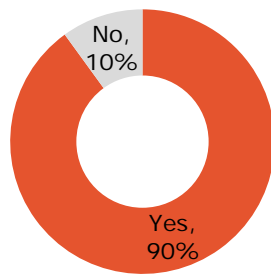


Exhibit 96. Overall Satisfaction with Received Services (n=58)

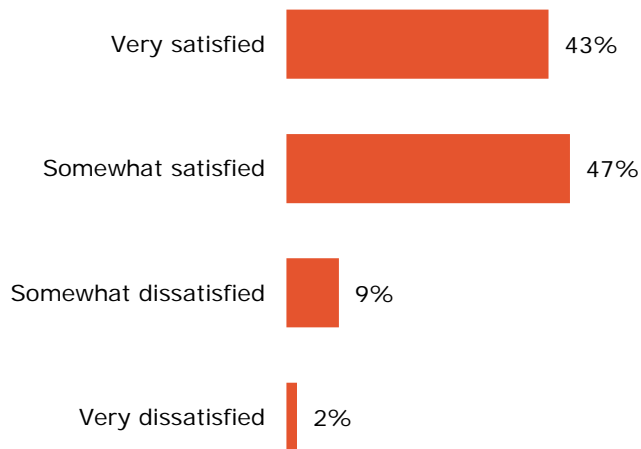
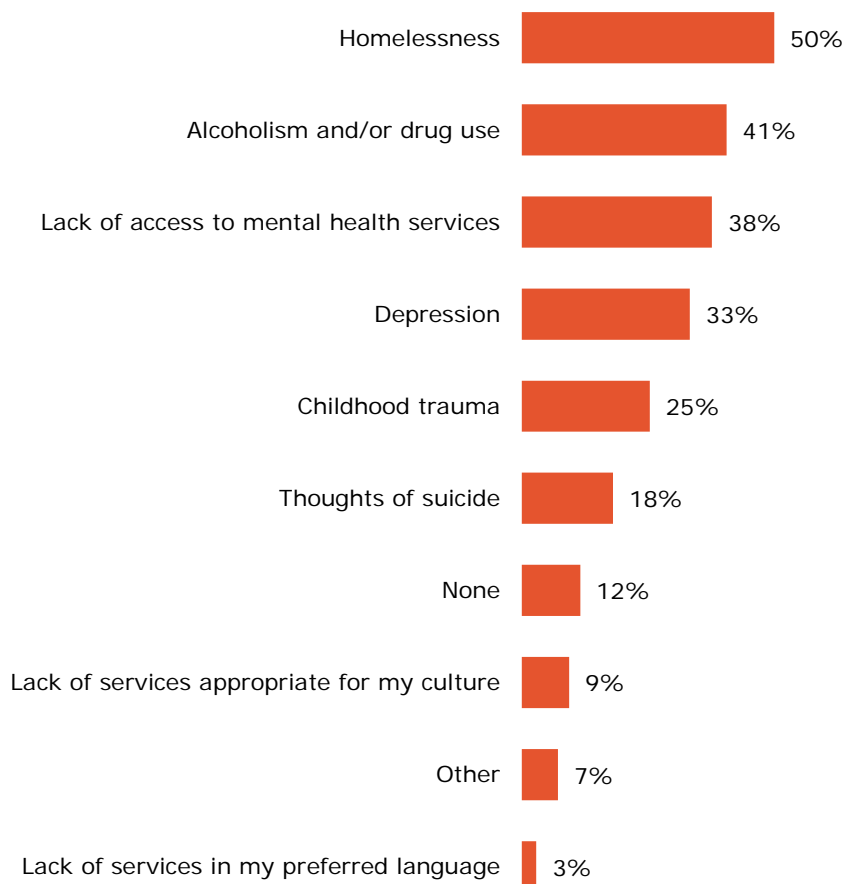


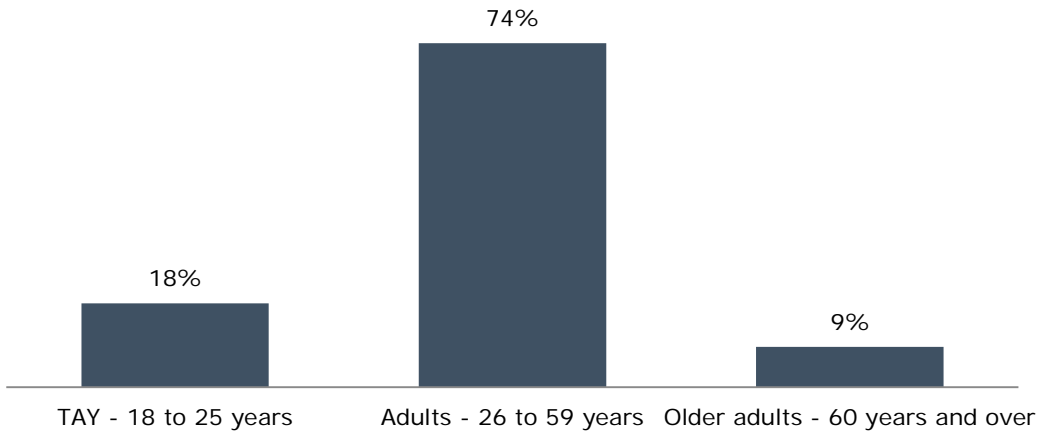
Exhibit 97. Most Urgent Mental Health Issues in the Community (n=138)

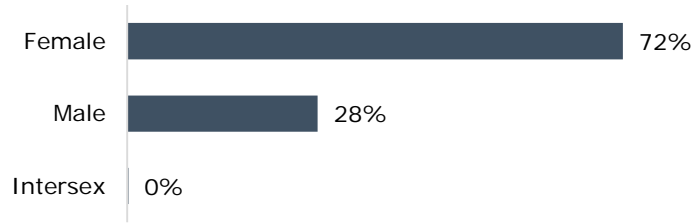


Exhibit 101. Gender of Respondent (n=2,367)

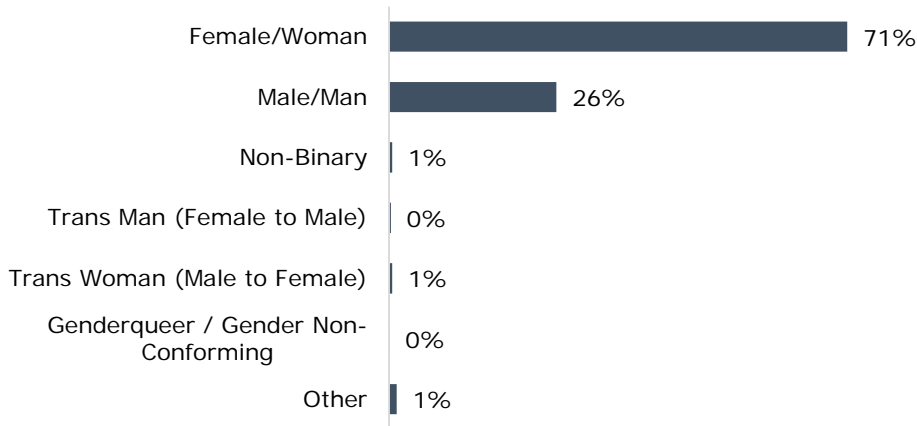


Exhibit 102. Current Sexual Orientation (n=1,945)

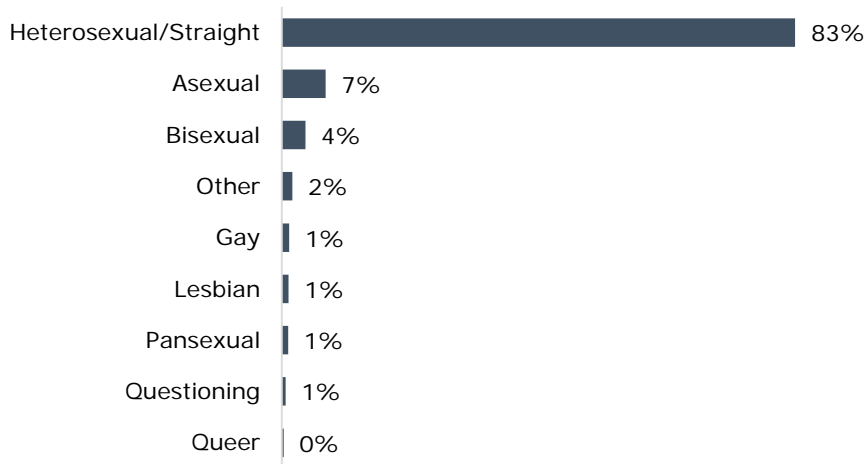


Exhibit 103. Country of birth of the respondent (n=2,385)

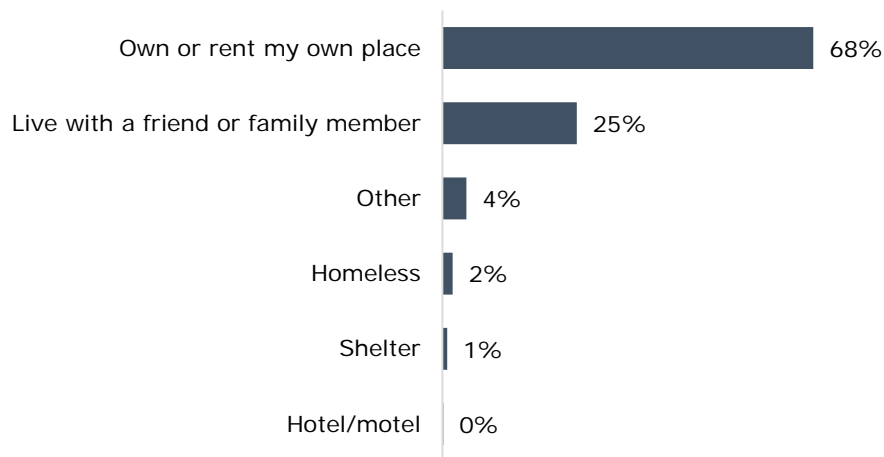
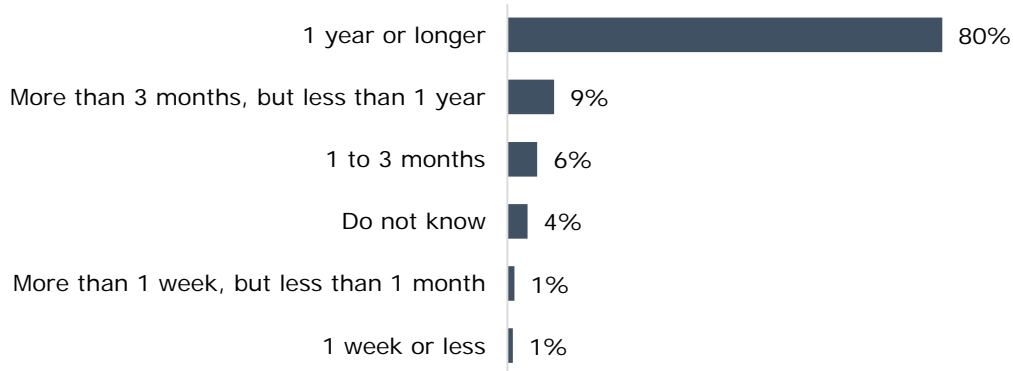


Exhibit 110. Length of Time in Current Living Situation (n=2,329)

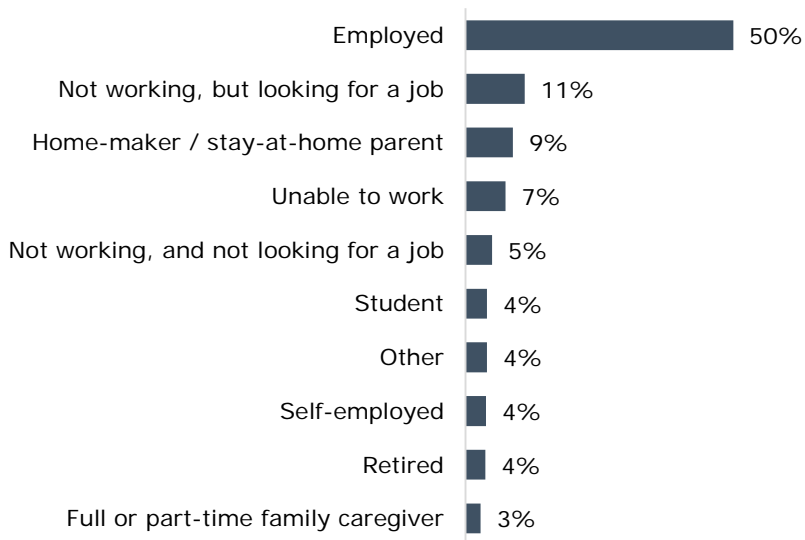
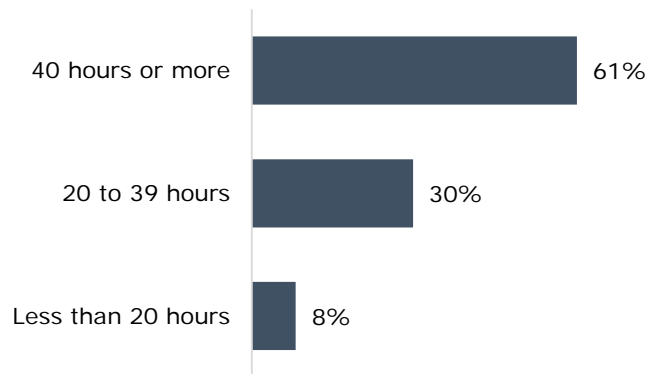


Exhibit 112. Number of Hours Respondent Works Each Week (n=1,265)⁸

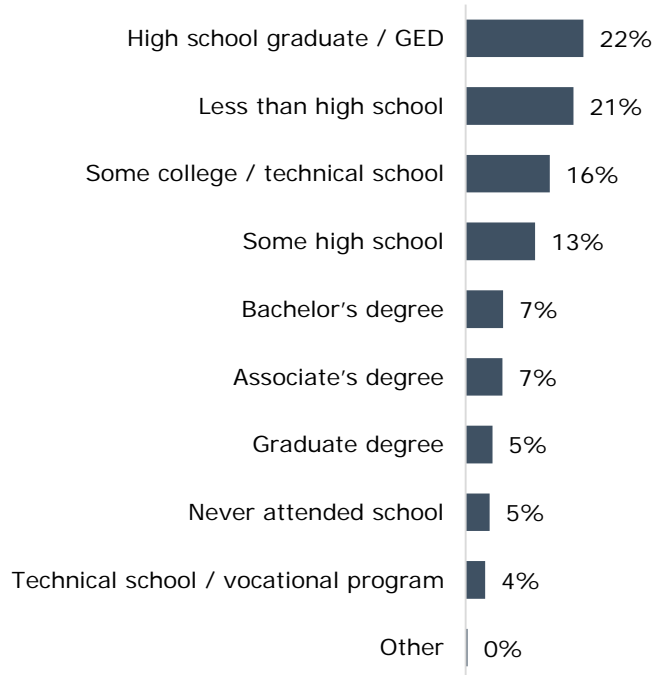
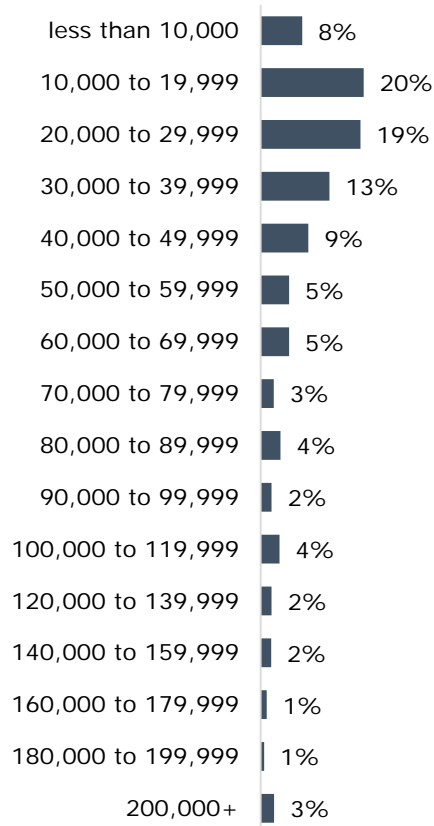
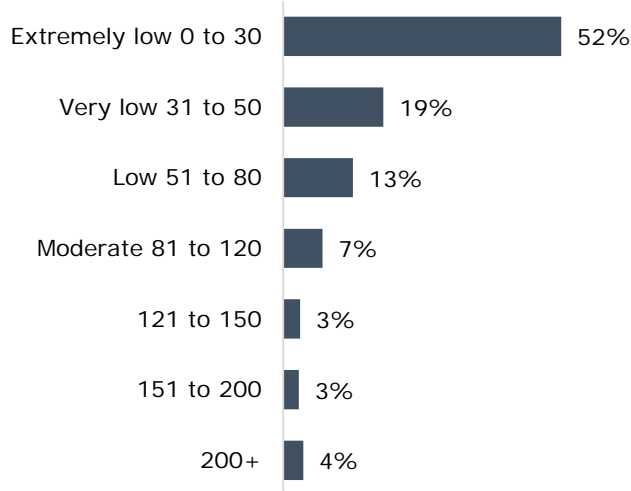


Exhibit 114. Total household income (n=1,378)



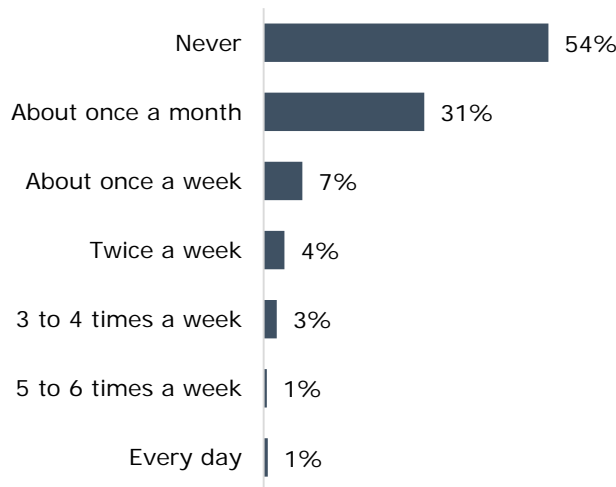

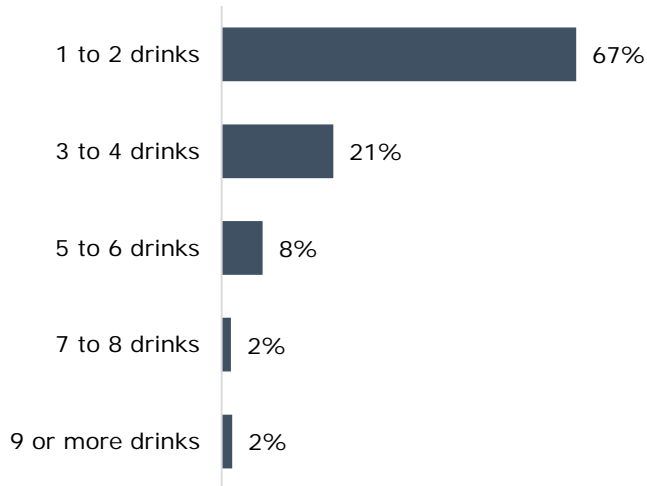


Exhibit 118. Substance Use in the Last 12 Months (n=2,292)

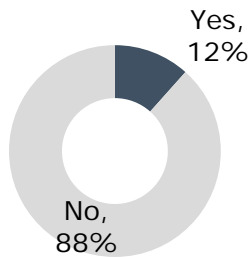


Exhibit 119. Mental Health Rating (n=2,252)

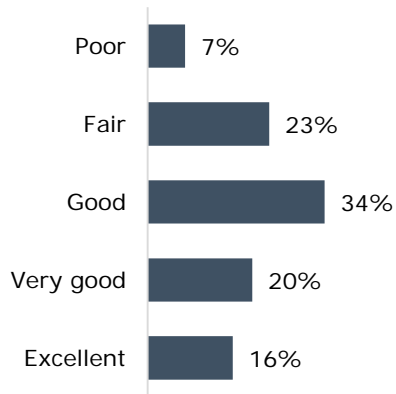


Exhibit 120. Mental Health Diagnosis by a Doctor or Other Healthcare Professional (n=1,428)

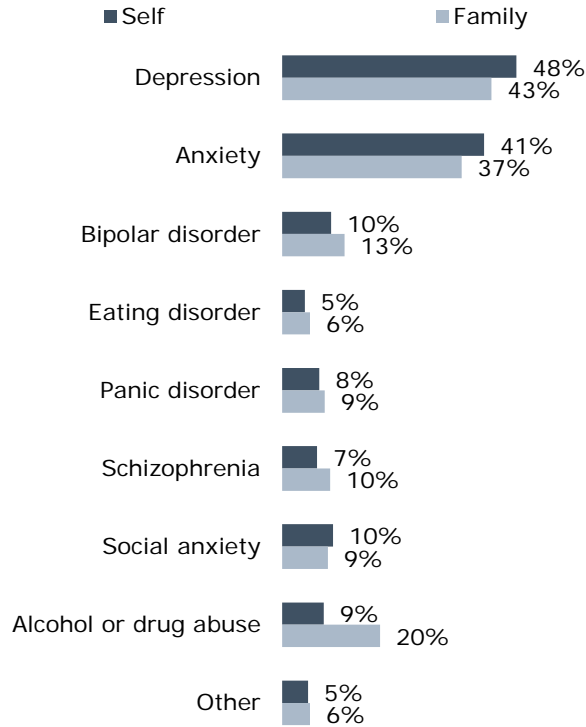


Exhibit 121. Age of First Mental Health Diagnosis

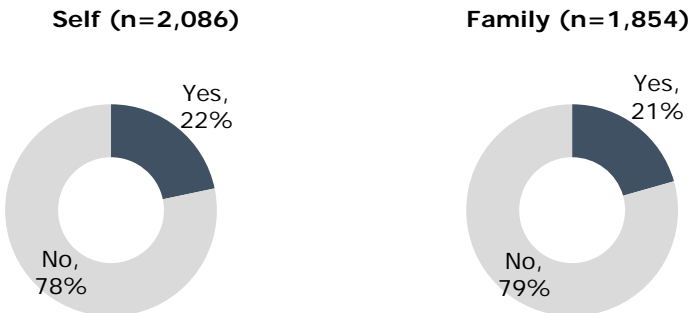


Exhibit 123. Age of First Suicide Attempt

Exhibit 124. Access to Needed Mental Health Services in the Last 12 Months

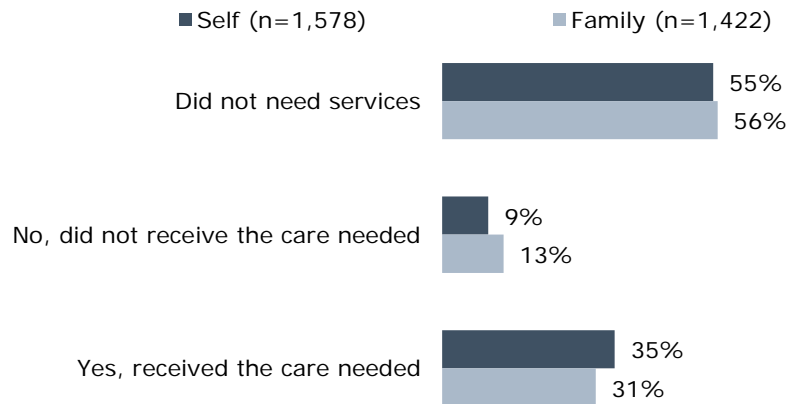


Exhibit 125. Main reasons Why Mental Health Services were NOT Received (n=207)

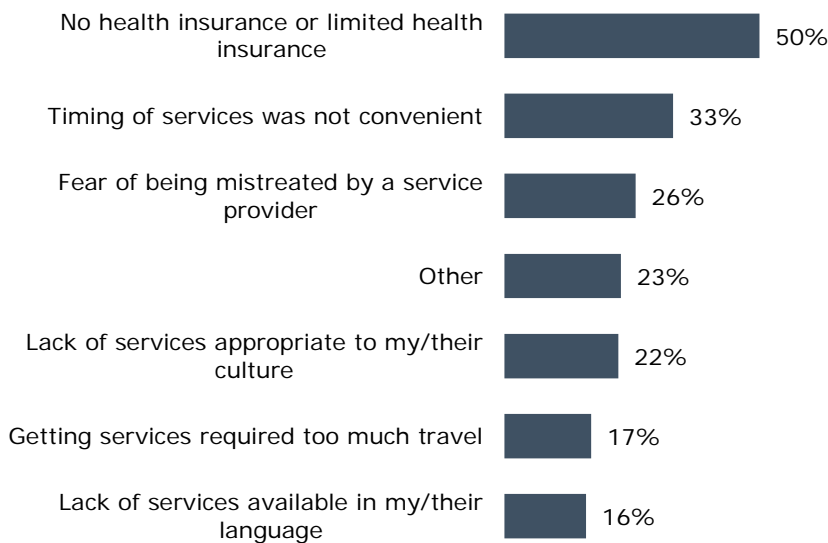


Exhibit 126. Staff that Provided Services were Sensitive to Cultural Background (n=738)

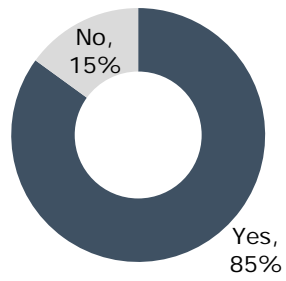


Exhibit 127. Services were Provided in Preferred Language (n=769)

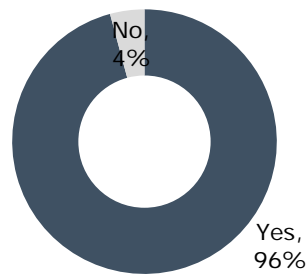


Exhibit 128. Overall Satisfaction with Received Services (n=753)

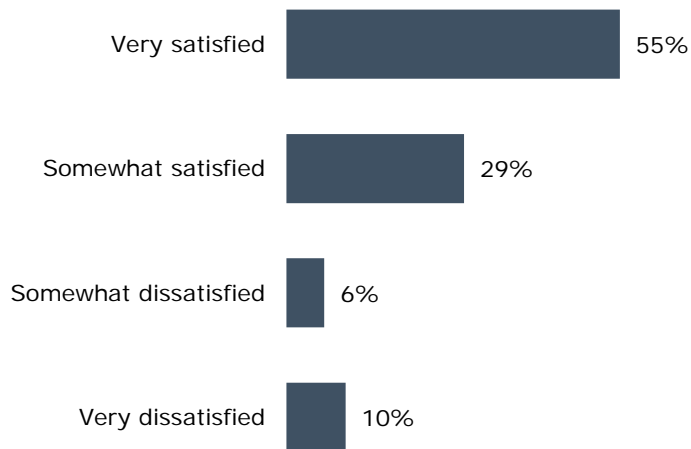
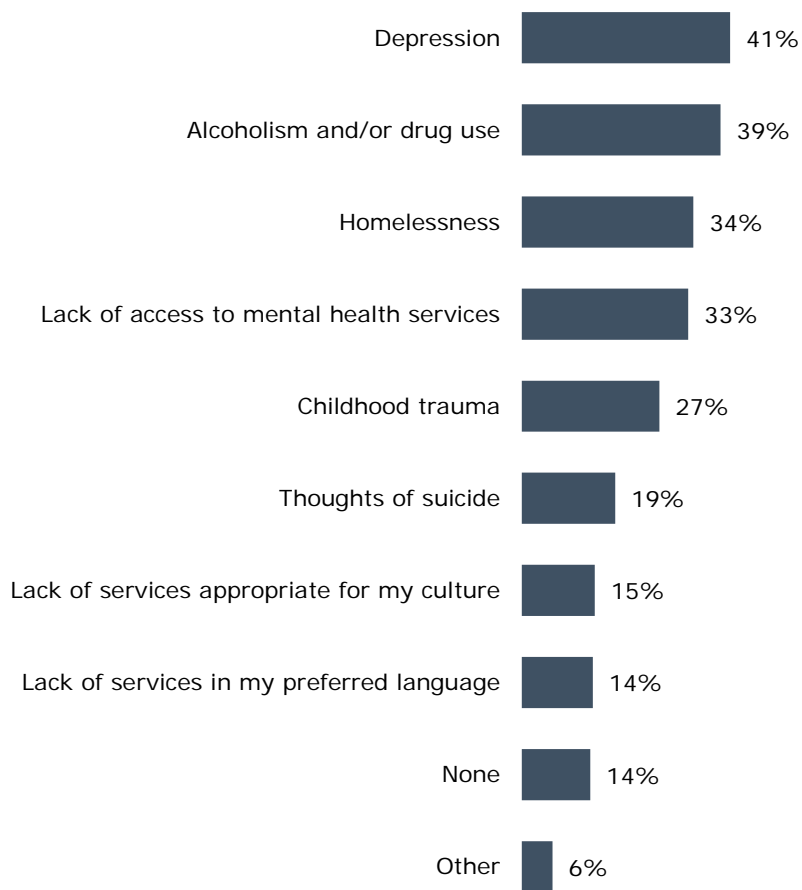


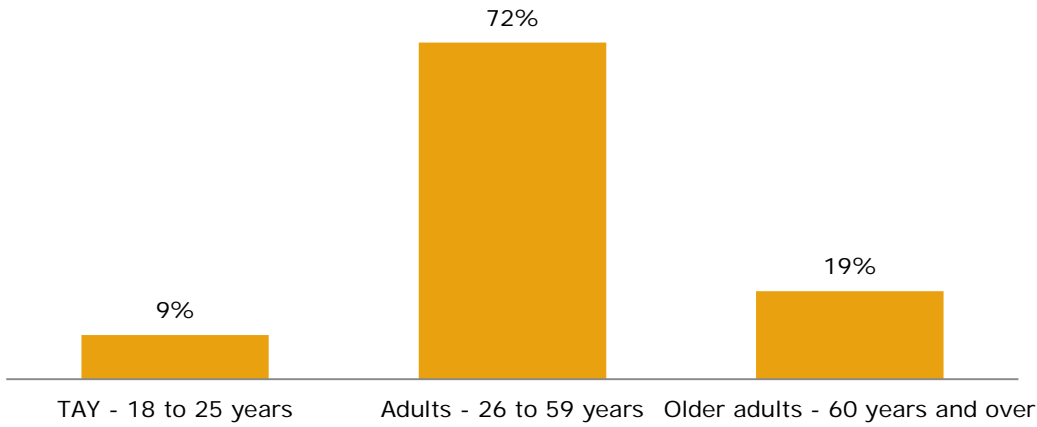
Exhibit 129. Most Urgent Mental Health Issues in the Community (n=2,112)

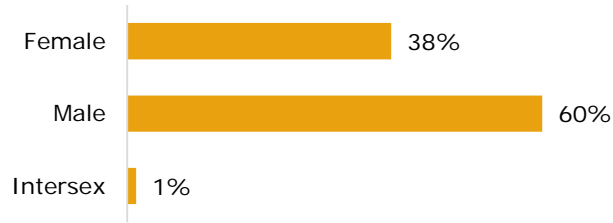


Exhibit 133. Gender of Respondent (n=154)

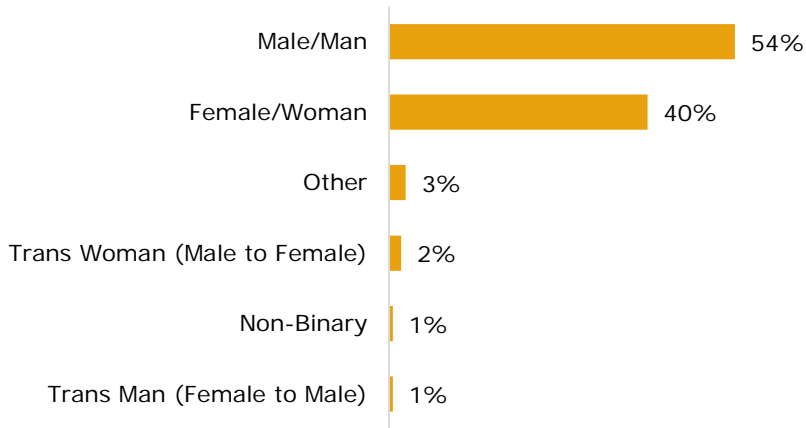


Exhibit 134. Current Sexual Orientation (n=151)

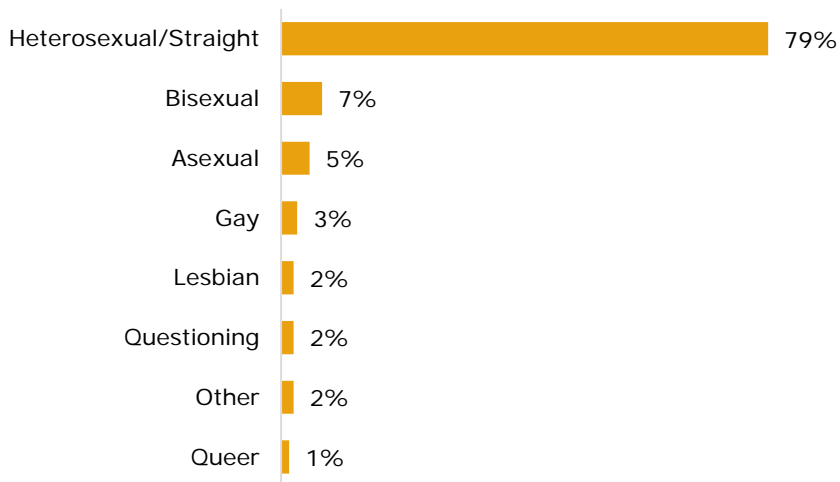


Exhibit 135. Country of birth of the respondent (n=155)

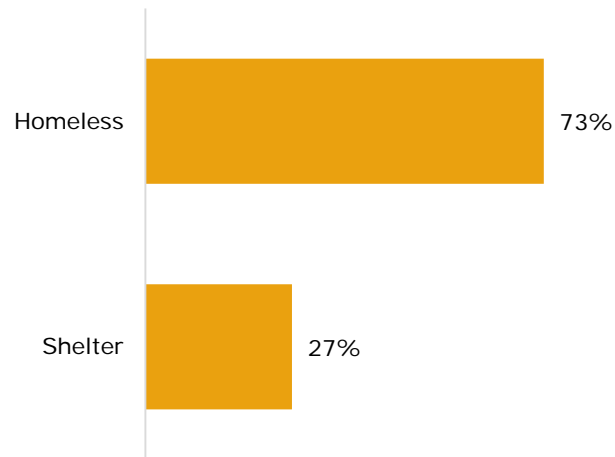
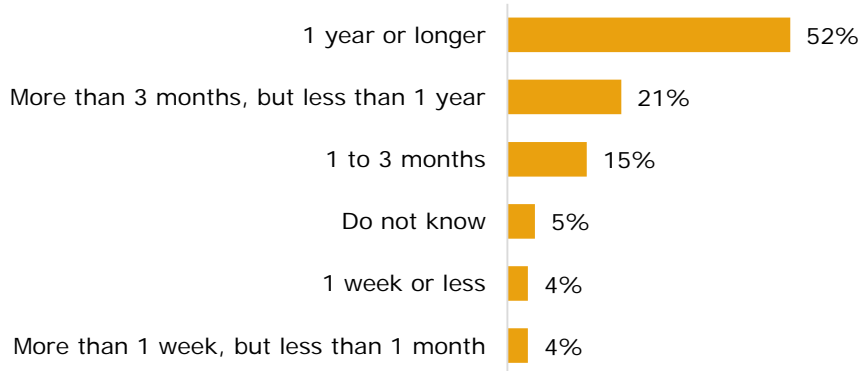


Exhibit 142. Length of Time in Current Living Situation (n=158)

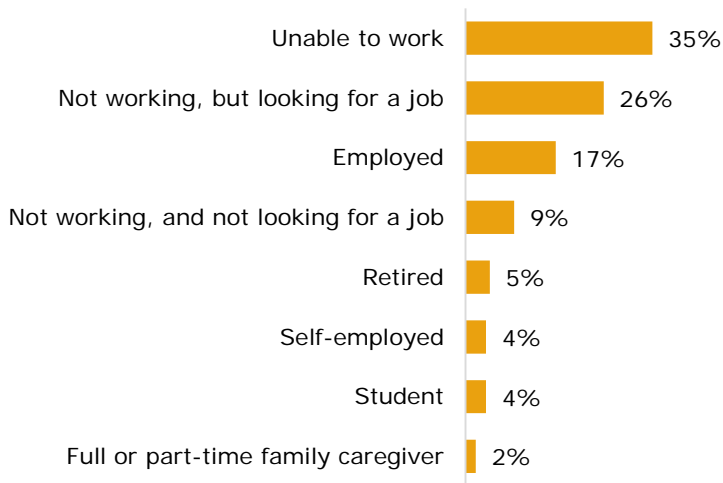
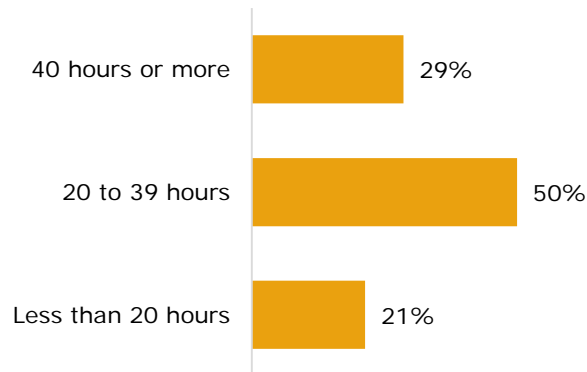


Exhibit 144. Number of Hours Respondent Works Each Week (n=28)¹⁰

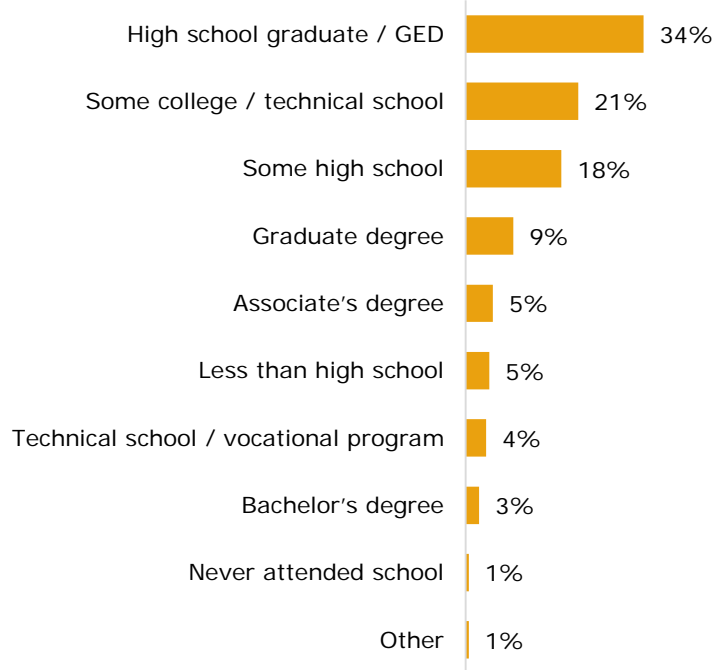
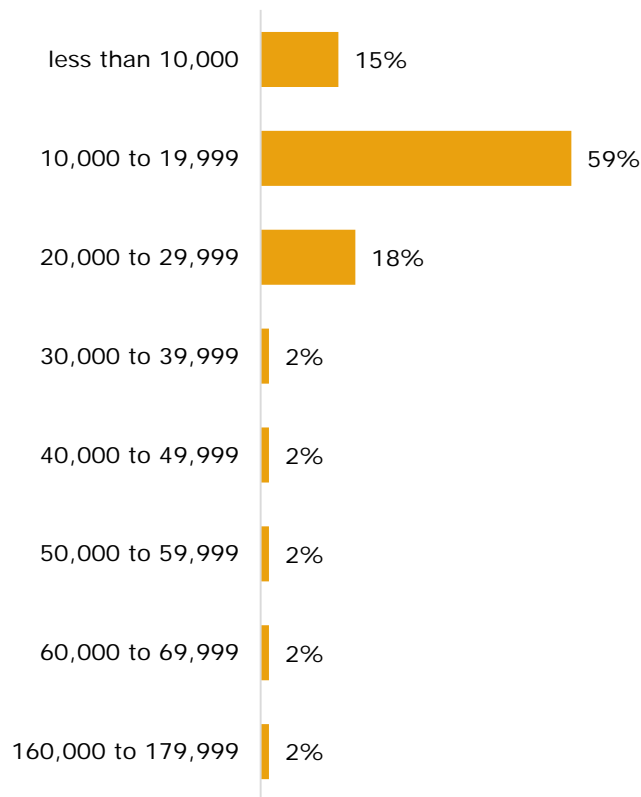
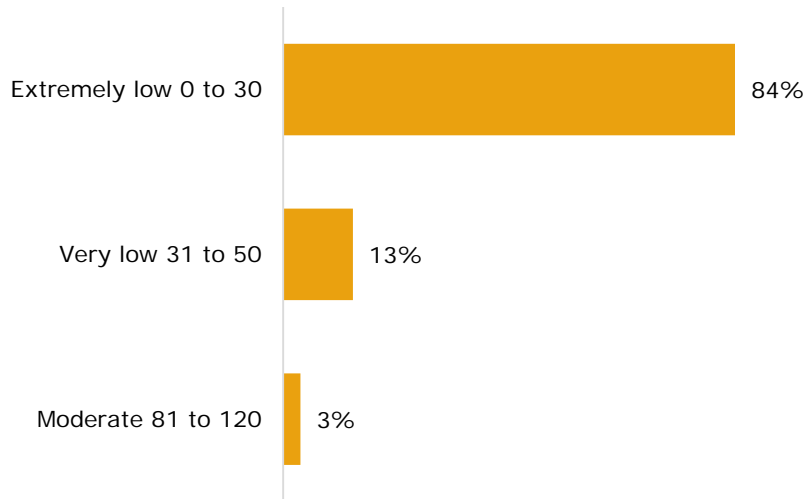


Exhibit 146. Total household income (n=61)



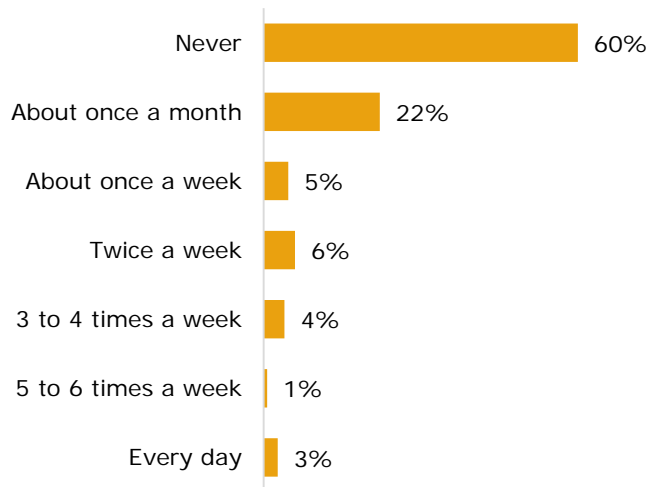

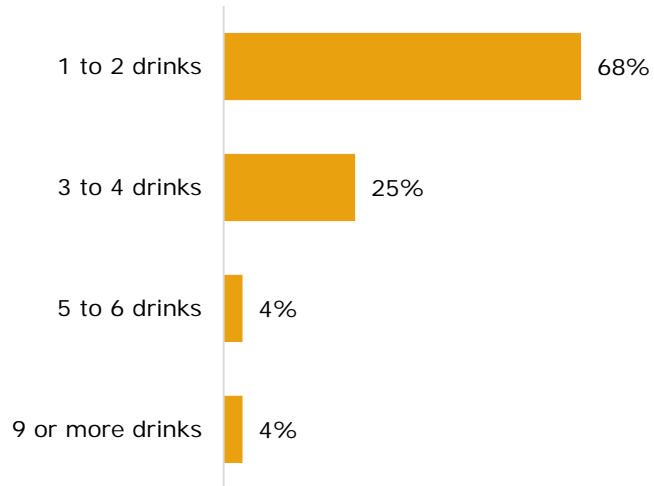


Exhibit 150. Substance Use in the Last 12 Months (n=148)

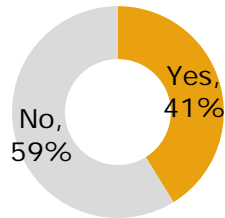


Exhibit 151. Mental Health Rating (n=147)



Exhibit 152. Mental Health Diagnosis by a Doctor or Other Healthcare Professional (n=134)

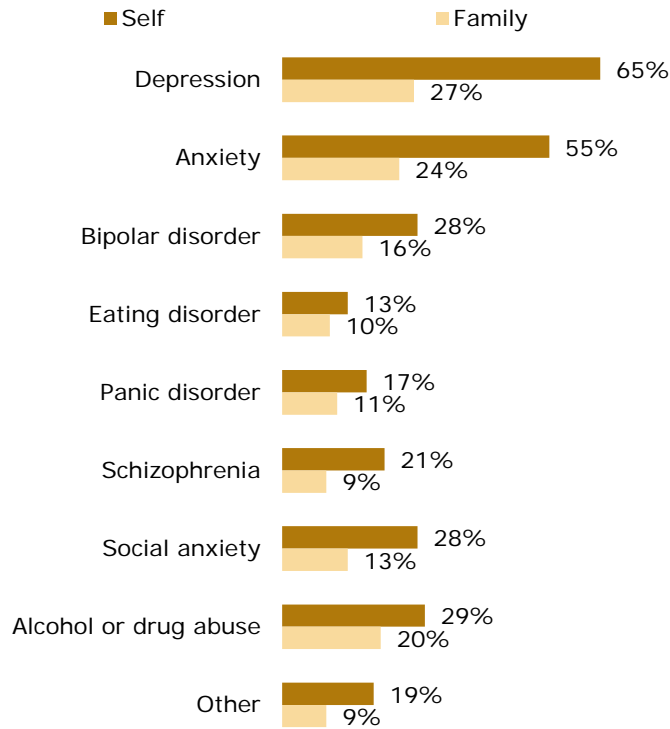

Exhibit 154. Suicide Ideation/Attempt

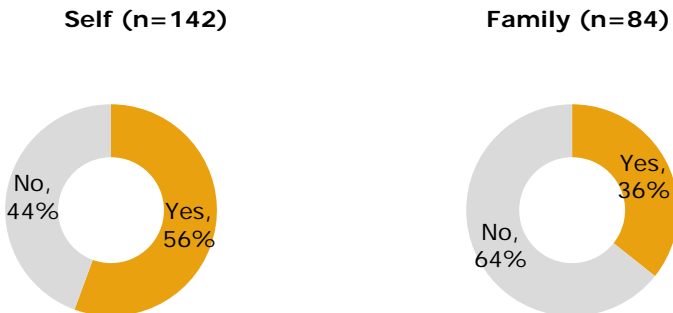


Exhibit 155. Age of First Suicide Attempt

Exhibit 156. Access to Needed Mental Health Services in the Last 12 Months

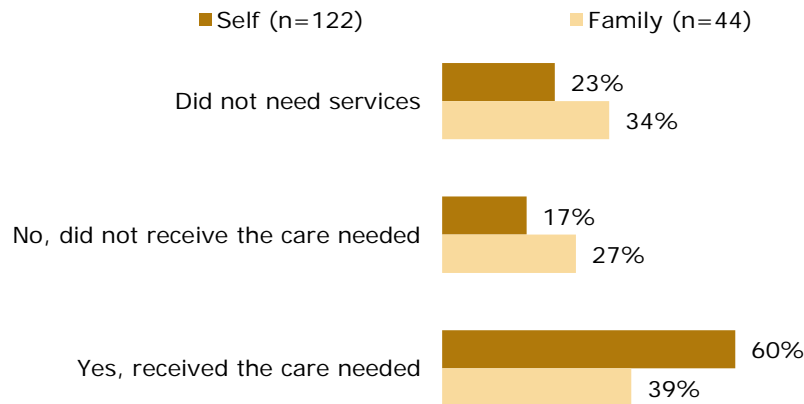


Exhibit 157. Main reasons Why Mental Health Services were NOT Received (n=23)

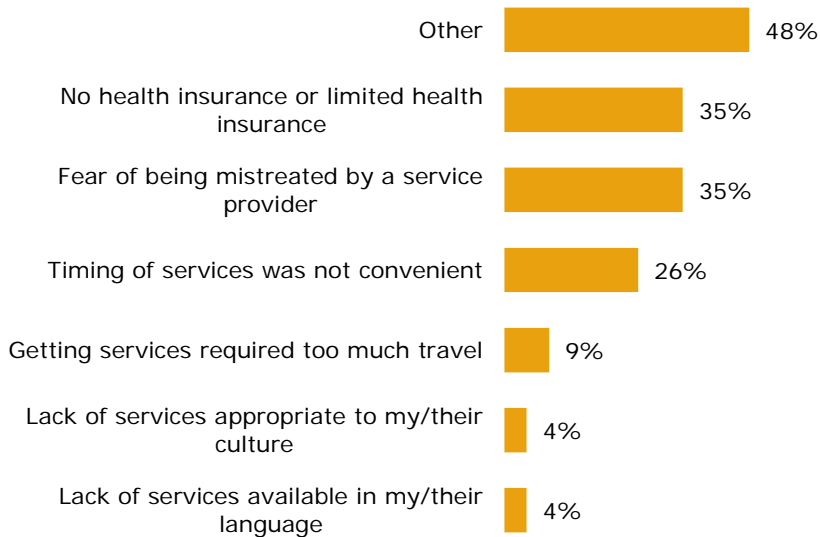


Exhibit 158. Staff that Provided Services were Sensitive to Cultural Background (n=71)

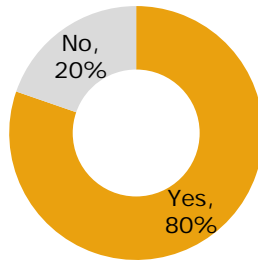


Exhibit 159. Services were Provided in Preferred Language (n=73)

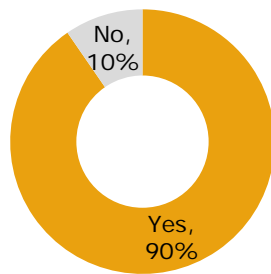


Exhibit 160. Overall Satisfaction with Received Services (n=72)

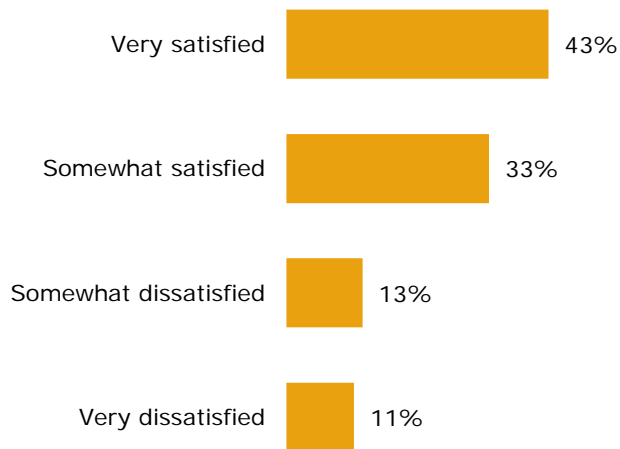
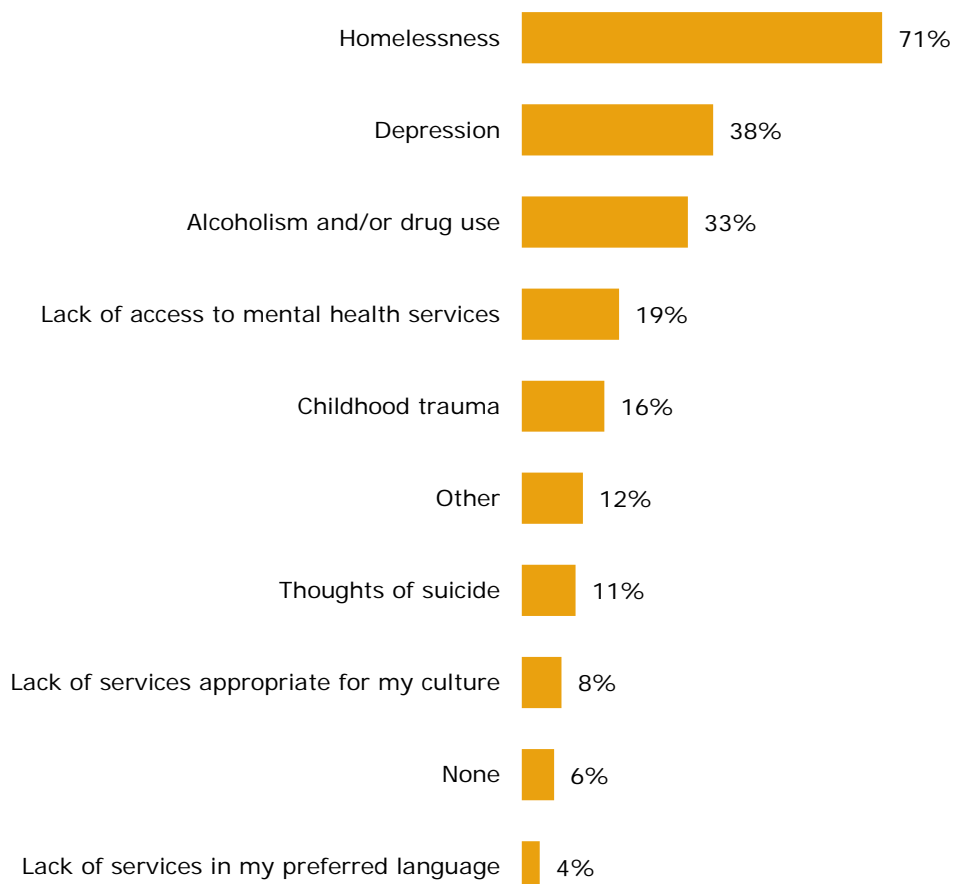


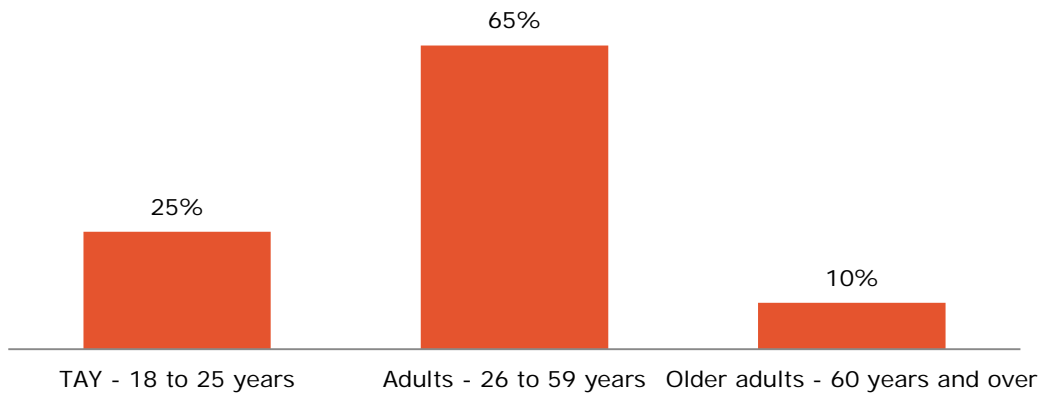
Exhibit 161. Most Urgent Mental Health Issues in the Community (n=140)

Exhibit 164. Sex Assigned at Birth (n=570)

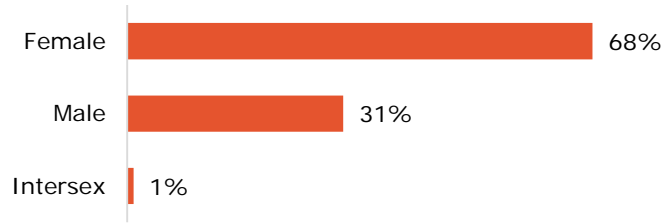


Exhibit 165. Gender of Respondent (n=559)

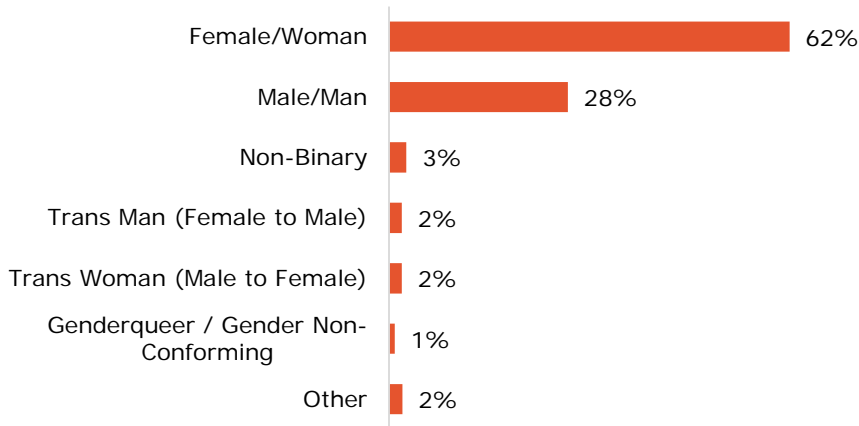


Exhibit 166. Current Sexual Orientation (n=573)

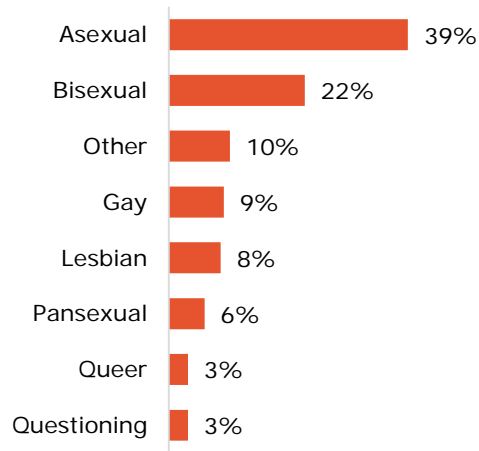


Exhibit 167. Country of birth of the respondent (n=564)

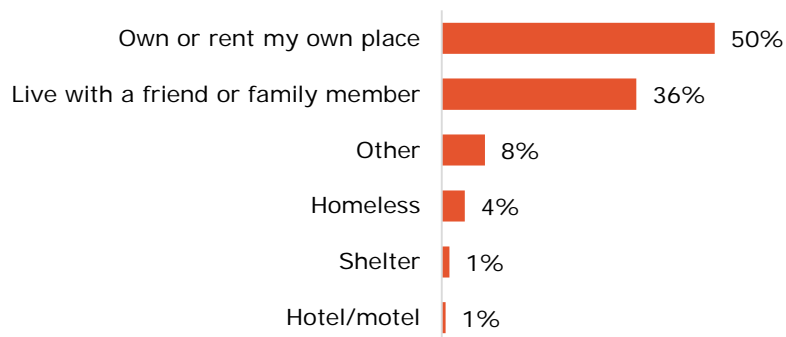
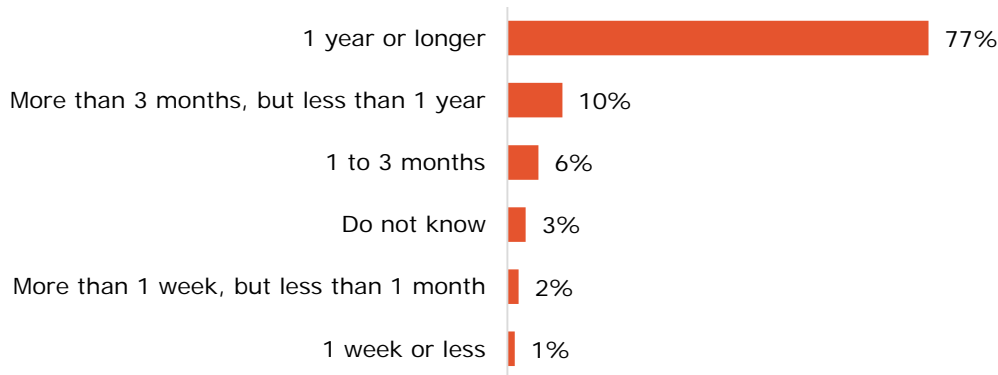


Exhibit 174. Length of Time in Current Living Situation (n=563)

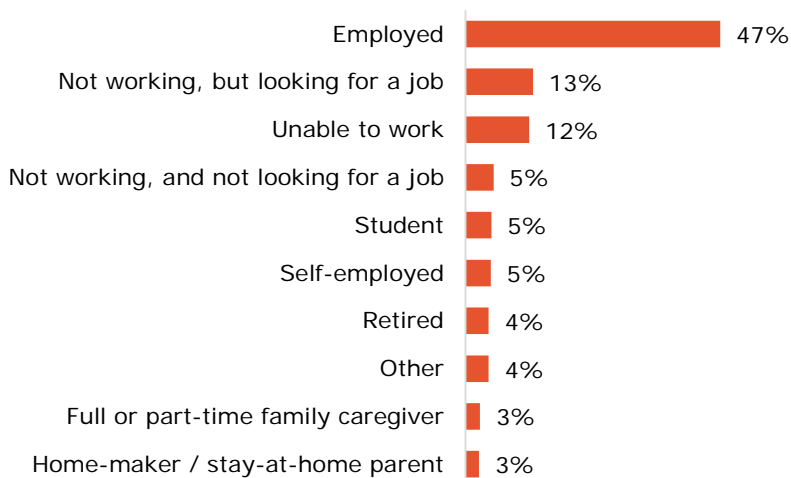


Exhibit 176. Number of Hours Respondent Works Each Week (n=287)¹²

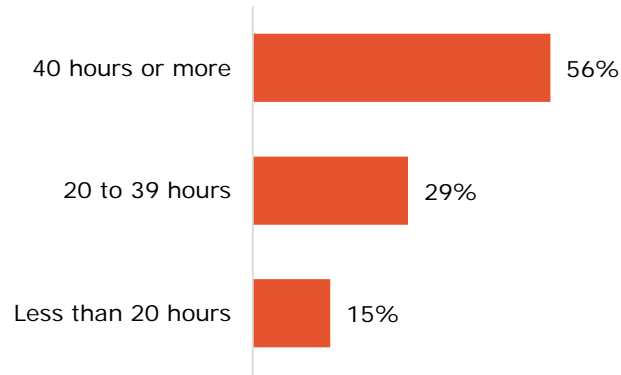


Exhibit 177. Highest level of education (n=554)

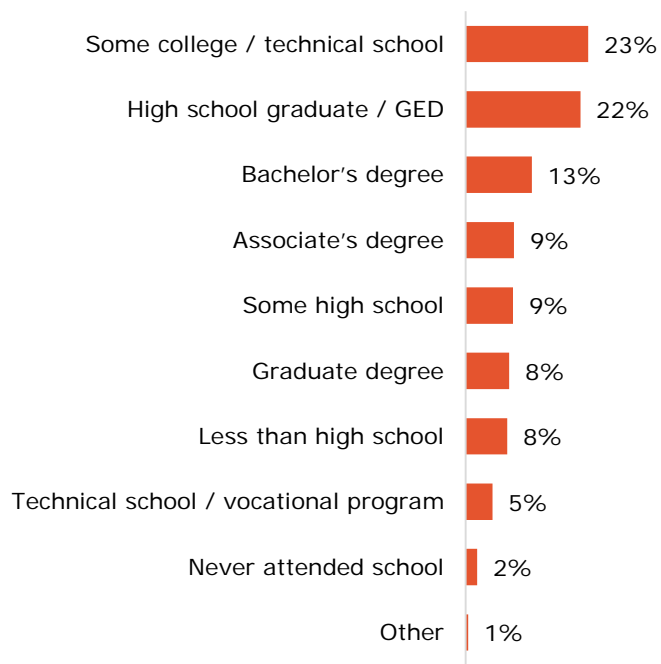
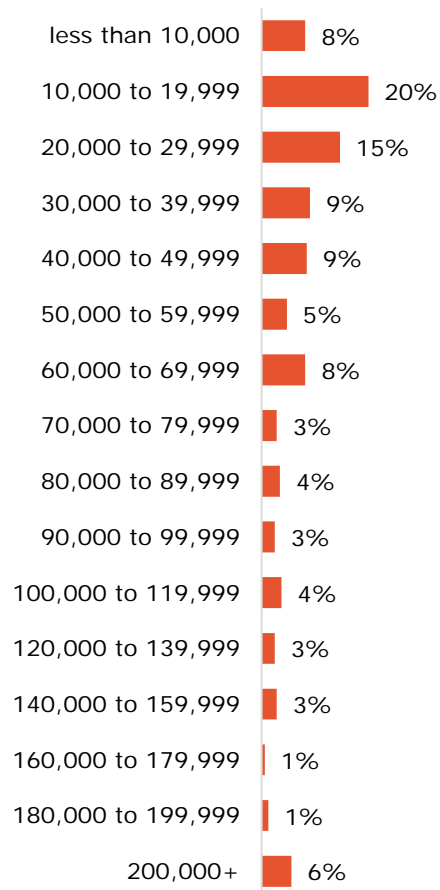


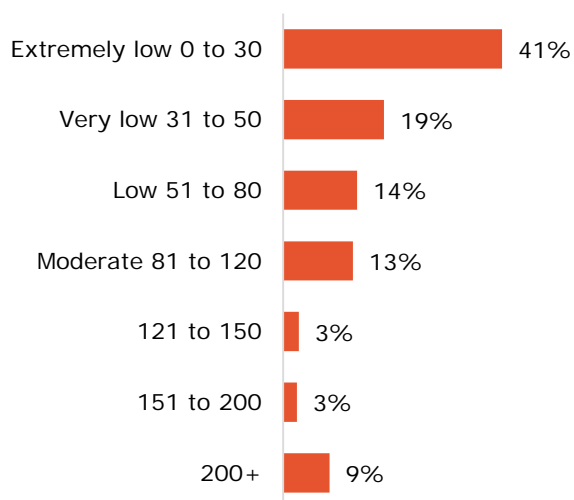

Exhibit 180. Alcohol Consumption in the last 12 months (n=532)

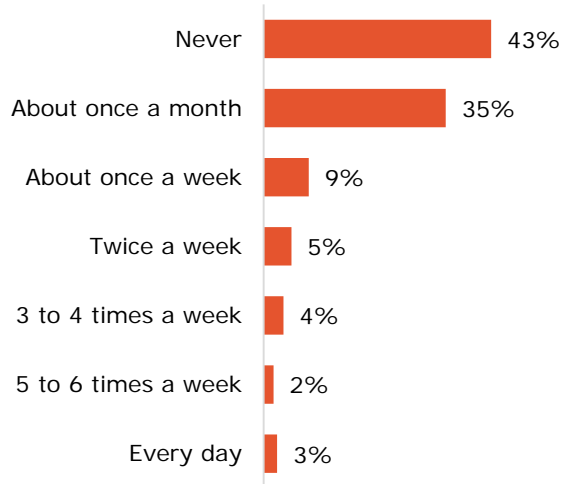


Exhibit 181. For Respondents who Reported Drinking, Average Number of Alcoholic Drinks (n=295)

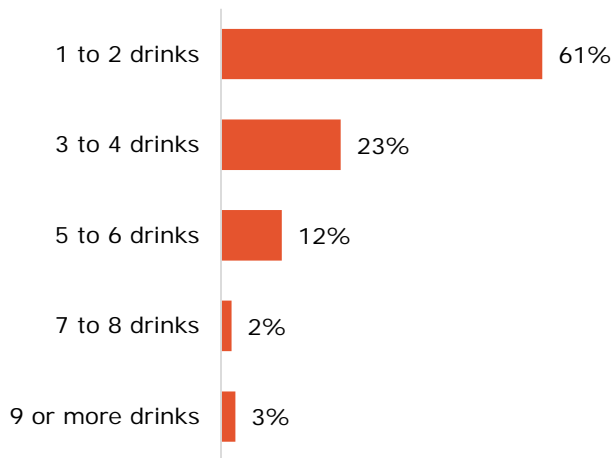


Exhibit 182. Substance Use in the Last 12 Months (n=532)

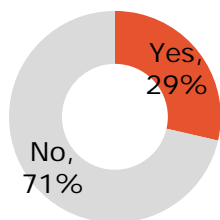


Exhibit 183. Mental Health Rating (n=518)



Exhibit 184. Mental Health Diagnosis by a Doctor or Other Healthcare Professional (n=427)

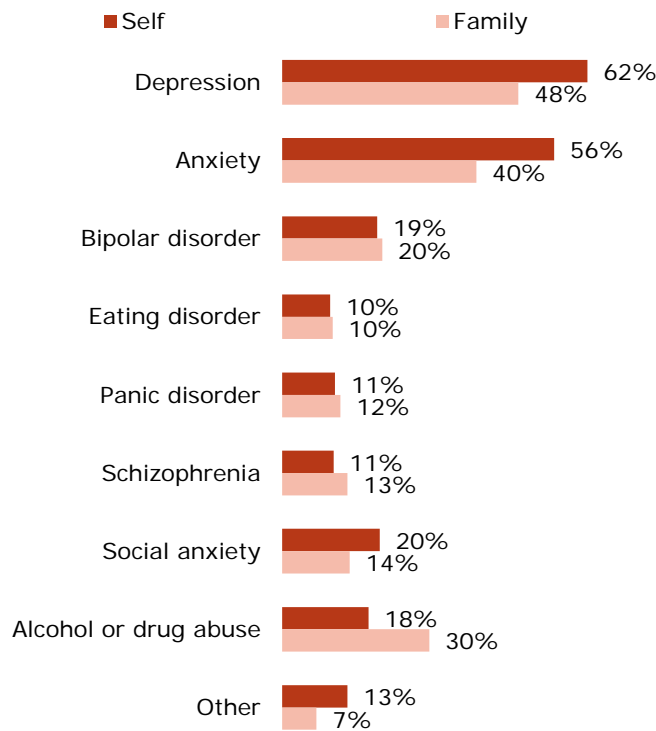


Exhibit 185. Age of First Mental Health Diagnosis

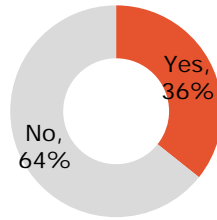
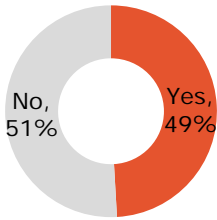


Exhibit 187. Age of First Suicide Attempt

Exhibit 188. Access to Needed Mental Health Services in the Last 12 Months

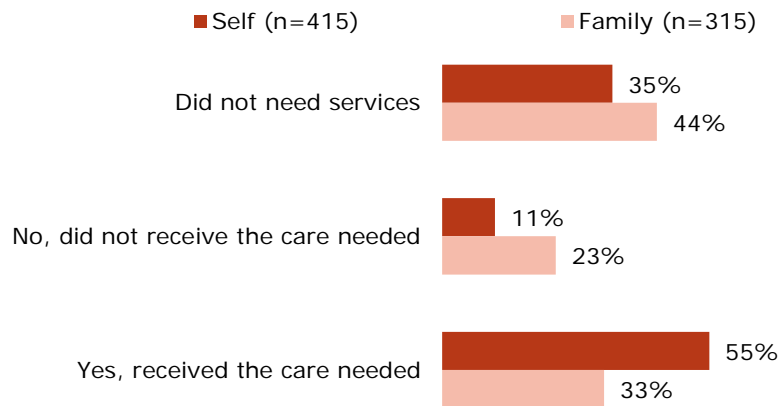


Exhibit 189. Main reasons Why Mental Health Services were NOT Received (n=88)

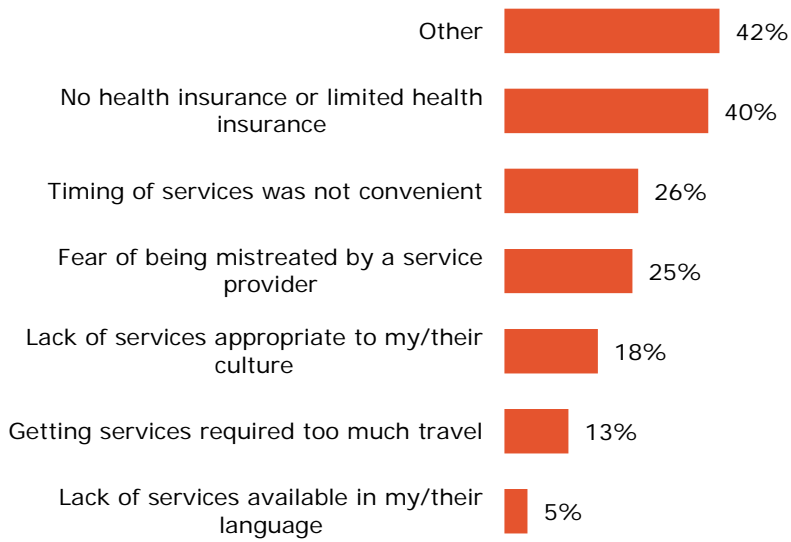


Exhibit 190. Staff that Provided Services were Sensitive to Cultural Background (n=249)

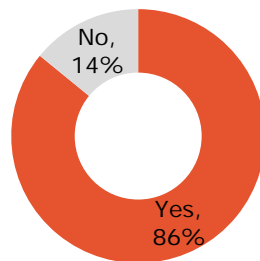


Exhibit 191. Services were Provided in Preferred Language (n=256)

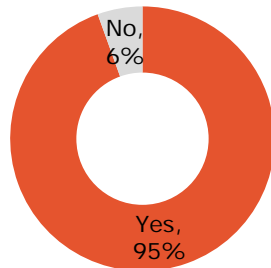


Exhibit 192. Overall Satisfaction with Received Services (n=247)

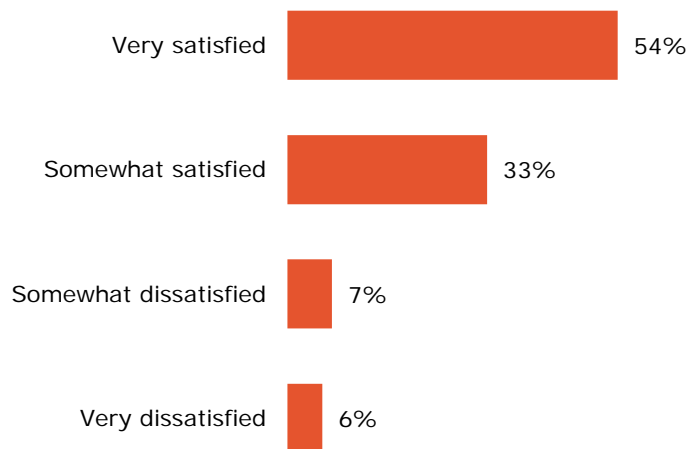
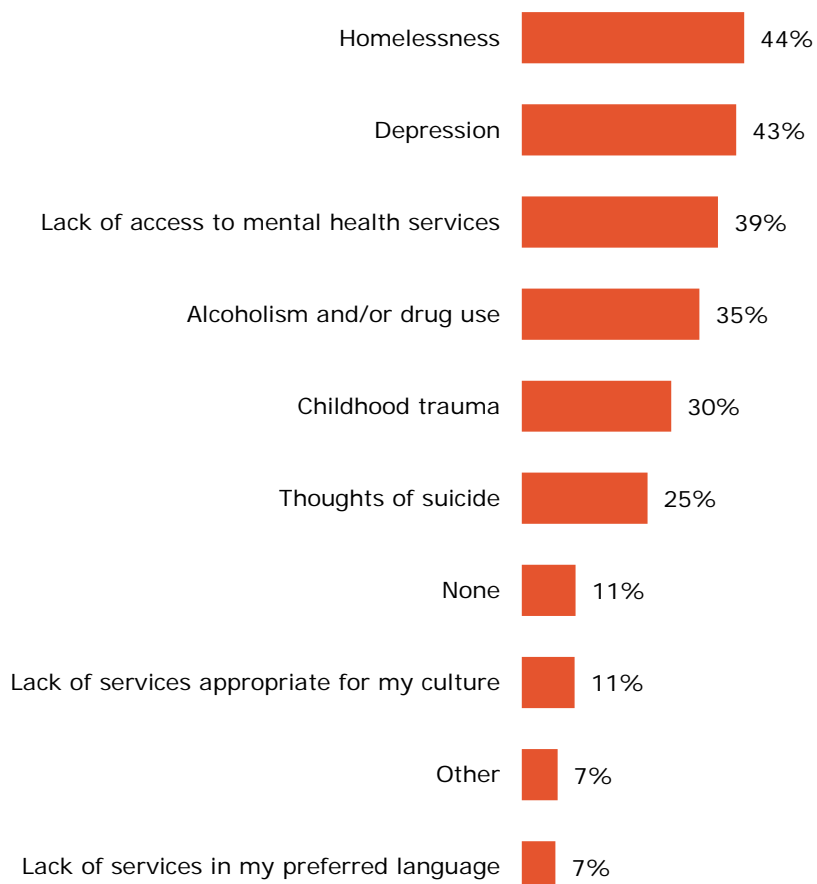


Exhibit 193. Most Urgent Mental Health Issues in the Community (n=494)

Exhibit 197. Sex Assigned at Birth (n=595)

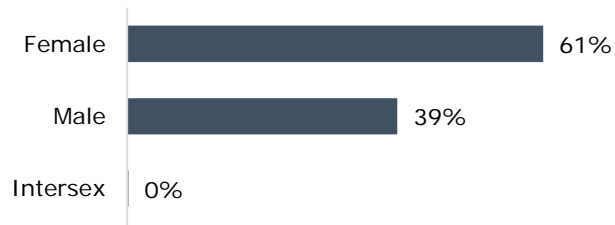


Exhibit 198. Gender of Respondent (n=574)

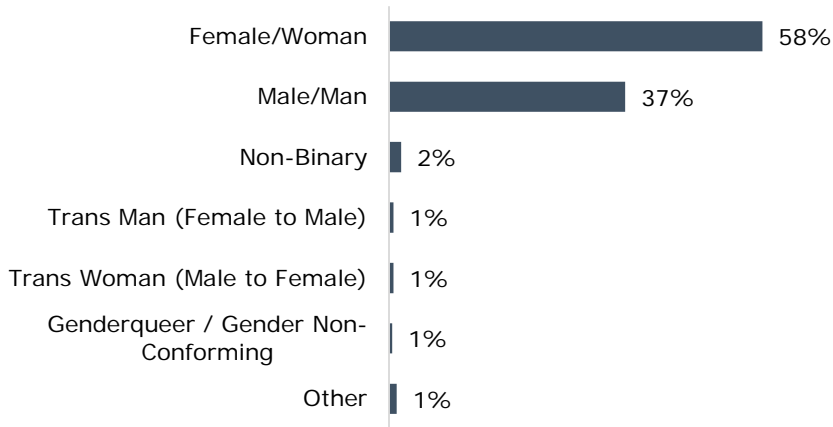
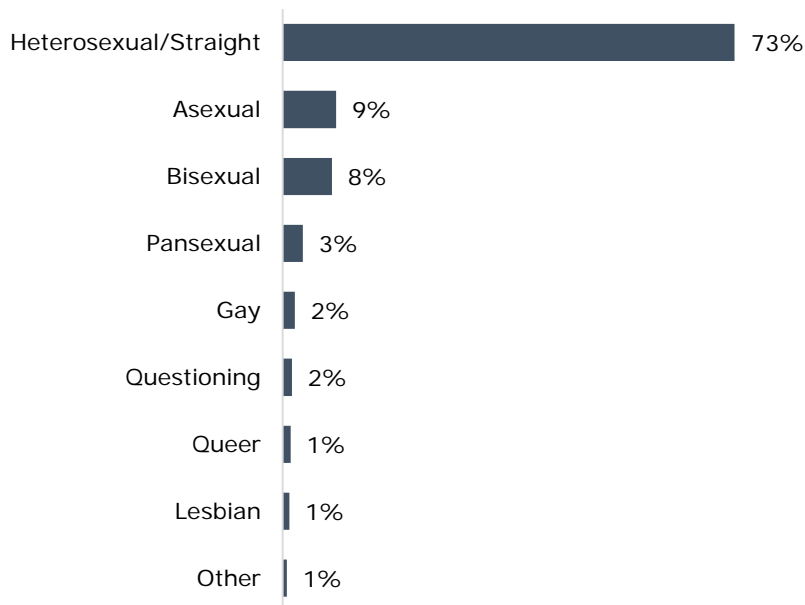


Exhibit 199. Current Sexual Orientation (n=538)

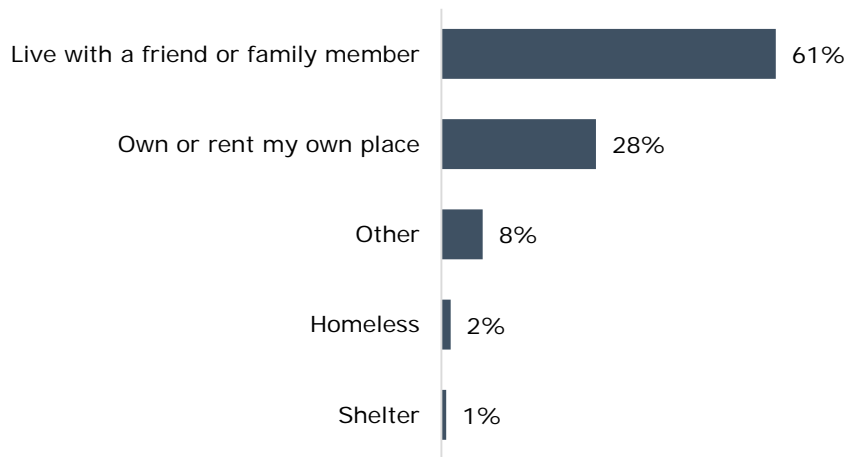

Exhibit 207. Length of Time in Current Living Situation (n=573)

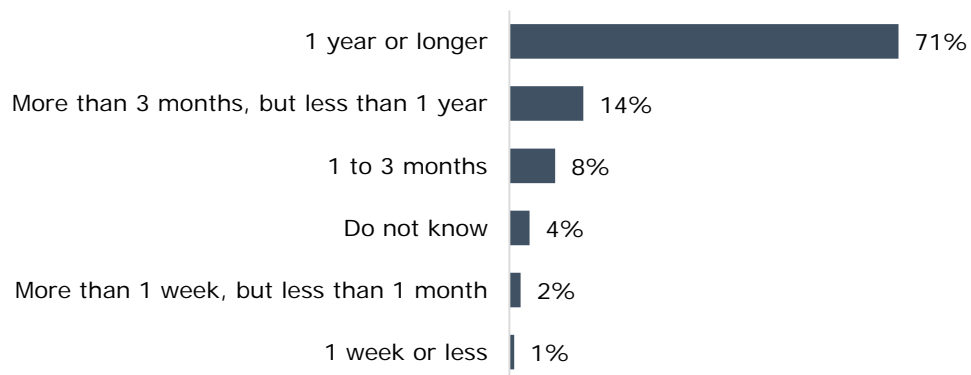


Exhibit 208. Respondents Occupation (n=574)

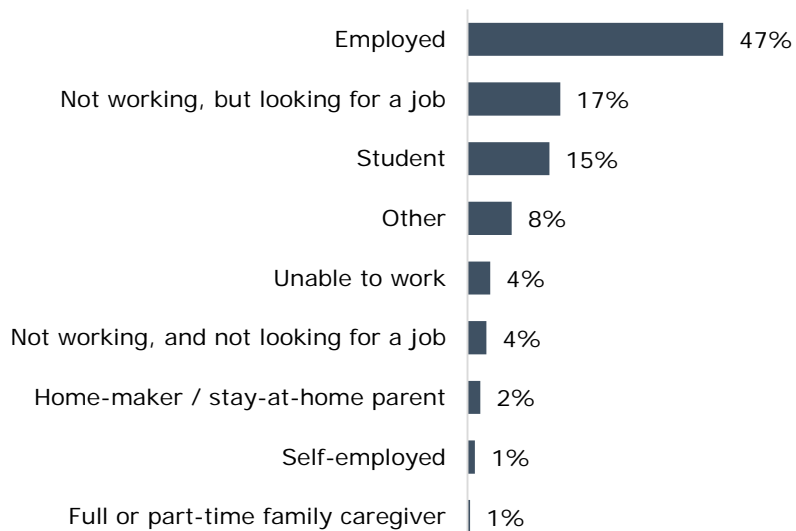


Exhibit 209. Number of Hours Respondent Works Each Week (n=302)¹⁵

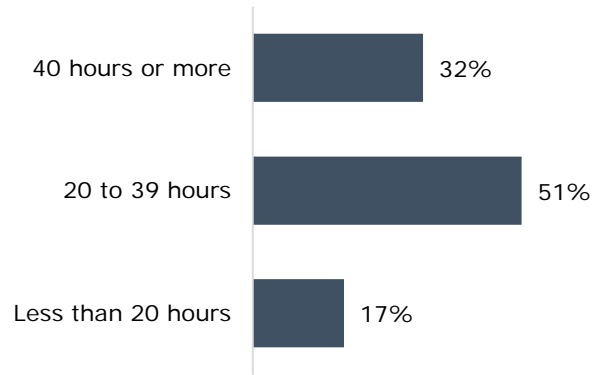
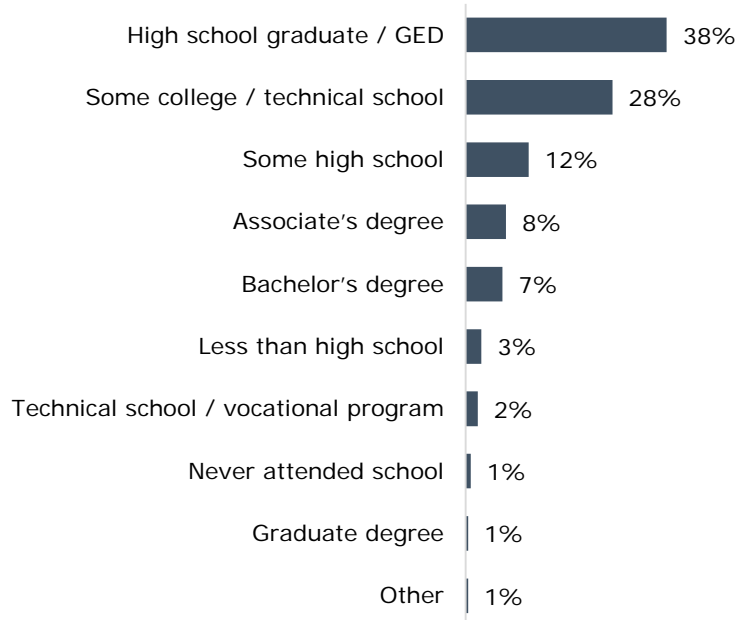
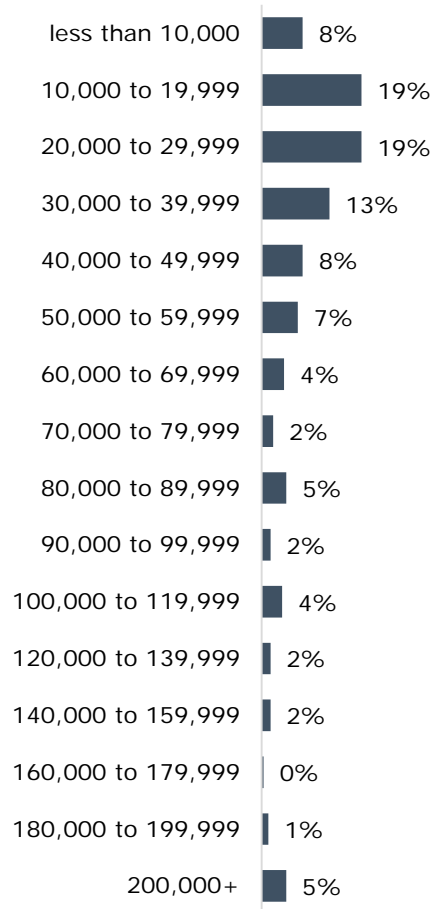


Exhibit 210. Highest level of education (n=574)



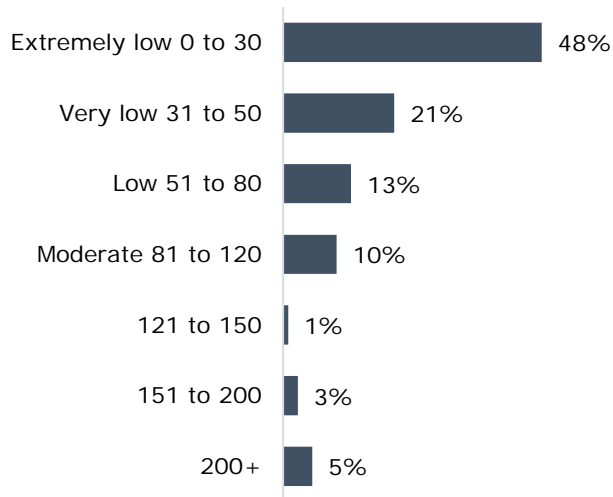

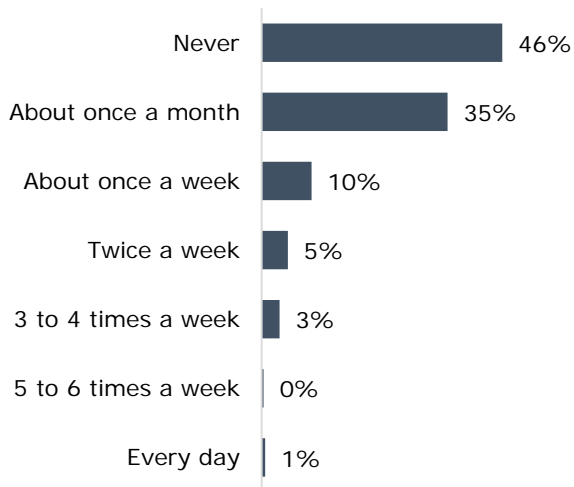

Exhibit 214. For Respondents who Reported Drinking, Average Number of Alcoholic Drinks (n=299)

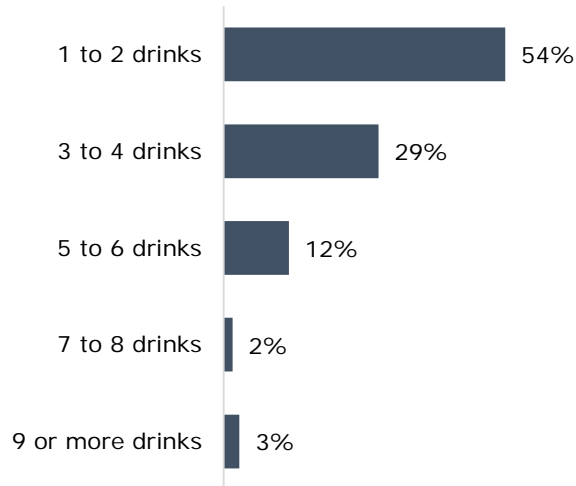


Exhibit 215. Substance Use in the Last 12 Months (n=557)

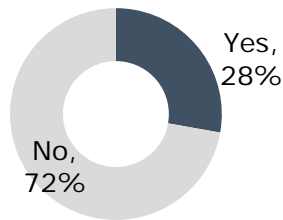


Exhibit 216. Mental Health Rating (n=555)

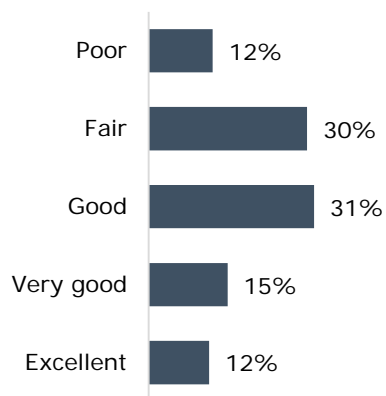


Exhibit 217. Mental Health Diagnosis by a Doctor or Other Healthcare Professional (n=385)

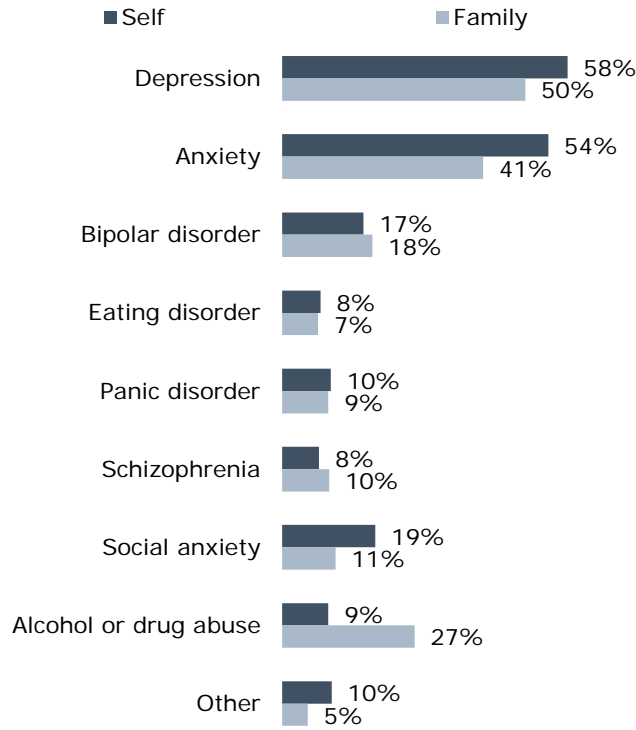


Exhibit 218. Age of First Mental Health Diagnosis

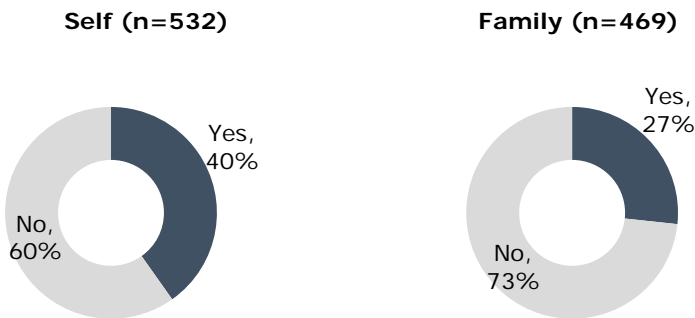


Exhibit 220. Age of First Suicide Attempt

Exhibit 221. Access to Needed Mental Health Services in the Last 12 Months

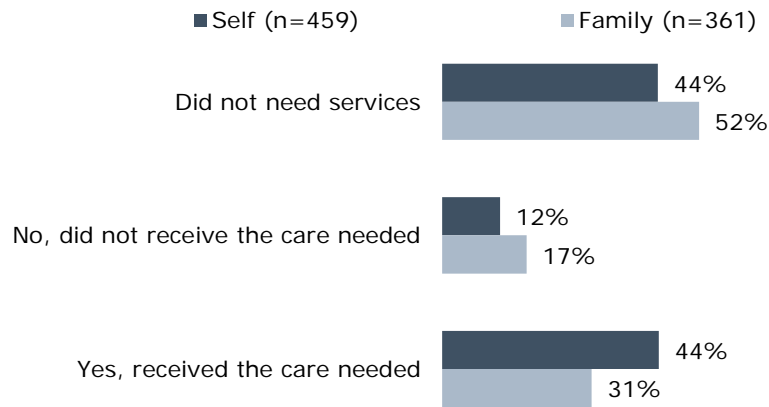


Exhibit 222. Main reasons Why Mental Health Services were NOT Received (n=74)

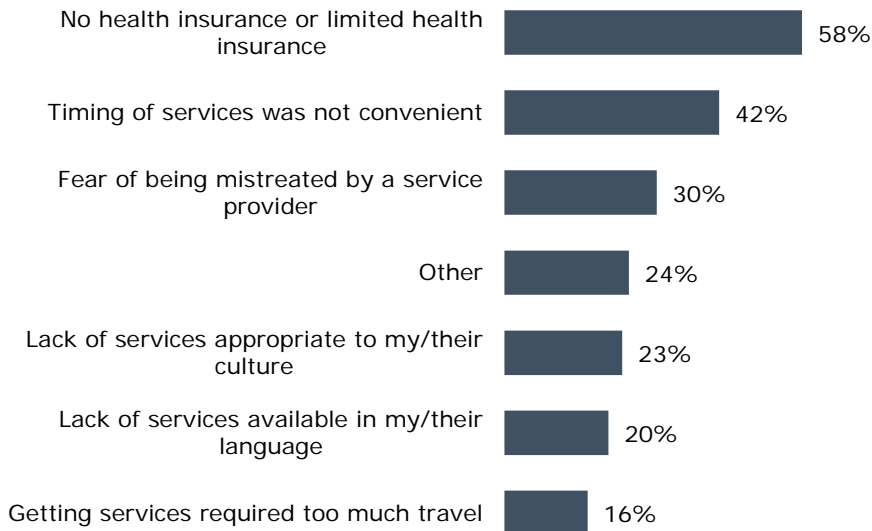


Exhibit 223. Staff that Provided Services were Sensitive to Cultural Background (n=224)

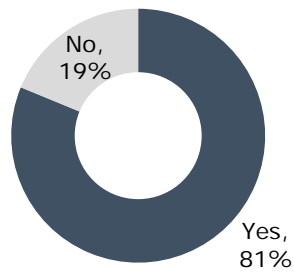


Exhibit 224. Services were Provided in Preferred Language (n=231)

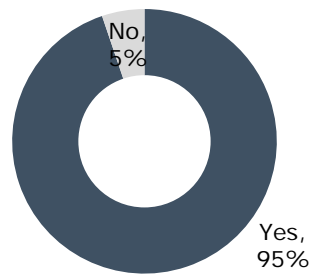


Exhibit 225. Overall Satisfaction with Received Services (n=221)

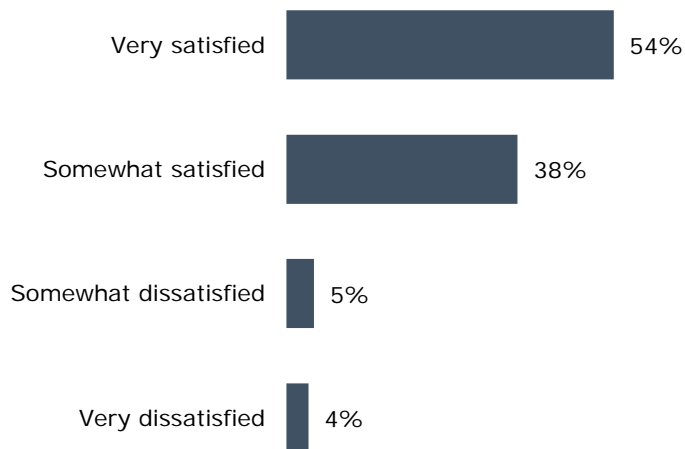
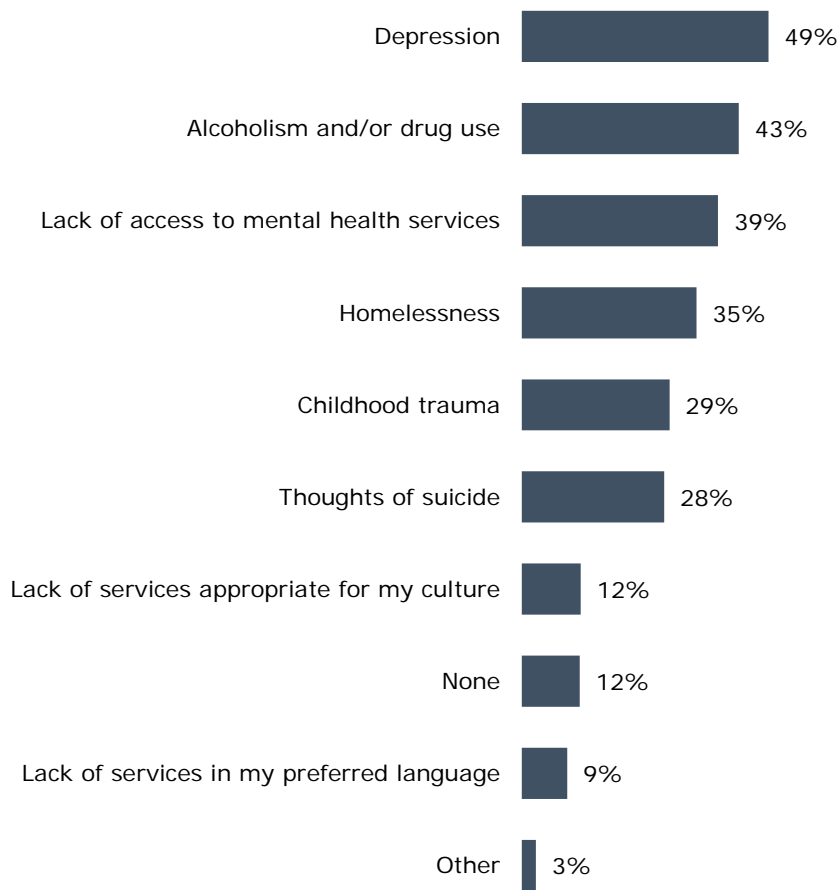


Exhibit 226. Most Urgent Mental Health Issues in the Community (n=532)

Exhibit 230. Sex Assigned at Birth (n=576)

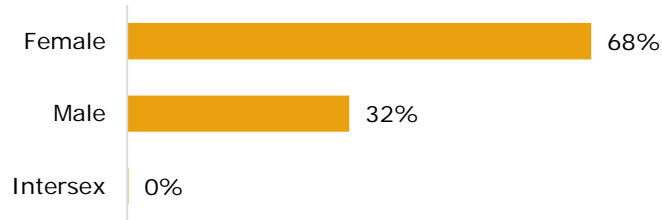


Exhibit 231. Gender of Respondent (n=553)

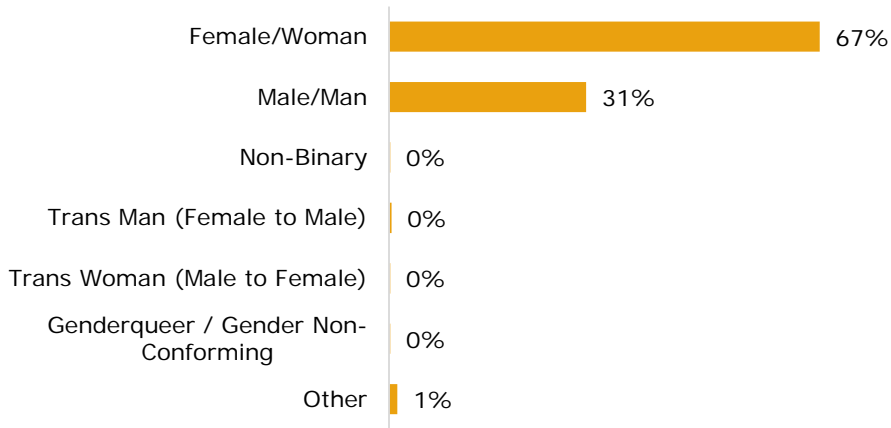


Exhibit 232. Current Sexual Orientation (n=522)

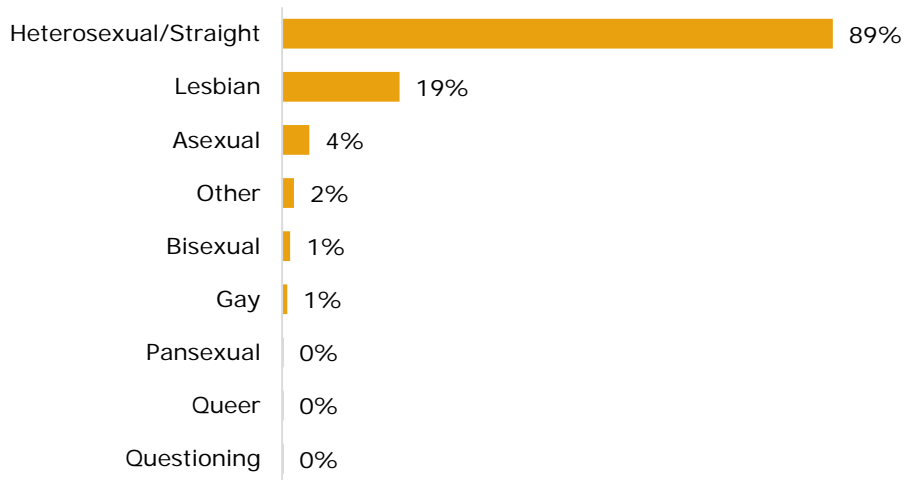

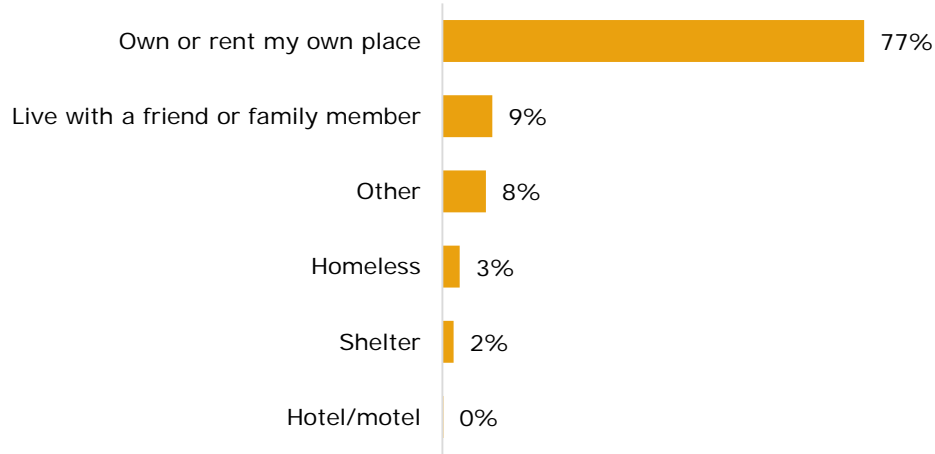
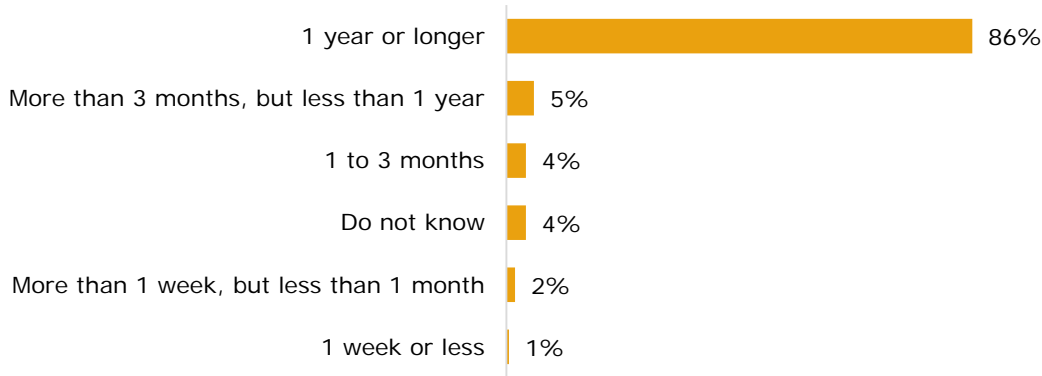


Exhibit 240. Length of Time in Current Living Situation (n=553)

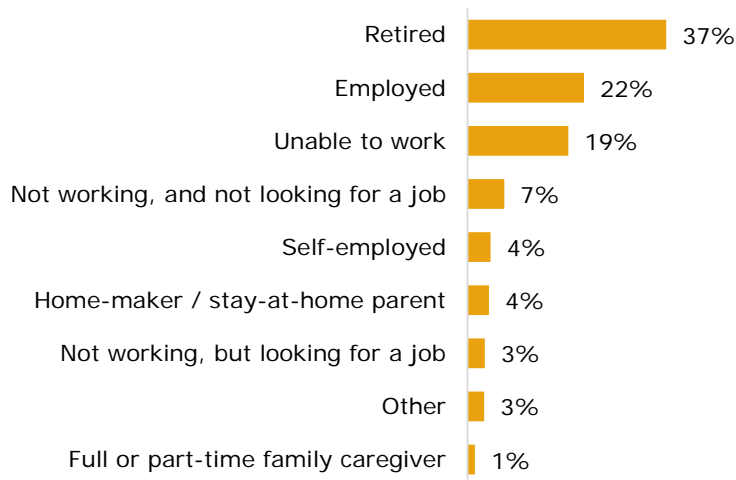
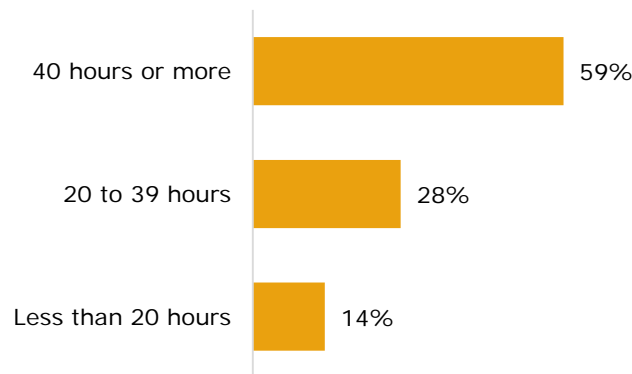


Exhibit 242. Number of Hours Respondent Works Each Week (n=140)¹⁸

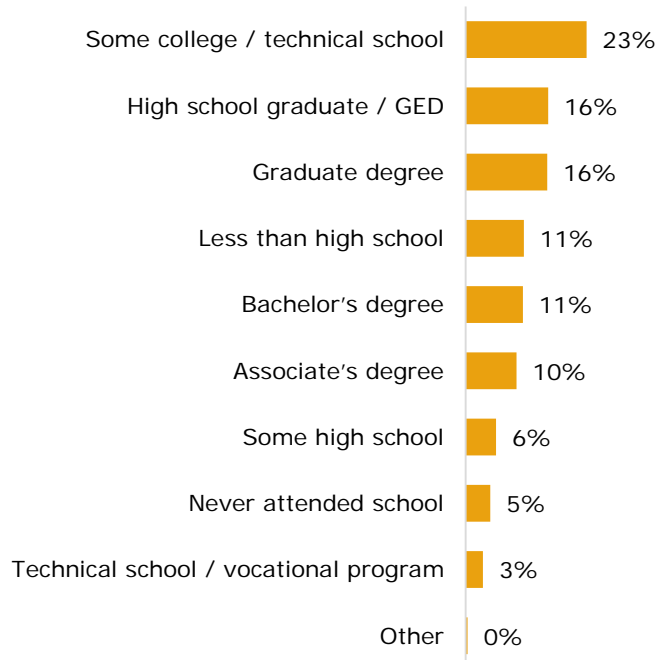
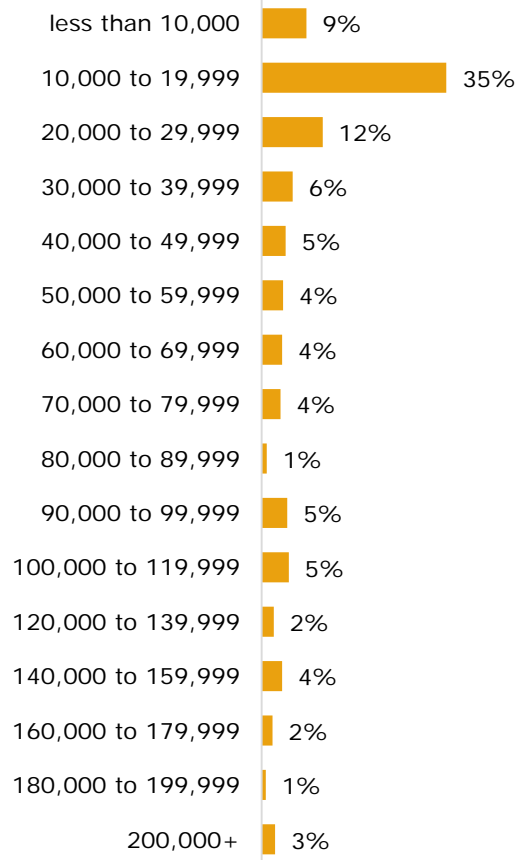
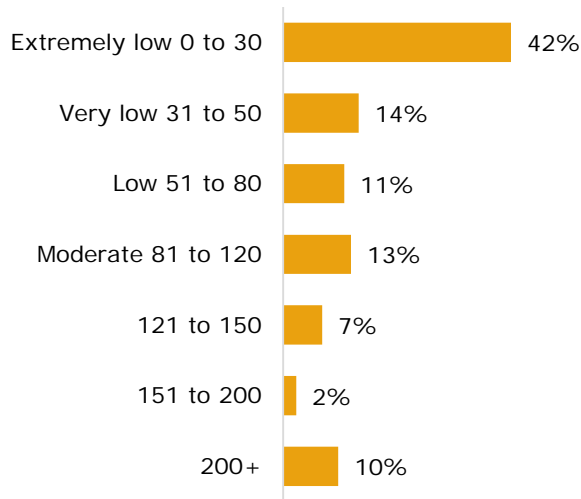


Exhibit 244. Total household income (n=388)



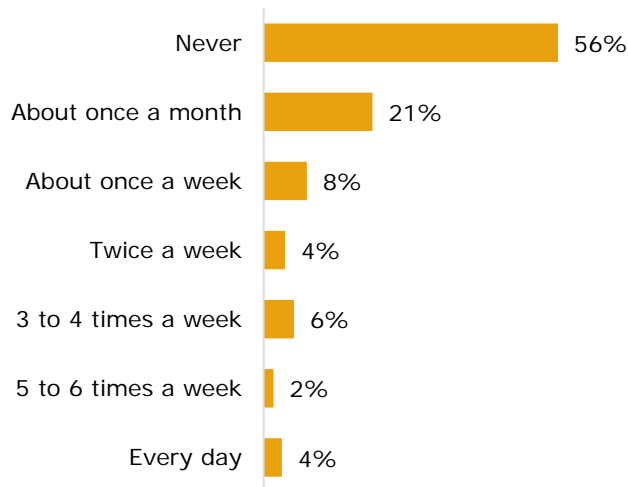

Exhibit 247. For Respondents who Reported Drinking, Average Number of Alcoholic Drinks (n=229)

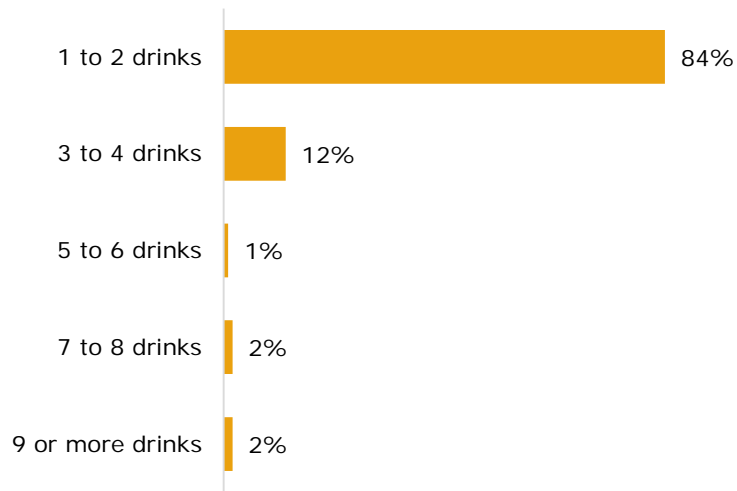


Exhibit 248. Substance Use in the Last 12 Months (n=538)

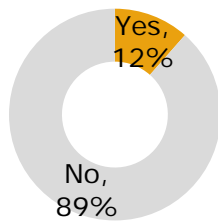


Exhibit 249. Mental Health Rating (n=524)

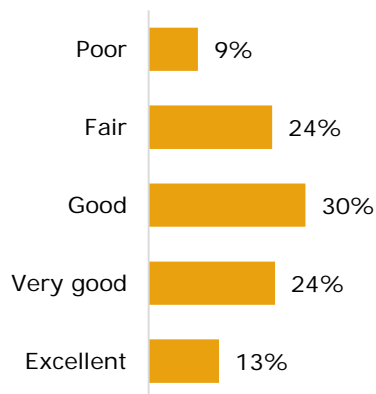


Exhibit 250. Mental Health Diagnosis by a Doctor or Other Healthcare Professional (n=411)

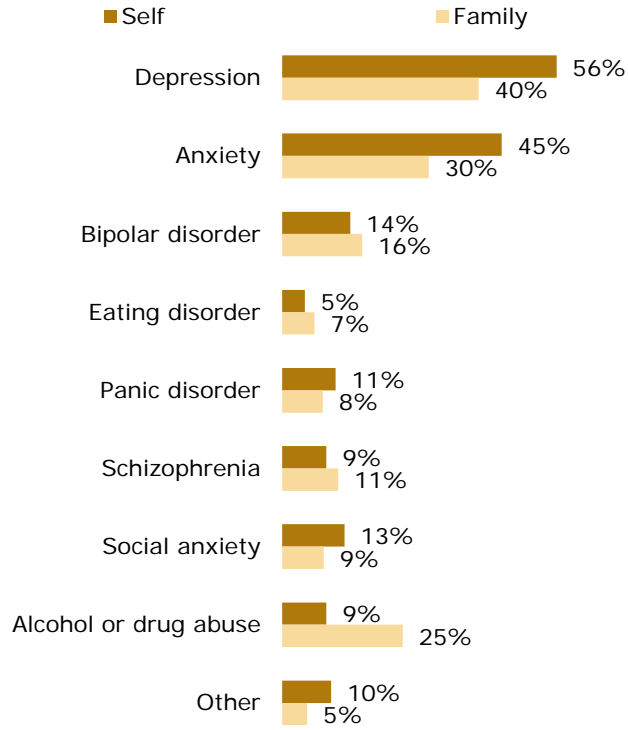


Exhibit 251. Age of First Mental Health Diagnosis

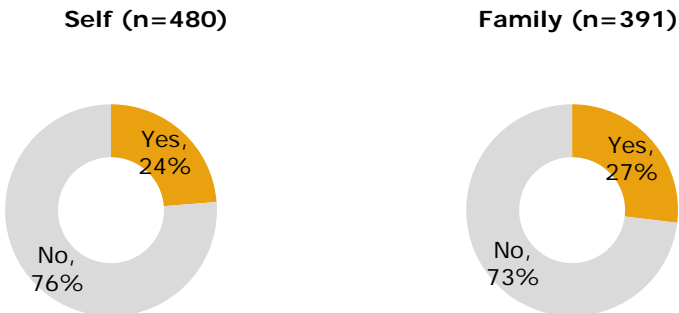


Exhibit 253. Age of First Suicide Attempt

Exhibit 254. Access to Needed Mental Health Services in the Last 12 Months

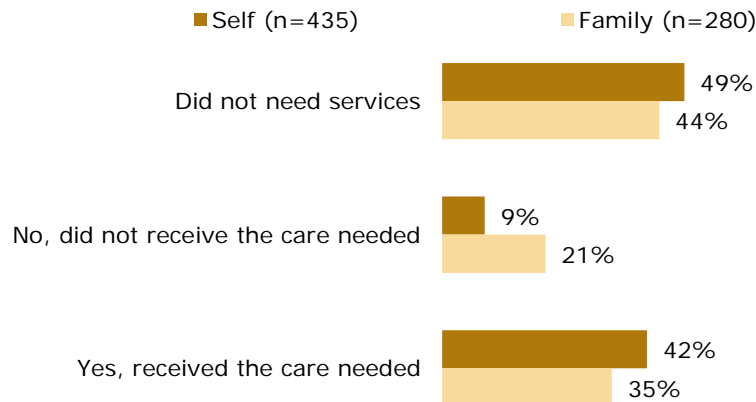


Exhibit 255. Main reasons Why Mental Health Services were NOT Received (n=66)

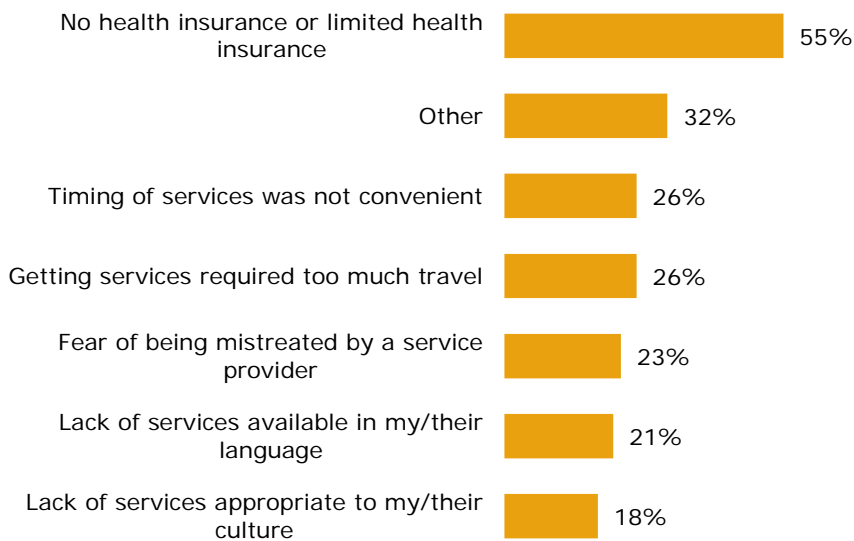


Exhibit 256. Staff that Provided Services were Sensitive to Cultural Background (n=215)

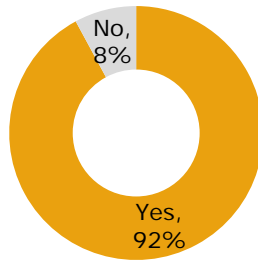


Exhibit 257. Services were Provided in Preferred Language (n=223)

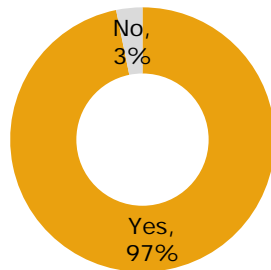


Exhibit 258. Overall Satisfaction with Received Services (n=223)

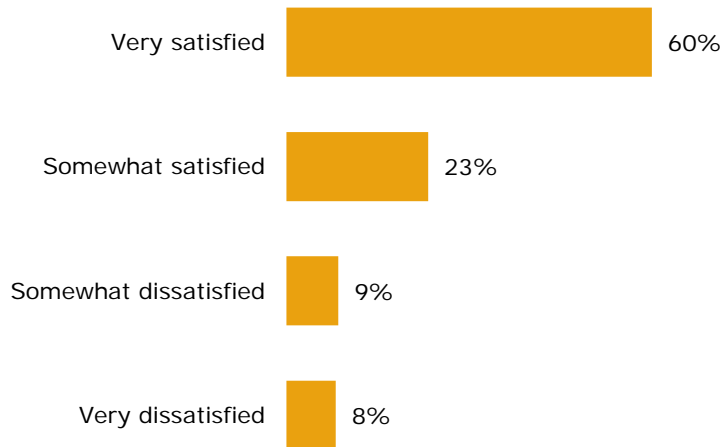
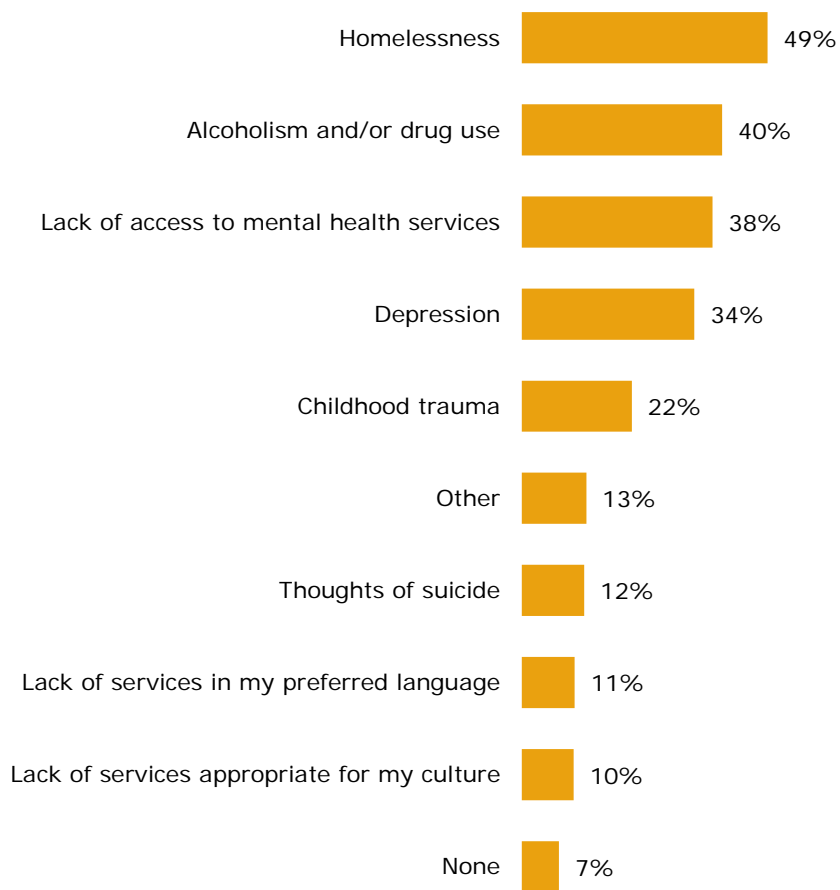


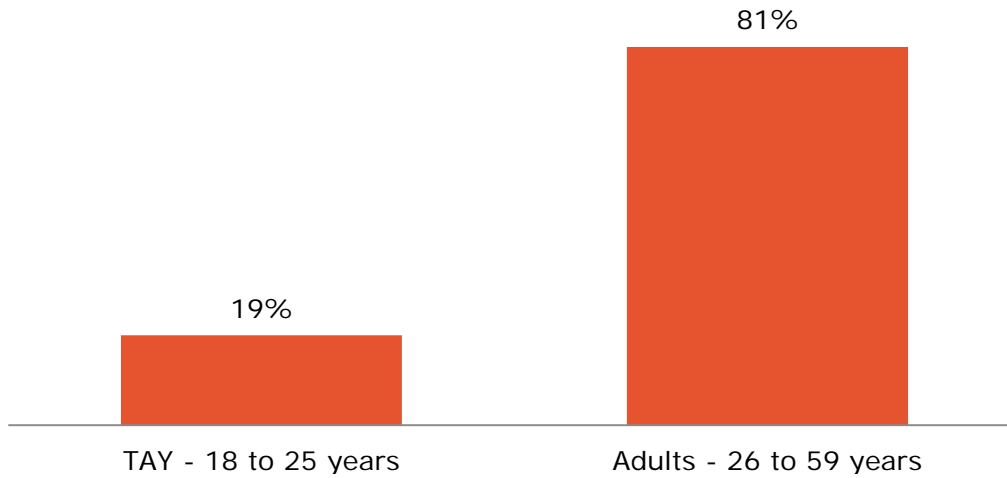
Exhibit 259. Most Urgent Mental Health Issues in the Community (n=524)

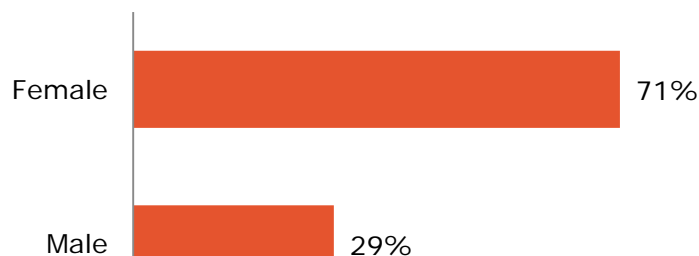


Exhibit 263. Gender of Respondent (n=23)

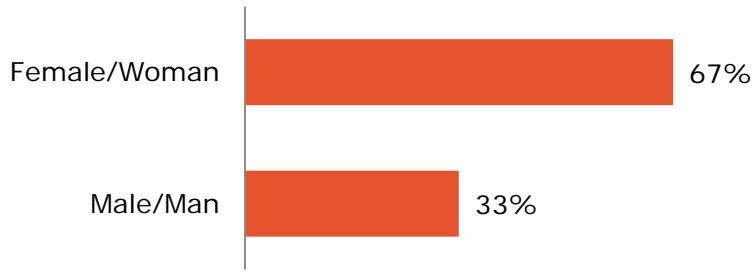


Exhibit 264. Country of birth of the respondent (n=22)

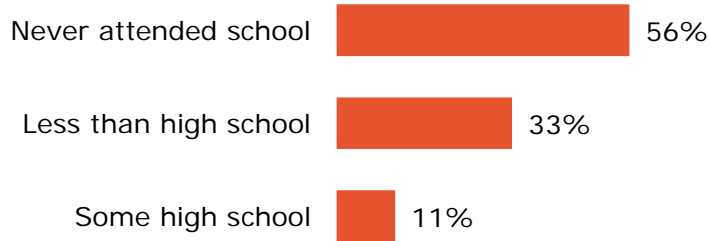

Exhibit 270. Mental Health Diagnosis by a Doctor or Other Healthcare Professional (n=1,428)

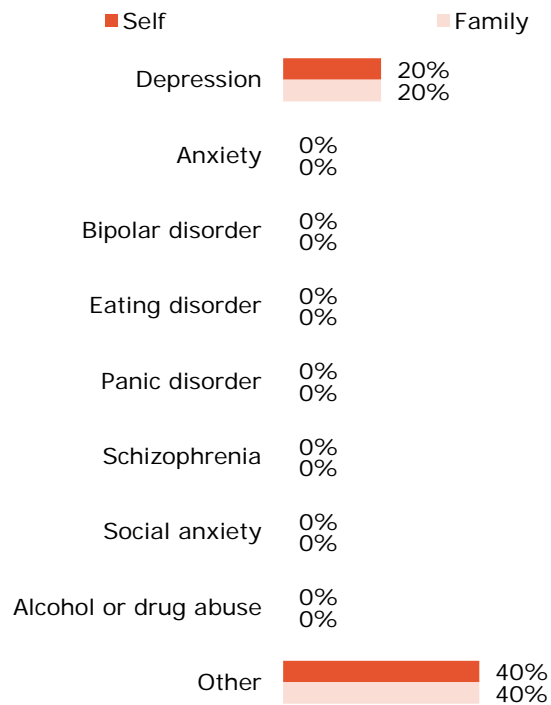


Exhibit 271. Access to Needed Mental Health Services in the Last 12 Months

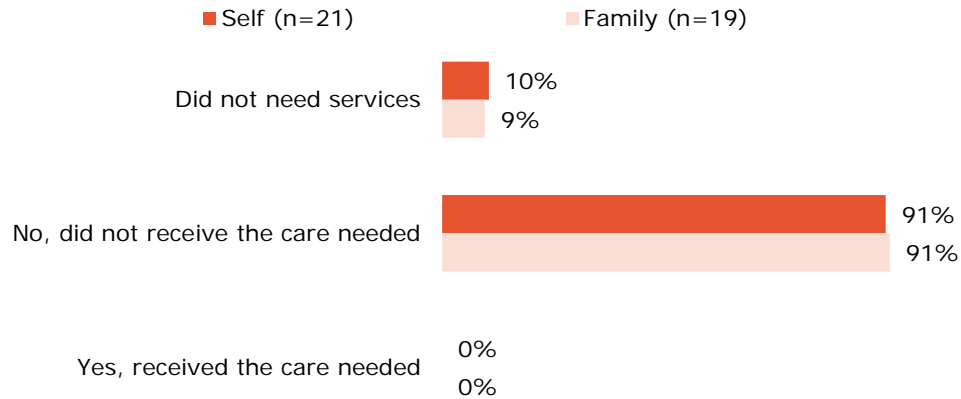


Exhibit 272. Main reasons Why Mental Health Services were NOT Received (n=21)

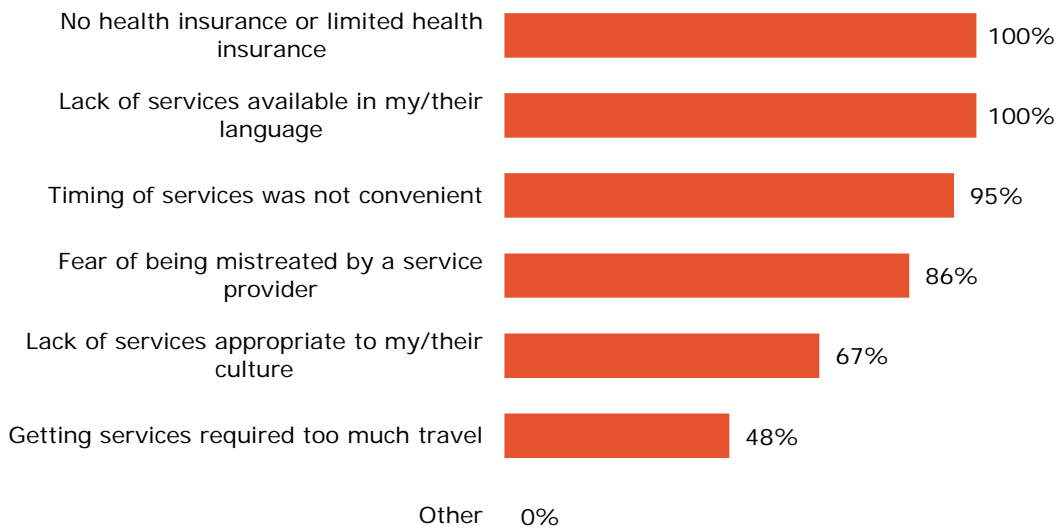
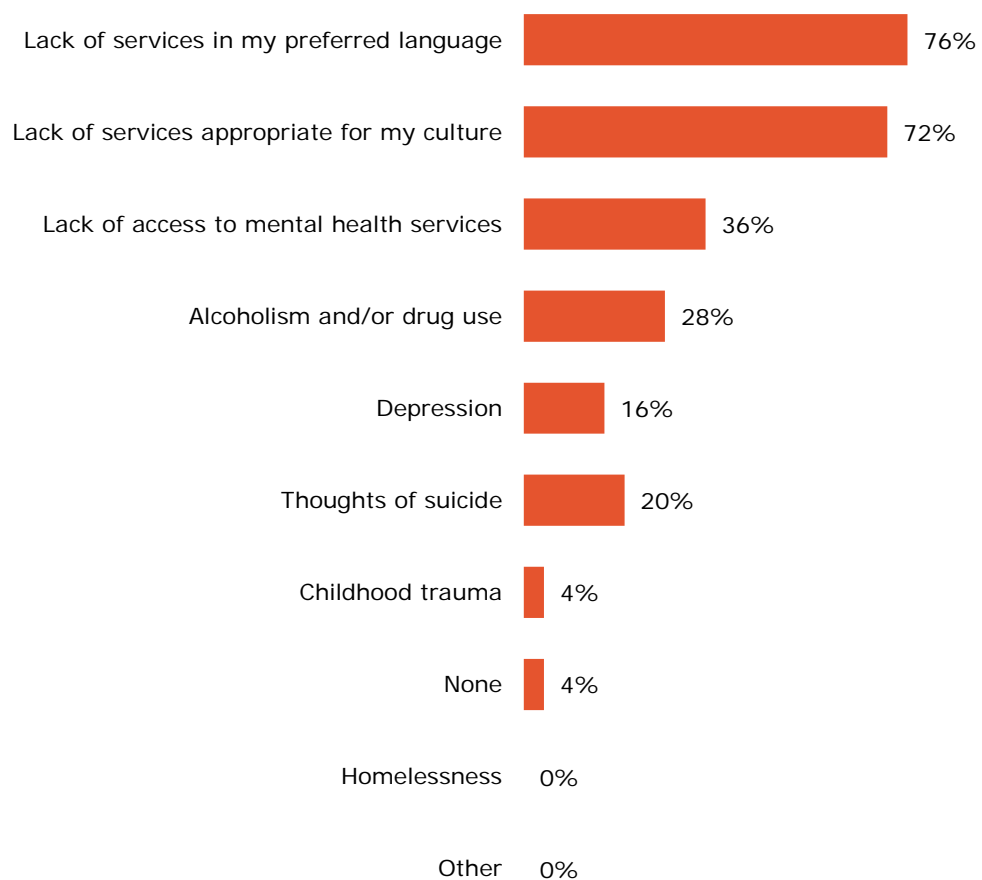


Exhibit 273. Most Urgent Mental Health Issues in the Community (n=25)

Exhibit 301. Respondents that reported substance use in the last 12 months

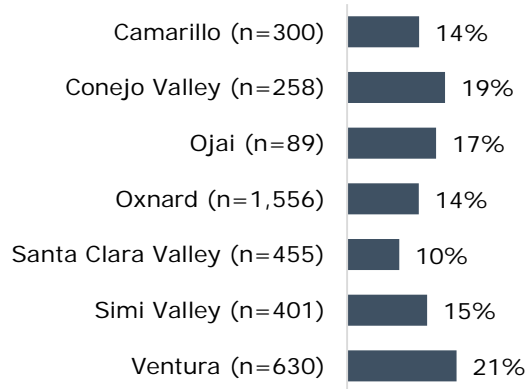

Exhibit 303. Respondent has been diagnosed with depression by a doctor or healthcare provider

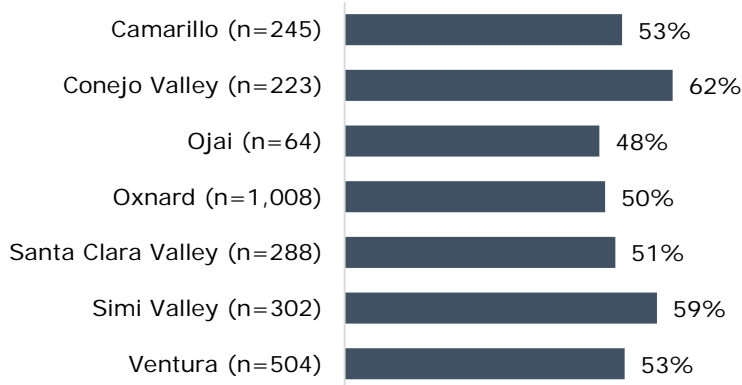


Exhibit 304. Respondent's family member has been diagnosed with depression by a doctor or healthcare provider

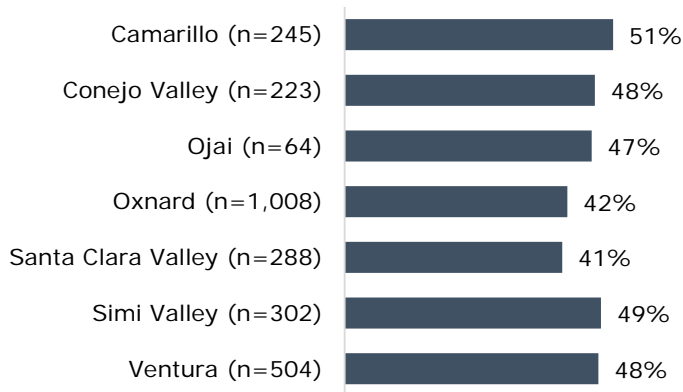


Exhibit 305. Respondent has been diagnosed with anxiety by a doctor or healthcare provider

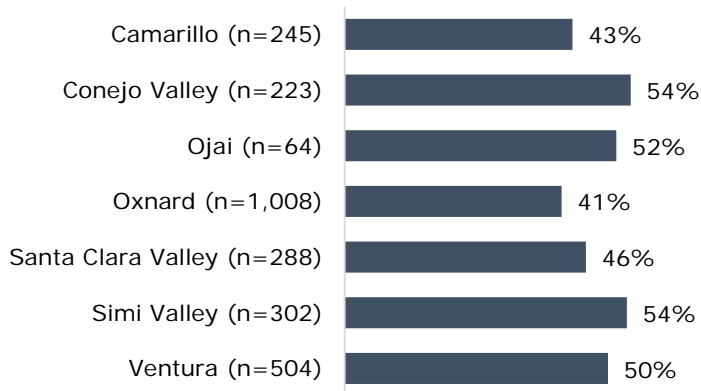


Exhibit 306. Respondent's family member has been diagnosed with anxiety by a doctor or healthcare provider

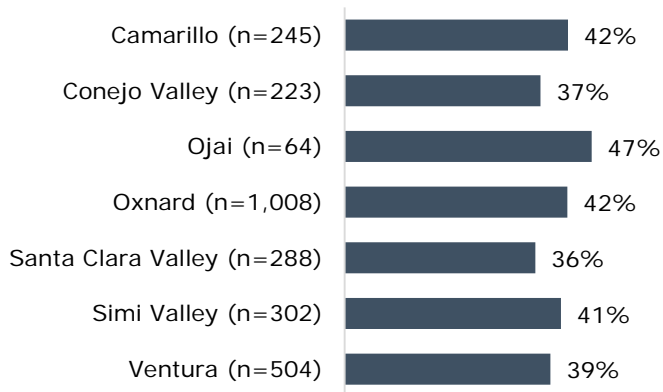


Exhibit 307. Respondent has been diagnosed with bipolar disorder by a doctor or healthcare provider

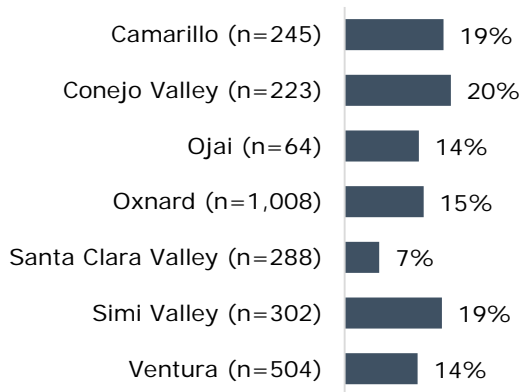


Exhibit 308. Respondent's family member has been diagnosed with bipolar disorder by a doctor or healthcare provider

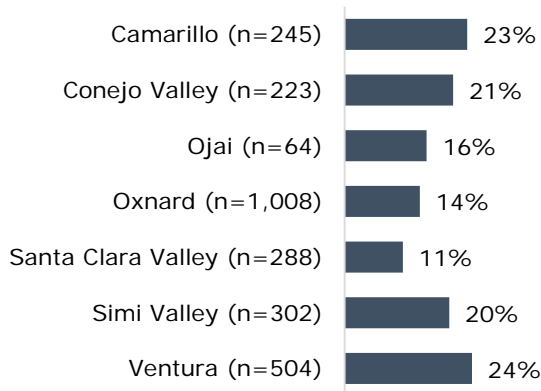


Exhibit 309. Respondent has been diagnosed with eating disorder by a doctor or healthcare provider

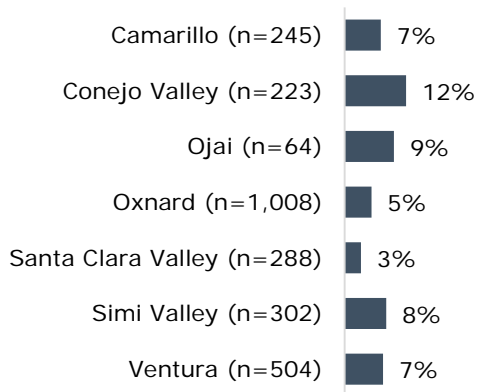


Exhibit 310. Respondent's family member has been diagnosed with eating disorder by a doctor or healthcare provider

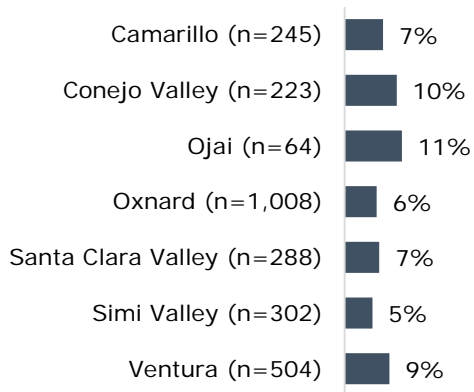


Exhibit 311. Respondent has been diagnosed with panic disorder by a doctor or healthcare provider

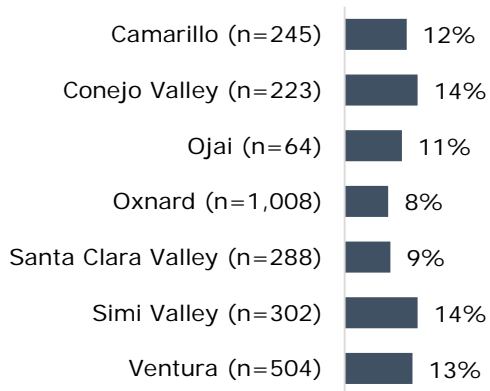


Exhibit 312. Respondent's family member has been diagnosed with panic disorder by a doctor or healthcare provider

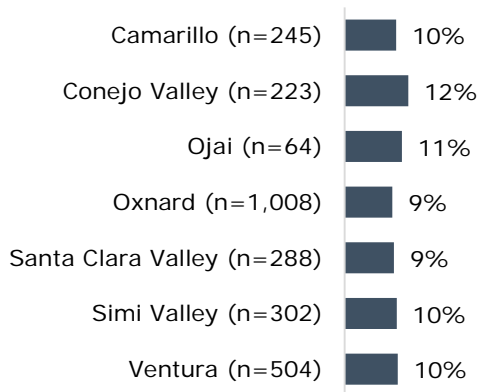


Exhibit 313. Respondent has been diagnosed with schizophrenia by a doctor or healthcare provider

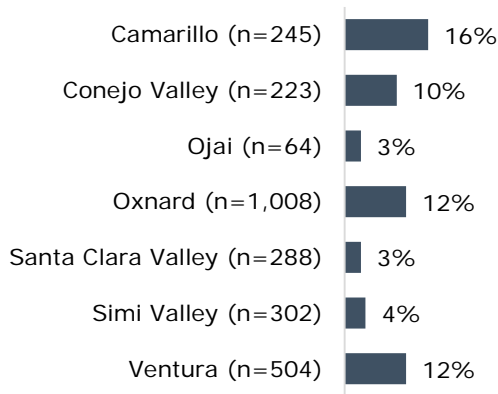


Exhibit 314. Respondent's family member has been diagnosed with schizophrenia with anxiety by a doctor or healthcare provider

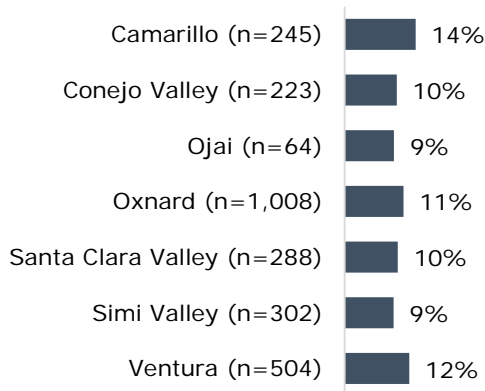


Exhibit 315. Respondent has been diagnosed with social anxiety or phobia by a doctor or healthcare provider

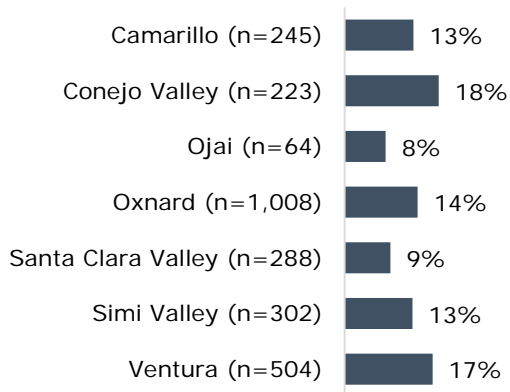


Exhibit 316. Respondent's family member has been diagnosed with social anxiety or phobia by a doctor or healthcare provider

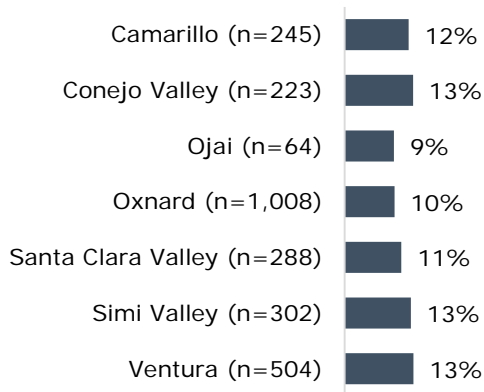


Exhibit 317. Respondent has been diagnosed with alcohol or drug abuse by a doctor or healthcare provider

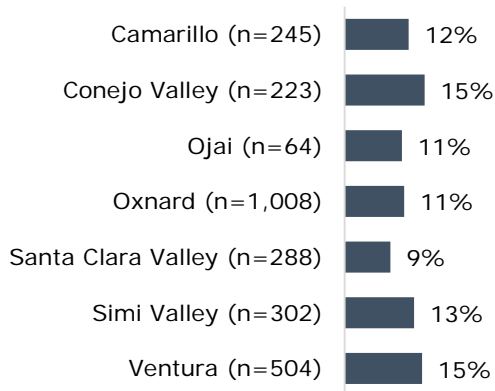


Exhibit 318. Respondent's family member has been diagnosed with alcohol or drug abuse by a doctor or healthcare provider

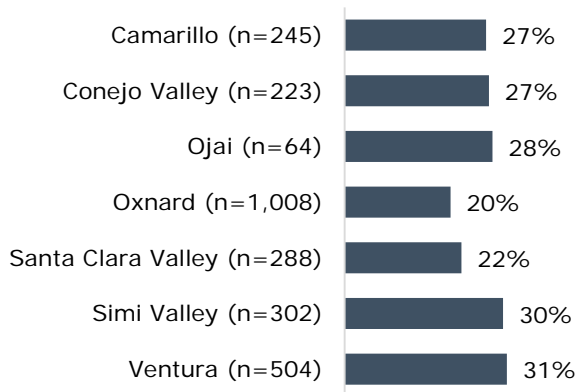


Exhibit 319. Respondent has been diagnosed with other mental health condition by a doctor or healthcare provider

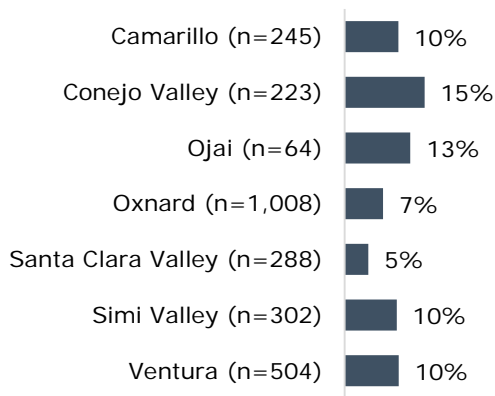


Exhibit 320. Respondent's family member has been diagnosed with other mental health condition by a doctor or healthcare provider

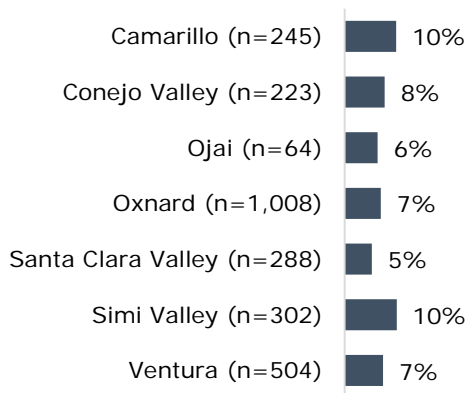


Exhibit 321. Respondent's Age at First Mental Health Diagnosis

Exhibit 323. Respondent has attempted or thought about suicide

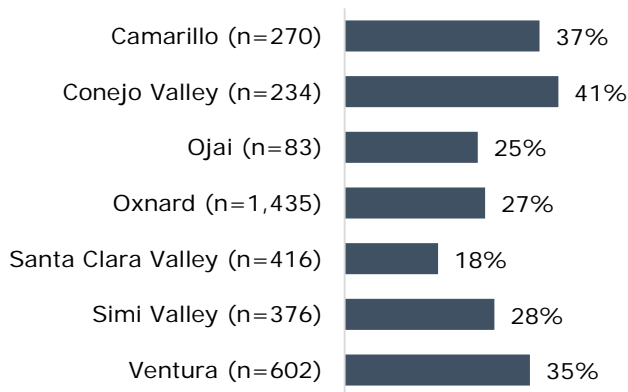


Exhibit 324. Respondent’s family member has attempted or thought about suicide

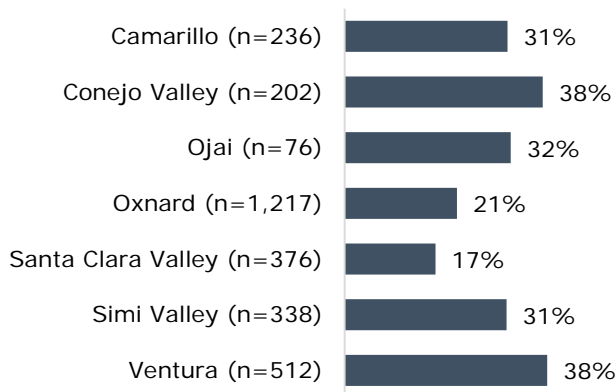


Exhibit 325. Respondent's Age at Suicide Attempt

Exhibit 330. Staff that provided services were sensitive to cultural background

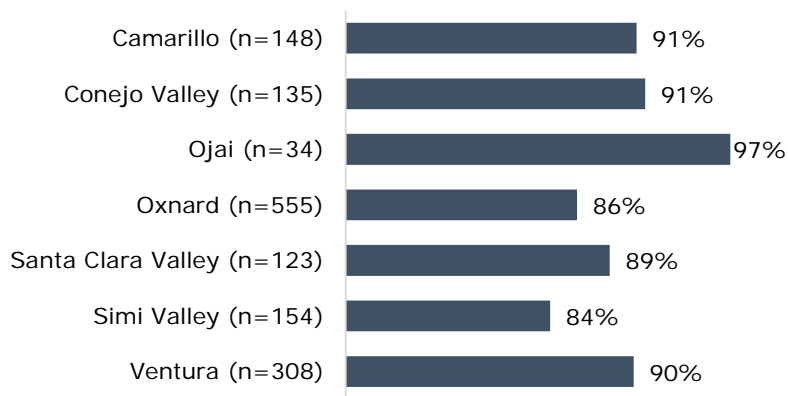


Exhibit 331. Services were provided in preferred language

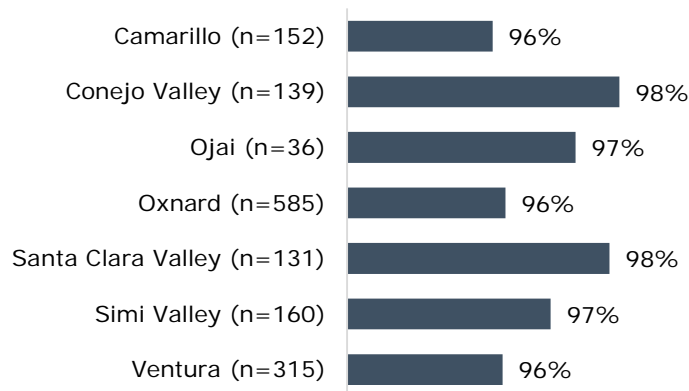


Exhibit 332. Overall satisfaction with received services

2018 Ventura County MHSA Needs Assessment Provider Survey Summary of Findings

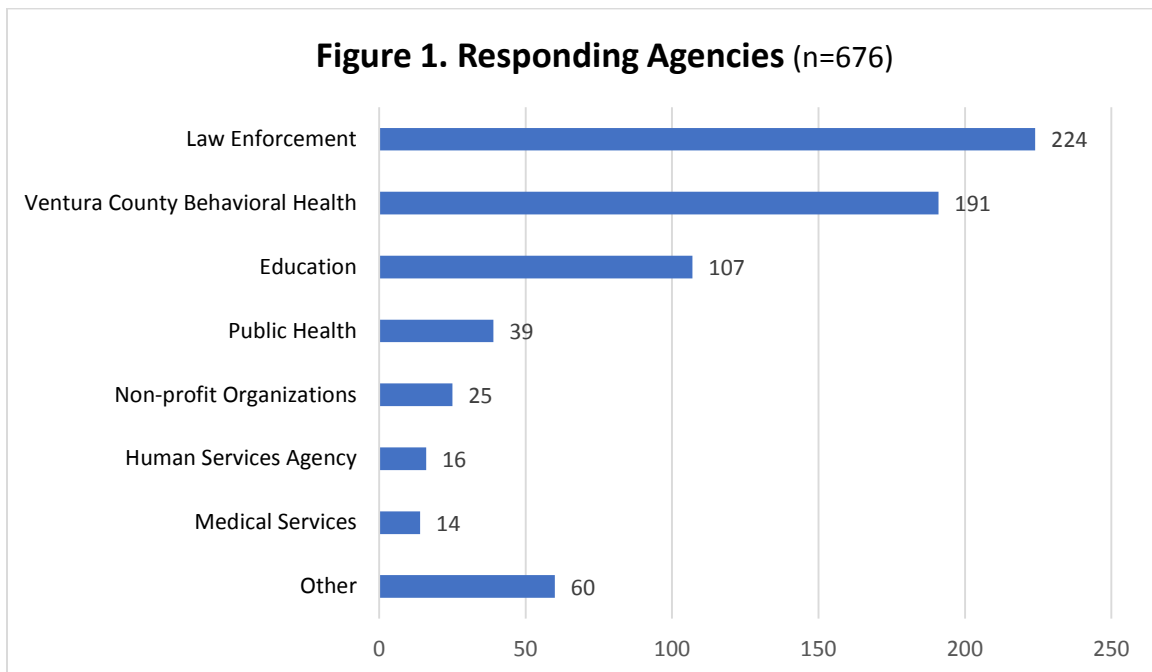
As part of a comprehensive countywide assessment initiative, EVALCORP Research and Consulting worked in collaboration with Ventura County Behavioral Health (VCBH) to develop and conduct the 2018 MHSA Provider Survey designed for agencies that work with populations in need of mental health services. The purpose of the survey was to obtain providers' perspectives and experiences regarding the availability and provision of mental health services countywide. Recommendations for improving mental health service delivery were also collected from providers. Key findings are summarized in this report.

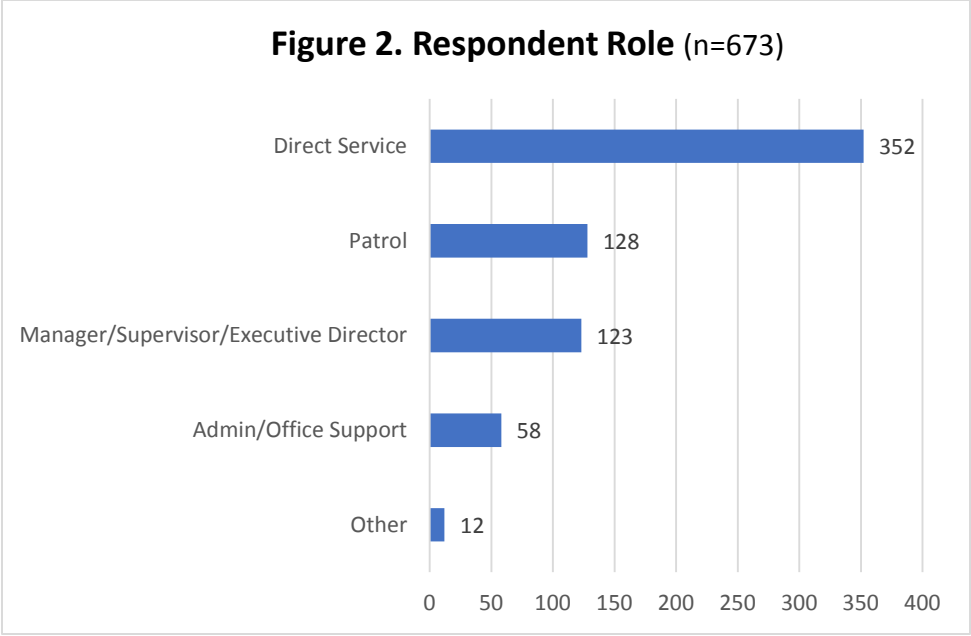
Provider Survey Findings

The Provider Survey was developed and administered online by EVALCORP during October 2018 to all agencies that assist the community with their mental health needs. The survey was distributed to a wide range of county, private, and non-profit agencies. During the three-week survey administration timeframe, a total of 690 individuals responded.

Responding Agencies

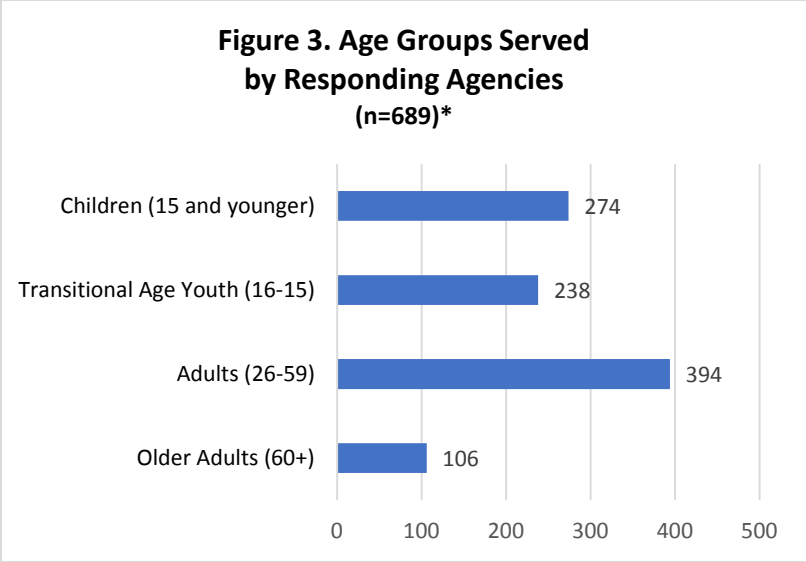
Of the 690 surveys collected, 676 respondents indicated which agency they worked for. The majority (61%) of respondents were from either Ventura County Behavioral Health (VCBH) or law enforcement agencies which included the Sheriff's Office, municipal police departments and probation. Other respondents' places of employment included educational institutions (such as those who work in primary, secondary, and higher educational institutions), Public Health, Human Services Agency, hospitals, ambulatory care, and community-based nonprofits (**Figure 1**). Over 70% of respondents identified as direct service providers or patrol interfacing directly with individuals (**Figure 2**).



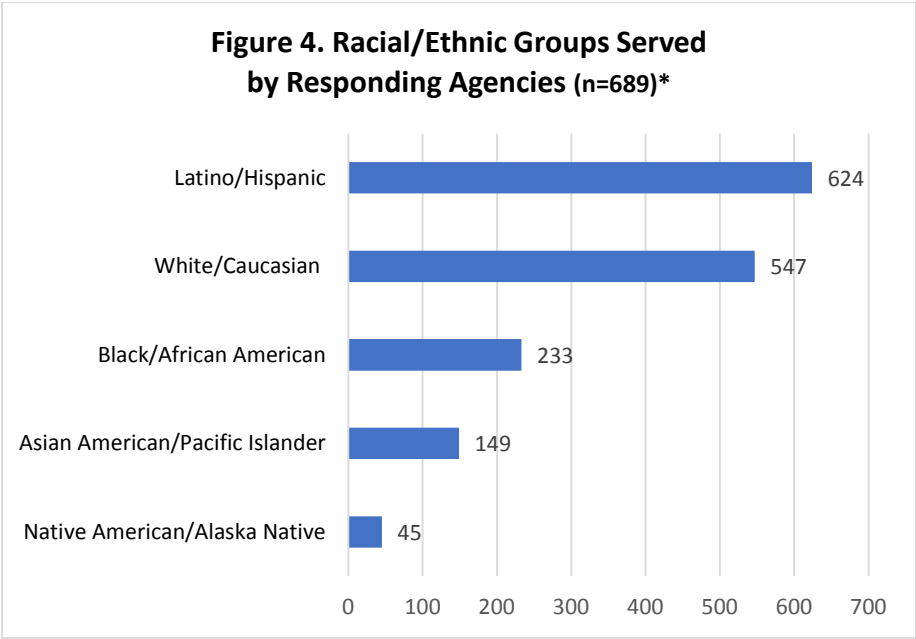


Respondents were also asked to indicate the primary regions and populations served (see Table 1, Figure 3 and Figure 4).

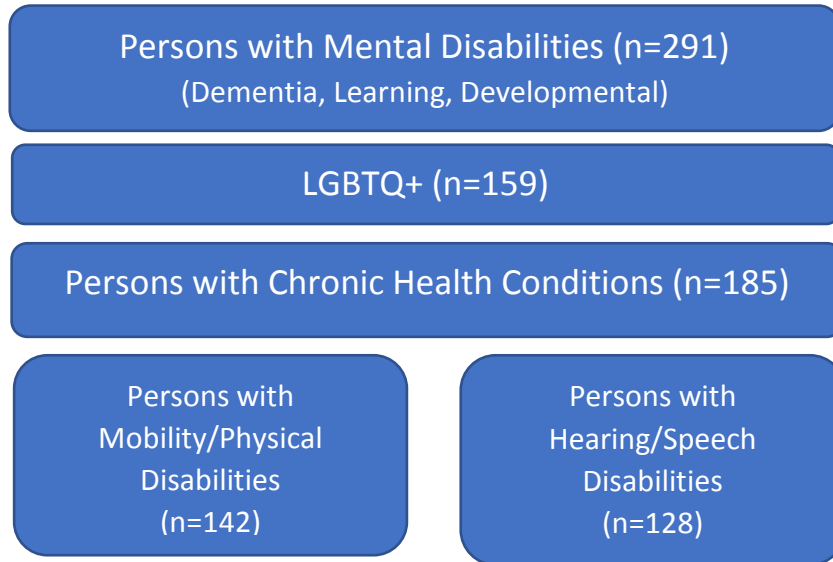

Other subpopulations served by respondents include persons with disabilities (e.g., cognitive, physical or challenges communicating); LGBTQ+; and persons with social/emotional or substance use disorders. Among the 23 individuals who selected ‘other’ populations served, responses included: persons experiencing homelessness (n=10), indigenous populations (n=3), foster youth (n=2), and the previously incarcerated (n=2).



Capacity and Availability of Mental Health Services Across Ventura County

Respondents were asked about the availability, wait times, cultural competency, and ease of access for clients given the currently “in place” mental health services within Ventura County (**Table 2**). Highest rated (i.e., deemed Good or Excellent) were: cultural competency of staff; hours of operation; and materials/services provided in multiple languages. Almost half (49%) rated “capacity” as poor.

After ranking the quality of the mental health services above, respondents were asked to explain their answers. Of the 634 who ranked the availability or quality of mental health services, 145 elaborated further. A sample of responses illustrating common themes is provided below:

“Excellent patient care is possible when there is enough staff. When there is minimal staff there is minimal care.”

“There is a continuous need for mental health workers to work in the field with patrol officers.”

“We need more therapists and psychiatrists desperately. Our appointments are booked out too far. Our therapy waiting lists are too long.”

“Clients have transportation and language barriers. The process is too lengthy and most clients give up and decide not to follow through with therapy. The ones that do go through the process are then placed on a waiting list due to the low number of bilingual therapists available. When they finally get called to set up therapy, they are no longer interested.”

“Materials are in multiple languages, but are not culturally competent”

“Public transportation for ease of access is limited”

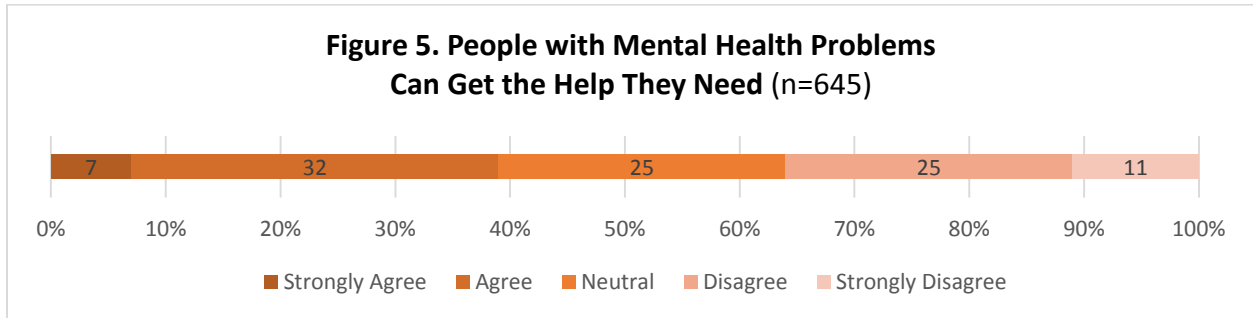
“I believe our agency does a great job at recognizing the clients that need services and what they need. However, there isn’t enough staff to accommodate the need.”

“The ER [Emergency Room] is filled daily with mental health patients and the ER is not equipped to provide the proper level of mental health care needed.”

Unmet Mental Health Needs

As part of the assessment, respondents were also asked (1) whether those in need of mental health services can access them; (2) what the most urgent issues affecting mental health are at this time; (3) which populations were in greatest need of mental health services; (4) what, if any, unmet mental health needs exist within the communities they serve; and, (5) whether their agency’s capacity is currently sufficient to meet identified needs.

As seen below (**Figure 5**), respondents were split when asked if people with mental health problems in their communities can receive the help they need.



When asked about the most urgent issues affecting mental health, respondents most frequently indicated substance use, homelessness, lack of access to services, and depression (**Table 3**).

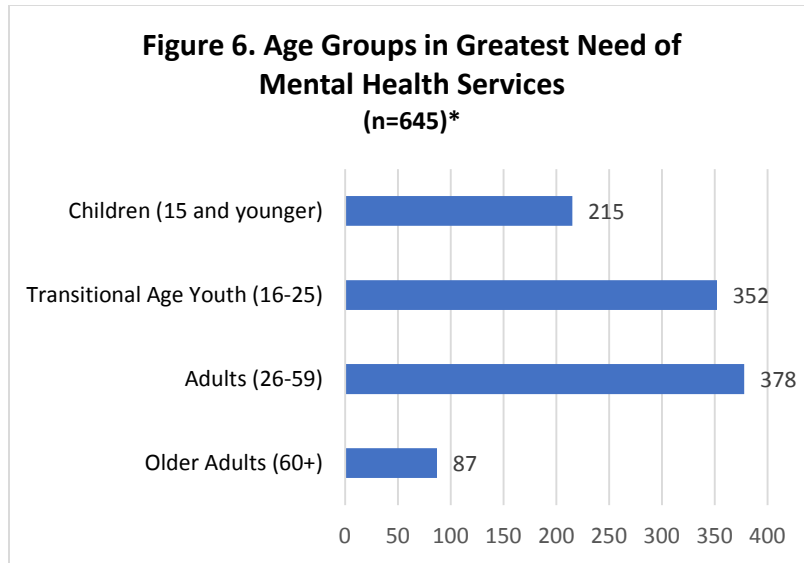

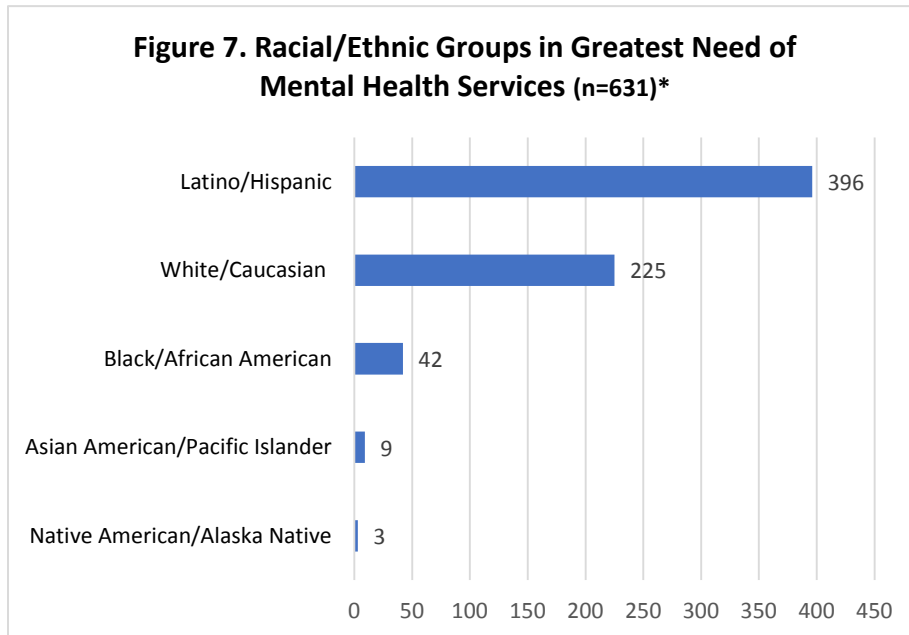
Over 100 respondents opted to provide additional “urgent issues” affecting mental health in Ventura County. A sample of the coded responses is below:

- Other mental health conditions or disabilities ranging from ADD/ADHD to schizophrenia and psychosis (n=23)
 - Note: anxiety was the most frequently indicated (n=15)
- Personal issues (e.g., divorce, deportation or incarceration of a family member) (n=7)
- Effects of low income (n=6)
- Domestic violence (n=4)
- Gang involvement/exposure (n=4)
- Stigma (n=2)

When asked specifically which age group is in greatest need of mental health services, the most frequently chosen age category was Adults (26-59), followed closely by TAY (ages 16-25) (**Figure 6**). Latinos/Hispanics, followed by Whites/Caucasians were the most frequently selected racial/ethnic groups in greatest need of mental health services (**Figure 7**).

Other subpopulations in great need of mental health services according to respondents include: persons with mental disabilities (n=186), LGBTQ+ (n=107), persons with chronic health conditions (n=64), persons with mobility/physical disabilities (n=30), persons with communication disabilities (n=21), and those with substance use problems (n=11). Other subpopulations indicated were: persons experiencing homelessness (n=7) and indigenous populations (n=4). An additional 38 respondents selected 'other' (e.g., caregivers; those with social emotional problems; and youth exposed to gangs, domestic violence, and sex trafficking).

When asked to describe any unmet needs relative to mental health services in the communities they serve, a total of 245 individuals provided responses. Coded response categories are below:

- Increased access to services: shorter wait times, more beds in hospitals and other facilities, services available at more times (weekends and evenings), and simplifying the difficulties in navigating the process (n=57)
- Substance use treatment: including in-patient, sober living facilities, and treatment for dual diagnoses (n=28)
- Housing: emergency, transitional, affordable, etc. (n=20)
- Transportation (n=15)
- Education and outreach (n=15)
- Services for individuals experiencing homelessness (n=15)
- Availability of different levels of care and follow-up such as counseling and therapy (n=15)
- Affordable/low income services (n=13)
- Local services (n=13)
- Appropriate treatment for youth: inpatient, psychiatric, substance use treatment (n=11)
- Childcare (n=10)
- Assistance for families with children with varying needs (autism, social emotional, behavioral) (n=9)
- Multilingual and culturally competent service providers (n=9)
- Mobile/in-the-field mental health services (n=8)
- Access to mental health services in schools (n=8)
- Timely crisis intervention (n=7)
- Treatment for eating disorders (n= 7)
- Services for undocumented individuals (n=2)
- Services for older adults (n=5)
- Services tailored to women (n=3)
- Care for caregivers (n=3)
- LGBTQ+ (n=2)

"[We need to determine] why clients don't follow through when a referral is made and [try] to correct whatever issues are blocking access to services."

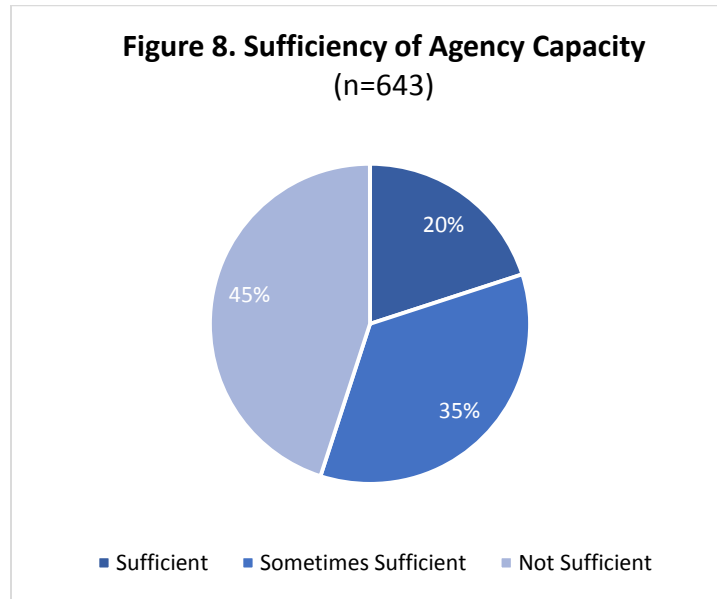
A sample of select quotes are provided below:

"Prevention and intervention is needed! Why does the county have to wait until a youth is in full crisis and suicidal?"

"Parents may not know a service exists or they get denied and give up. Sometimes the parent needs someone to advocate for them to help them navigate how to get services for their child."

"Local services with culturally competent staff. Often families are referred to locations towards the east end of Ventura. Families on the West side often are limited in their English communication skills and lack transportation."

As shown in **Figure 8**, almost two-thirds of respondents felt that their agency’s capacity to meet the mental health needs in their service area is sufficient or sometimes sufficient; yet, 45% felt that their agency’s capacity was insufficient (45%) to meet the mental health needs in their service area.



Barriers to Accessing Mental Health Services

Respondents were asked to consider available mental health services in the communities they serve and indicate which barriers listed below may prevent clients from accessing care (**Table 4**). They were also provided with an option to write in barriers not provided.

Over 65 respondents provided additional barriers affecting mental health care access in Ventura County. A sample of the most common response themes is below:

- Individuals themselves are unwilling to seek or pursue services (n=12)
- Financial concerns/unable to afford services (n= 7)
- Hours of operation (n= 6)
- Wait times for care (n= 5)
- Staffing shortages (n= 4)
- Language barriers (n= 3)
- Stigma (n= 2)

Recommendations

At the conclusion of the survey, respondents were asked to provide recommendations to better meet the primary mental health needs within the communities they serve. A total of 260 respondents provided suggestions. Coded response categories are below:

- More providers and capacity to serve (nonprofit, private, and county clinics; mental health facilities or hospitals) (n= 92)
 - Hiring staff (n= 25)
 - School-based services (n =17)
 - Inpatient (n=10)
- Improving access to care (n=59)
 - Extended hours of operation (n=18)
 - Transportation to and from services (n=17)
 - Childcare for clients (n=7)
 - Streamlining intake/reducing barriers to services (n=5)
 - Addressing stigma (4)
 - Advocacy (1)
- Community and provider outreach, education, and training (n=46)
- Supplemental or enhanced types of services (n= 37)
 - Substance use (n= 11)
 - Follow-up/aftercare (n= 8)
 - Mobile/in-the-field services (n= 7)
 - Affordable (n= 5)
 - Assessment/screenings (n= 5)
 - Local (n= 1)
- Services for specific subpopulations (n=17)
 - Older adults (n= 6)
 - Caregivers (n= 4)
 - People experiencing homelessness (n= 3)

“Mental health professionals should be available to ride with certain police officers during varying hours of the day and be available to assist persons who are in a mental health crisis.”

- Housing (including board and care facilities) (n=16)
- Interagency collaboration (n= 15)
- Multicultural/lingual staff (n=12)
- Prevention (n=5)
- Prosocial youth activities (mentoring, sports, art programs, etc.) (n=5)
- More options for quick/immediate care outside of law enforcement and emergency rooms (i.e., hotline) (n=5)
- Whole Person care (n=2)

“[We need to be able to provide] prosocial referrals for youth and families that are struggling with negative activities of gang violence and drug abuse in the community. Families are seeking replacement activities to remain sober, channel anger, express emotions...that are not accessible to families with little economic resources and in poverty.”

“There is not enough being done to address chronic homeless mental health issues. It is without doubt the greatest mental health challenge facing our community. It should be given the highest priority.”
