HEAC 2025 Retreat Proposal

Part A: August – Group Identity and Who are We?

Reconnecting in Purpose, Rediscovering Our Collective Voice: This session is focused on strengthening HEAC members and designed to support relationship-building. This retreat would focus on building trust among old and new members. Through values alignment activities, collaborative dialogue, and norms setting, we would cocreate a stronger sense of roles and responsibilities. Participants would leave feeling seen, valued, and clearer about the unique contributions they bring—and how to work together across sectors more effectively. Great for groups navigating change or growing pains.

This session will serve as an opportunity to honor the Council's origin as a response to racism as a public health crisis, and recognizing its evolution with new CBO partners and community leaders.

Virtual Orientation Opportunity (between Part A & B in Sept 2025)

- Share the history of HEAC
- Brown Act Info
- Key Info from Bylaws/Charter

Aimed at new people but open to anyone who wants a refresher.

Part B: October - What are we Doing?

Vision Forward: Priorities for the Year Ahead: This retreat would guide the HEAC through a reflective arc—We could facilitate a round table shared reflection discussion on a set of prompts, and visual mapping to help members reconnect to HEAC's founding purpose, rediscover the diversity of skills and lived experience in the room, and identify what each member is most called to contribute in this next chapter. It is ideal for re-centering the group's identity before moving into goal setting.

This working retreat would guide members through an inclusive goal-setting process grounded in HEAC's charter and purpose. We would review key equity indicators and gaps option to include data or insights from the Community Health Needs Assessment or other HCA data prioritized for HEAC and use small-group breakouts and consensus-building tools to identify 3–5 shared priorities. Ideal for a council ready to shift into action and sharpen its collective focus.

These would be facilitated sessions. Part A/B – retreat style and still open to the public. Still a Brown Act meeting with public comment at the beginning.

Office of Community & Belonging and Youth Equity Initiative Teams would lead with support from HCA PIO.
